WEDNESDAY, April 30, 2003

The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

#### **PRAYER**

# ANNUAL REPORT ON THE FARMLAND PROTECTION PROGRAM

Dear Mr. Faber:

The Pennsylvania Department of Agriculture is pleased to submit to the General Assembly an annual report for the period April 30, 2002 through April 30, 2003, in accordance with Section 14.4 of Act 149 of 1988 (the Agricultural Area Security Law).

In the fifteen years since the authorizing legislation became effective, Pennsylvania's Farmland Protection Program has permanently preserved 252,296 acres of farmland in 51 counties. Act 149 provides for permanent preservation of agricultural land through the purchase of conservation easements from qualifying farmers. Easements can be purchased entirely with Commonwealth funds, with a combination of state and county funds, or solely with county matching funds. The Pennsylvania program is first in the nation in the number of acres preserved and is continuing to preserve farmland at a rate greater than any other state.

From 1996 through 2000, more than 1,200 Pennsylvania children under the age of 15 lost their lives because of violence and unintentional injuries. The causes of death included falls, motor vehicle crashes, bicycle crashes, poisonings, fires, choking, scalding, and drowning incidents. It is pretty scary, but it gets worse. Each year one out of every four children is hurt seriously enough to require medical attention. These injuries cost society \$165 billion annually. All in all, preventable injuries are the number one killer of children 14 years and under in the United States. Yet 90 percent of these injuries could have been prevented if families had taken the simple steps necessary to protect their children.

Dr. C. Everett Koop, Chairman of the National Safe Kids Campaign, offers this observation: If a disease were killing our children at the rate unintentional injuries are, the public would be outraged and demand that this killer be stopped. Based on the numbers, I find it hard to disagree, Madam President. Fortu-

nately, Pennsylvanians have decided not to sit idly by and watch these trends continue. In cooperation with a national grassroots movement, the Pennsylvania Safe Kids Coalition was formed to aggressively promote awareness of the need to prevent childhood injuries. Currently, there are Safe Kids Coalitions in 13 counties and Safe Kids Chapters in 24 additional counties. Awareness, education, and understanding are the tools we have at hand to combat the epidemic of serious, preventable injuries. Once risks are comprehended, steps can be taken in the household, the community, and the school to create safer environments for our children

Madam President, in recognition of this serious problem and the need to provide remedies, I urge unanimous approval of this resolution proclaiming May 3 through 10 as "Safe Kids Week" in Pennsylvania.

Thank you, Madam President.

And the question recurring,

Will the Senate adopt the resolution?

A voice vote having been taken, the question was determined in the affirmative.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Mercer, Senator Robbins.

Senator ROBBINS. Madam President, today we passed Senate Resolution No. 80, which designates the month of May as "Community Action Month" in honor of the work that the 43 community action agencies in our Commonwealth provide to all 67 counties. For over 35 years, community action agencies have provided outreach to low-income individuals and families to help them achieve self-sufficiency.

Through locally designated programs, community action addresses a multitude of needs, including food, emergency and affordable housing, home weatherization, literacy in education, job training and placement, transportation, day care, drug and alcohol abuse prevention, and personal and family development. The truth is, community action changes lives by helping people help themselves.

Today we recognize the good work done by those involved in community action. I have seen firsthand the work done in my district in the Mercer County Community Action Agency, headed by Ron Errett.

Again, I thank all the staff who work at community action agencies for all that they do, and continue to do, for the community.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator Piccola.

Senator PICCOLA. Madam President, about 10 or 15 miles down river from where we are sitting today is a nuclear power plant, Three Mile Island. It is probably the most famous nuclear power plant in the world after the events of March 1979, when the people of central Pennsylvania were traumatized by the world famous, or infamous, nuclear power accident that occurred there, and the focus of the world was on Middletown and Three Mile Island for days and weeks during that period of time. At the time of that accident, Governor Dick Thornburgh exercised extraordinary leadership in containing the effects of that accident, but more importantly, in reassuring the people of central Pennsylvania that he and the State of Pennsylvania, as well as the Federal government, in conjunction with President Jimmy Carter, were going to do everything in their power to make sure that the citizens of this region would be safe from any emission of radioactive material from Three Mile Island. We have lived with that nuclear power plant for over the last 20 years, always having it in the back of our minds. And in the year 2001 and 2002, after the events of September 11, 2001, under the leadership of Governor Ridge and Governor Schweiker, special attention was paid to the security at Three Mile Island, as well as the other nuclear power plants of the Pennsylvania. And due to the concern of the residents of this region, as well as the concern of local government officials and the State legislative delegation, Governor Ridge and Governor Schweiker devoted extraordinary State Police and National Guard attention and security around the clock at Three Mile Island.

It is for that reason, Madam President, that today I come to the floor of the Senate rather stunned and disappointed at the rather precipitous action that has apparently been taken today by Governor Rendell, announcing that effective at midnight tonight, the around-the-clock security by National Guard and State Police at all of the nuclear power plants of Pennsylvania will be terminated. The precipitous action that Governor Rendell is taking tonight may or may not be justified. I simply do not know, because I only learned of this announcement a few hours ago by way of a press release that I obtained emanating from the Governor's Office. As far as I know, there has been absolutely no consultation on this action by anyone in State government, with any Member of the legislative delegation either here in central Pennsylvania or around any other nuclear power plant throughout the Commonwealth of Pennsylvania. I know for a fact that the borough of Middletown, situated in close proximity to Three Mile Island, was not consulted in advance. They learned of this action from my office. I know for a fact that the Dauphin County Emergency Management Agency, charged with evacuation procedures and some of the notification procedures attendant to that plant and that emergency plan down there, was not notified in advance of this action and heard it first from my office. I know for a fact, Madam President, that this is not a partisan issue, because my good friend and colleague from western Pennsylvania, Representative Mike Veon, in recent months has called for an extended National Guard presence at the nuclear power plants in Pennsylvania, due to the heightened security risks attendant to the war on terrorism. And in spite of the fact that we have had a slight reduction in the level of alert, it seems to me that at the end of the hostilities in the Middle East, now is not the time to be reducing State presence at the nuclear power facilities of the Commonwealth of Pennsylvania. I know for a fact, Madam President, that the people of my district and the central Pennsylvania region, having suffered the trauma of 1979, do not want a power plant like Three Mile Island, world famous, world famous, Madam President, and we know for a fact that it was a potential target of al-Qaeda and other terrorist organizations, we do not want to see the security of that facility compromised.

I am rather disappointed that the Governor failed to at least inform us in advance of this action that he has taken, and I am calling on him today, Madam President, and I hope soon in conjunction with many of my colleagues in the General Assembly, to call upon him to delay and postpone indefinitely this precipitous action until he and his experts in State government have had the opportunity to explain to us, to explain to the local government officials of central Pennsylvania, and all of Pennsylvania, as well as the people of central Pennsylvania, why this action is in their best interests and why it should be done.

So today, Madam President, I rise on the floor of the Senate to express my disappointment in the Governor and his rather precipitous action and his failure to communicate, not only to the legislature and not only to the local government officials, but to take this precipitous action without even consulting the people of Pennsylvania whose lives and security are at risk in proximity to these plants.

Madam President, I thank you for allowing me to make these remarks under Petitions and Remonstrances.
