An Act amending the act of March 10, 1949 (P.L.30, No.14). known as the Public School Code of 1949, adding definitions; further providing for background checks of prospective employees and conviction of employees of certain offenses, for fiscal year, for tax levy and limitations, and for per capita taxes; authorizing school districts to reopen their 2003-2004 budgets; imposing limitations on certain unreserved fund balances; repealing provisions relating to professional teacher assessment; further providing for residence and right to free school privileges, for cost of tuition and maintenance of certain exceptional children in approved institutions and for actual cost of tuition and maintenance of certain exceptional children in the four chartered schools for education of the deaf and the blind; providing for firefighter and emergency service training; amending provisions relating to the education support services program; providing for the educational assistance program and the Head Start Supplemental Assistance Program; defining "history of financial distress"; further providing for education empowerment list, for implementation of school district improvement plan by board of school directors, for education empowerment districts, for school improvement grants, for mandate waiver program and for definitions; providing for State System of Higher Education campus police powers and duties; imposing certain limitations on provisions relating to education empowerment; amending provisions relating to educational improvement tax credit; further providing for small district assistance and for temporary special aid to school districts suffering loss of tax revenue due to reduction in assessed valuation of taxable property; providing for basic education funding for 2002-2003 school year and for reimbursement of additional expenses related to basic education; further providing for payments to intermediate units, for special education payments to school districts, for extraordinary special education program expenses and for Commonwealth reimbursements for charter schools and cyber charter schools; providing for Pennsylvania accountability grants and Keystone educational accountability; further providing for powers and duties of the State Board of Education; providing for teacher recruitment assistance; and making a related repeal.

#### ANNOUNCEMENT BY MAJORITY LEADER

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Madam President, for the information of the Members, we are about 15 minutes away from having final bills ready so we can wrap things up.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, at this point in time, for the benefit of PCN viewers, I say if you are up this late watching us, you need a life. We have set a new record today at a quarter to 7:00, and if you are up this early, good luck in your day's work.

We have been at this for 24 hours now, so those critics who say that we do not work, we do.

Madam President, this has been long and arduous, but in the end an enjoyable process to come to this evening to complete our budget, finally. We were the last State in America, but we did get it done and we are bringing all that to fruition tonight. I think as an institution, bipartisan institution, this Senate did very well this year in standing up for the principles that we all believe in.

Tonight I would like to thank a lot of the staff people who have helped, and if I miss someone's name, I sincerely apologize.

First, I would like to thank Tom Starke from the Republican Committee on Appropriations, the executive director, for his historic discovery, and what will always be remembered is that Tom actually looked at one of those sheets that we had and read it and found \$700 million when the rest of us did not see it. We thank him for that. I want to thank Donna Malpezzi, Steve MacNett, Drew Crompton, Dave Broderic, Erik Arneson, Greg Jordan, and George Riddle from the Republican staff who worked so well with our staff.

On our side, I want to thank Paul Dlugolecki, our executive director, C.J. Hafner, Tony Lepore, Sandy Leopold, Randy Albright, John Raymond, Liz Craig, Chris Craig, Gladys Brown, and Mark McKillop. I think that this was a great experience for our staff. I e-mailed someone that this was really a horrible budget process, and then I said maybe it was not, it has just been 8 years since we have had one, and maybe I forgot what it was like. But we all learned to negotiate budgets. We appreciate the courtesies that were extended, and we appreciate the cooperation. I think the staffs did very well working together rather than in an adversarial role.

So, I would like to thank everyone tonight. I want to thank Chip Brightbill for his efforts and Bob Mellow and my colleague, Senator Thompson. Thank you, everyone. Fortunately, it turned out pretty damn good.

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Madam President, I learned a long time ago that you do not go second after Senator Fumo. He usually says everything there is to say. So, I simply echo his comments. The people that he mentioned and some others really did a terrific job. There are a lot of very, very good, dedicated people who work here, and while Senator Fumo mentioned that we have been at this for 24 hours, this institution and its employees have been at this pretty much since Sunday night with very, very minimal amounts of sleep on the part of the staff. There are people in the Legislative Reference Bureau, the print shop, and so forth and so on, grinding this work out, because this does not just happen. This really was very much a process where people put aside their partisan differences and decided that we had to get it done. That does not mean there were not differences, and it does not mean that we did not have to come to some compromises, but at the end of the day, we knew that we could not take this to the jury, we could not wait for some third party to step in, we had to get the job done.

I would just like to comment that while we are well into the fiscal year as we adopt this, because of the way the process developed with the budget that we did adopt back in March, there was a lot more worry and crying afoul out there in the public than really was necessary. Every school district will get not only more money than they anticipated when they did their budget, but they will also get interest on their money. At the same time, we have backed into a process when we do this year's budget, we have the best numbers available as to what this fiscal year will look like, as well as what the next fiscal year will look like. Of course, as we work through this week to try to come up with a set of numbers that will serve the Commonwealth of Pennsylvania, by providing the services that really are necessary and at the same time keeping the taxes as low as possible, we look not only at this year but at next year, too, and I am happy to be able to report that when the Governor makes his Budget Address, which I think will be in about 10 minutes, he will have the money and we will have the money to run this Commonwealth, and we will not have to come back to the people again.

Madam President, this process works, and I am indeed proud to work here and work with these folks. This Caucus as well as the Democratic Caucus, each and every Member was called upon at one time or another during this process to get something done, and they and their staffs went ahead and accomplished it. It was very much a team effort. No one person runs this show, and it is something that we all participated in. So with that, Madam President, I simply say thank you to the people of the Commonwealth of Pennsylvania for the opportunity to do this.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, there is one person I did forget. He is a staffer, and he reminds us of that ever since we were at the mansion, and he is John Estey, the Governor's chief of staff; and we also want to thank him for his efforts. He has never run back and forth to this Chamber so many times. He used to be a very successful lawyer in Philadelphia. I think we asked him about 2:30 a.m. what he was doing up here, and I said he likes hanging out with the big guys eating pretzels at 2 o'clock in the morning. We thank him and his staff for their efforts and remind him again that he is a staffer.
