An Act amending the act of February 1, 1966 (1965 P.L.1656, No.581), known as The Borough Code, further providing for regulation of contracts; and providing for additional contracting authority for electric power and energy.

SB 317 (Pr. No. 315)

An Act amending the act of August 9, 1955 (P.L.323, No.130), known as The County Code, further providing for commissioners sole contractors for county, for contract procedures, terms and bonds and advertising for bids and for evasion of advertising requirements.

SB 318 (Pr. No. 316)

An Act amending the act of June 23, 1931 (P.L.932, No.317), known as The Third Class City Code, further regulating contracts as to purchasing and advertising requirements.

SB 319 (Pr. No. 317)

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, further providing for competitive bidding of contracts.

SB 320 (Pr. No. 318)

An Act amending the act of June 24, 1931 (P.L.1206, No.331), known as The First Class Township Code, further providing for contracts and acquisition of property and for general regulations concerning contracts.

SB 321 (Pr. No. 319)

An Act amending the act of February 1, 1966 (1965 P.L.1656, No.581), known as The Borough Code, further providing for regulation of contracts, for evasion of advertising requirements and for certain purchase contracts.

SB 322 (Pr. No. 320)

An Act amending the act of May 27, 1953 (P.L.244, No.34), entitled "An act relating to and regulating the contracts of incorporated towns and providing penalties," further providing for regulation of contracts; providing for annual adjustment; further providing for evasion of advertising requirements, for contracts between \$750 and \$10,000 and for separate bids for plumbing, heating, ventilating and electrical work.

SB 323 (Pr. No. 321)

An Act amending Titles 53 (Municipalities Generally) and 74 (Transportation) of the Pennsylvania Consolidated Statutes, further providing for competitive bidding of contracts by intergovernmental units, by parking authorities, by municipal authorities and by metropolitan transportation authorities.

SB 324 (Pr. No. 322)

An Act amending the act of July 28, 1953 (P.L.723, No.230), known as the Second Class County Code, further regulating contracts and purchases.

SB 325 (Pr. No. 323)

An Act amending the act of August 6, 1936 (Sp.Sess., P.L.95, No.38 1/2), entitled "An act to authorize and empower cities, boroughs, towns, and townships, separately or jointly, to provide for protection against floods by erecting and constructing certain works and improvements, located within or without their territorial limits, and within or without the county in which situate; and to expend moneys and incur indebtedness; to assess benefits against property benefited; to issue improvement bonds imposing no municipal liability; and to acquire, take, injure or destroy property for such purposes," further providing for competitive bidding of contracts.

SB 326 (Pr. No. 324)

An Act amending the act of April 29, 1937 (P.L.526, No.118), referred to as the Political Subdivision Joint Purchases Law, increasing the amount of purchases that may be made subject to certain conditions.

SB 327 (Pr. No. 325)

An Act amending the act of July 29, 1953 (P.L.1034, No.270), known as the Public Auditorium Authorities Law, increasing the dollar amount of supplies and materials which may be purchased without advertising.

SB 419 (Pr. No. 420)

Senator SMUCKER. Mr. President, it is my pleasure to introduce guests today, visitors who I believe would win the farthest-traveled award. Since 1983, 83 Chinese executives have enrolled in the program and returned to China, where they have been instrumental in the rapid changes taking place in that country.

Program participants visit various companies, government offices and agencies, community organizations, schools, hospi-

tals, and retirement communities. These extended visits in an actual business setting enhance the principles learned in the classroom and help the participants develop an understanding of the United States through hands-on experience.

The program is also a great resource for the Pennsylvania business community in exploring business opportunities in China, as well as promoting opportunities for Chinese investment in the Commonwealth. Regardless of business opportunities gained, the most important aspect of the program is its effectiveness in fostering mutual understanding between the people of our nations. I am delighted that they could visit today. Please give them a warm Pennsylvania welcome.

SB 490 (Pr. No. 750) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of December 15, 1955 (P.L.865, No.256), entitled "An act requiring rents and royalties from oil and gas leases of Commonwealth land to be placed in a special fund to be used for conservation, recreation, dams, and flood control; authorizing the Secretary of Forests and Waters to determine the need for and location of such projects and to acquire the necessary land," providing for an interfund transfer; making appropriations from the Oil and Gas Lease Fund; authorizing an expenditure; and making editorial changes.

On the question,

Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I respectfully ask if the prime sponsor would stand for interrogation.

The PRESIDENT. She indicates she will.

Senator COSTA. Mr. President, the first question I have as it relates to Senate Bill No. 490 is, this is legislation that proposes transferring \$174 million from the Oil and Gas Lease Fund, as

well as some other moneys, which I will talk about later. My first question is whether or not this is intended to be a one-time transfer or a one-time occurrence, that this does not authorize the General Assembly to be able to tap into the Oil and Gas Lease Fund at a later date and time but rather is restricted to a one-time transfer.

Senator M.J. WHITE. Mr. President, this current bill, Senate Bill No. 490, relates only to the current lease payments for this past fiscal year for the 75,000 acres of State forest land that were recently leased.

Senator COSTA. I am sorry, Mr. President, I could not hear the last part of that answer.

The PRESIDENT. Will the Senate please come to order. Would the gentlewoman please restate her answer to the gentleman's question.

Senator M.J. WHITE. Mr. President, Senate Bill No. 490 relates only to the payments that were received for the 75,000 acres that were leased on State forest land. It does not have any other prospective application.

Senator COSTA. So, Mr. President, as we go forward and begin to lease additional forest lands to individuals who want to do drilling of the Marcellus Shale, this would not obligate those additional leases and royalties to ongoing transfers beyond this \$174 million, is that correct?

Senator M.J. WHITE. That is correct, Mr. President. If we were to do that, it would require additional legislation.

Senator COSTA. Thank you very much, Mr. President.

The second question I have relates to, as we have discussed, it talks about the \$174 million, but the legislation appropriates from that gas fund in excess of \$174 million. It is \$174 million plus, I believe, an additional \$8.5 million for other projects and other programs. My question is, at this time, as I understand it, there is about \$165 million in the fund, with an anticipation that by year's end, there will be roughly \$196 million or so. My question is: Will the first \$174 million into the fund from the Oil and Gas Lease Fund be transferred first? At this point, we are not quite there yet, but by the time the legislation is enacted, will the \$174 million come out first, and then we may or may not consider the remaining provisions in the legislation?

Senator M.J. WHITE. It is my understanding, Mr. President, that the \$174 million is already included in the Governor's proposed budget, and that would be the first money out.

Senator COSTA. Thank you, Mr. President.

Mr. President, finally, in terms of the nature of the projects that are eligible for funding through this program that we are taking the funds from, it is my understanding that there are other types of funding streams that are now available and that we enacted here in the General Assembly, that these type of projects could seek to receive funding through these programs. Mr. President, I am wondering whether or not the prime sponsor and the maker can discuss, briefly, some of those avenues or some of those pots that are now available that may not have been available in years past.

Senator M.J. WHITE. Mr. President, we have adopted a number of very beneficial programs, particularly relating to dams and flood protection. The $\rm H_2O$ program deals with drinking water. That is paid for with gambling funds. We did a bond issue for other water-based initiatives and conservation initiatives. So the

gentleman is correct. There are other programmatic pots of money that are available for some of these activities. That is correct.

Senator COSTA. Thank you, Mr. President.

Finally, Mr. President, I just want to add that, I think, as the Members know, the transfer of the \$174 million has been contemplated by the administration as one of the ways in which we are going to solve the budget dilemma, the budget deficit that we have for 2008-09. But in addition to doing that, this legislation provides for, as I indicated, an additional \$8.5 million of spending. I think it is important that we make certain that the \$174 million be utilized in the appropriate fashion as soon as it comes in and gets out the door.

No doubt, we will have further discussion in the House, I believe, and ultimately, when we enact the final budget, whether or not Senate Bill No. 490 will stand on its own through the House or whether or not we get to a point where it will be incorporated into what we do in the General Fund budget conversation. But I think it is important that we move the vehicle forward, and I intend to support the legislation.

So I thank the gentlewoman for her answers.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I rise to speak against the bill, because I believe that you are taking one particular type of program that deals with the environment, and you are moving it. I might in the end have no objection, but I believe that we need to look at this holistically. For five decades, this money has remained in the budget through recessions, through economic difficulties, to support the environment. We took a resource out of the land, and we used the money to put it back into appropriate programs that allowed us to restore the natural environment.

We are making the decision now to end this program. I know there are other sources of funding. But when the legislature and the voters approved Growing Greener and other sources of funding, they did so with the full knowledge that this program was also in place. All I am saying is everyone has to make a sacrifice, including those who are for the environment.

But I believe to do this now, to choose one area and move it, that those that -- many of you have received letters from all of the major environmental groups within the Commonwealth, including from your districts, which have said, do not move this now. We understand, for example, it is possible that there will be a tax, a severance tax, that might be able to take the place of this funding, but I am not comfortable with moving it now. I want it to be done in coordination with the total budget. So that is why I rise to oppose it.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Venango, Senator Mary Jo White.

Senator M.J. WHITE. Mr. President, I rise to ask for an affirmative vote on this bill. I think it is important to know that this is a lease payment. No wells have been drilled on the State forest land at the current time. In fact, DCNR had a moratorium on any oil and gas leases on State property for several years. This is the first one that has been done in my recent memory, so this is not money that has been going into these coffers, because we have not been doing any leasing. I think it is no secret that the

Marcellus Shale interest and the huge--no one anticipated the size of these lease payments, because it has been unprecedented in the State.

I understand the disappointment of some of the conservation folks who thought they had a \$180-million windfall and now are seeing it taken away to plug the budget hole, but these are very difficult times. And I am not taking anything away from the importance of their programs. I am simply saying that if we are going to get through this budget successfully, we must use this money to plug the very serious budget hole we have. In fact, it points out the problem with dedicated funding. It takes away your ability to budget when money is automatically earmarked for specific uses. This is a time when we need all the budget powers we have.

The Governor has included this in his budget proposal, and I think it is a sensible one, and we certainly have a number of programs to help the conservation districts. We put \$1 million in here for the conservation districts, to assist them in any oil and gas activities that they may be asked to perform in connection with the Marcellus Shale. We also put some money in for the Fish and Boat Commission for similar responsibilities, as well as money for a demonstration project that DCNR wants for carbon sequestration. So we did use some of it for good environmental purposes, but the bulk of it really needs to go to plug the budget hole, and I hope my colleagues will agree.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, not to prolong the debate on the bill, but I think just to make a very important point, we are now in the process of the time of the year of taking care of a budget, and we all know that this is going to be an extremely difficult, very complex year in trying to satisfy the needs of the Commonwealth and the needs of the Members of both the House and the Senate in trying to come up with a budget that will be acceptable, not only by 26 Members of the Senate but by 103 Members of the House of Representatives and, equally as important, by the constituencies that we represent.

Mr. President, I view the enactment of Senate Bill No. 490 as a budgetary process. I do not see this particular bill as a free-standing bill that is going to do anything other than--and it is a very important bill, and I congratulate the sponsors, because it is something that is badly needed, but I think ultimately this is going to be part of, or somewhere in, the budgetary process that we are now in the middle of going through. So I personally view a vote in favor of this bill as not a vote against any one particular group, but a vote in favor of moving the process on to the next level, where we can continue the job and, hopefully, get it finished.

Thank you, Mr. President.

And the question recurring, Shall the bill pass finally?

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Mr. President, I really just want to rise today for the benefit of the Members to provide an update on an initiative that is bipartisan in nature and seeks to retain young Pennsylvanians in our Commonwealth and, perhaps more importantly and broadly, encourage young people throughout the world to come and become Pennsylvanians. And statistically, in this

Commonwealth, I am discouraged to announce, we are not doing very well retaining our young people.

I define a young Pennsylvanian as someone between the ages of 18 and 32. In fact, on a statistical basis, the Commonwealth ranks 36th, 14th from the bottom, in retaining young people. And survey after survey suggests when asking someone in their mid-20s why they are no longer remaining in our Commonwealth, it is because they do not see economic opportunity. They do not see job security. They do not see the Commonwealth as a place in which they could be empowered to be our next generation of entrepreneurs.

So in late November of last year, Mr. President, a number of us convened a working group of young individuals, young professionals from throughout this Commonwealth, to develop a short, medium, and long-term legislative agenda for that growing demographic. And today, on a bipartisan basis, we announced--and over the next several days, we will be introducing--legislation that, first, encourages entrepreneurship in this Commonwealth, that creates a more business-friendly environment for someone in their mid-20s to take that risk and start an enterprise.

Mr. President, the statistics do not lie. If you look at, on a percentage basis, the number of jobs that will be created in this Commonwealth between now and 2020, 50 percent of new jobs created between now and 2020 will be the result of someone in their mid-20s, with a germ of an idea and a little bit of risk, starting that enterprise. And so I applaud Senator Farnese, who will be introducing legislation in support of encouraging the language of entrepreneurship into our public school curricula, starting first with personal finance, and then literally how to start your own business, so that perhaps emerging graduates of this Commonwealth will not only understand the language of entrepreneurship, but will take that risk.

I also want to applaud Senator Eichelberger as chair of our Committee on Local Government. He will be offering resolutions and legislation that will encourage the myriad Commonwealth boards and commissions at the State, county, and local level, to encourage someone in their mid-20s to serve in an ex-officio capacity on that board or commission, so that someone who is a young Pennsylvanian can serve on a zoning board or the local water or sewer authority and perhaps get a taste of what it means to actively engage in appointed or elected citizenship and then, perhaps, take that step in becoming actively involved much sooner rather than later. It is our opinion that such involvement empowers individuals in their mid-20s in this Commonwealth not just to stay here, but to remain here as well.

And then finally, Mr. President, we are introducing an array of bills that support lifelong learning, that understand that if you are 25 years of age, and you are in Pennsylvania or coming to Pennsylvania, that you are going to need to continue learning in an applied way so that you continue to be employed in whatever your career pursuits might be.

So under the banner of "You Lead," Mr. President, from which we have built a legislative agenda to focus on entrepreneurship, education, and empowerment, I am delighted to recognize not only Senator Farnese and Senator Eichelberger, but Senator Alloway, Senator Folmer, Senator Costa, and Senator Stack as well.

Senator FONTANA. Mr. President, I would like to rise to clarify some information that has been passed around the Chamber referring to a rock-and-roll group called Wayne Fontana and the Mindbenders. On behalf of those of us who did read the literature that was provided on our desks and then went and got an autograph from Senator Fontana, I guess he is now telling us they are of no value, with his comments, so we are asking for a refund. And all the young ladies who are in the Chamber who actually got those signatures also, we want to defend their honor on your behalf.

To Senator Brubaker, we want to thank him for this light-hearted moment. We also enjoy laughing with you, Senator Fontana.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, I know it is Wednesday, and all of us are anxious to get back to our respective districts, and I am not going to talk about sports, although, "let's go Pitt."

Mr. President, I think you will clearly recognize that the fundamental issue on the minds of most Americans today, aside from all the problems that we have being in military conflict, the struggling economic recovery plan, you could go on endlessly about the daily struggles and crises that we go through, but I would venture to guess that one fundamental issue is the whole issue of the healthcare industry in our country and the fact that today, as we continue to speak in these Chambers about needed healthcare reforms, more than 47 million Americans have no form of adequate health insurance. Of the 20 to 25 million Americans who have health insurance, we continue to see situations where they are underinsured. We keep hearing about the insurance staff person on the other end of the line who often will tell the patient or the hospital that a particular needed medical procedure just cannot be covered, as a preexisting condition, you name

it. There are all kinds of concerns and complaints attributed to the healthcare industry in this country, but the fundamental issue has to do with the financing mechanism in which we either do or do not provide necessary healthcare.

There is a very significant movement around this country in every local community and every State government, in every union shop and every church meeting, religious meeting, PTA meeting, you name it. People are beginning to discuss the actual nature of the healthcare industry in our country today. And there is a profound movement in support of a basic, fairly simple concept that has been referred to as the single-payer healthcare plan. It is much-maligned by big industry and big insurance companies and others who have a vested interest in the profit nature of our healthcare industry in this country. But it is really a fundamentally simple, basic way in which we can guarantee, very similarly, the Medicare system, only this would be a system that would provide Medicare for all, cradle-to-grave coverage, comprehensive universal coverage, everybody in, nobody out. That does not come without a cost, as you well know, Mr. President, It would be a cost that everyone would contribute to, be they large businesses or small, be they private individuals, be they host communities and municipalities. So we are talking about a fundamental change in the manner in which we provide healthcare coverage.

This coming Saturday, there is a very focused conference on the campus of Carnegie Mellon University, Saturday, March 28, from 9 to 4 p.m. I encourage Pittsburghers who are interested in learning more about the single-payer plan, both the national piece of legislation that has well over 75 congressional cosponsors, House Resolution No. 676, Congressman Conyers' plan for single-payer, and as well, Representative Manderino has offered legislation in the House, House Bill No. 1660. I have companion legislation. These are works in progress. Senate Bill No. 400 would set up and establish a statewide version of single-payer.

I just want to close and reiterate that the conference is open and available to the public to learn more about the single-payer approach, how we can best work to educate and organize and advocate to government officials and to those in the community who have the sincere desire to grapple with a complicated issue but something that can be made much more simple than individuals are presenting in our nation today. Some want to gang up on the single-payer concept. Many of those are private health insurance corporations that, right now, have been raking in billions of dollars. And we know for a fact that a publicly administered medical trust fund would provide coverage with less than 3 to 4 percent administrative overhead, and private insurance corporations in our country are providing coverage with 12 to 14 percent overhead. Mr. President, as you well know, when we say "overhead" and use numbers like 12, 14 percent, we are literally talking about billions and billions of wasted dollars that do not go into the direct delivery of healthcare.

I encourage Pittsburghers and those throughout the southwestern Pennsylvania area to attend this conference. You can call my office at 412-621-3006 to learn more about single-payer healthcare for all. Demand first-rate, comprehensive healthcare. The conference is this Saturday, March 28, on the campus of Carnegie Mellon University. And in the future, we will talk at length, but we will provide that opportunity for another day.
