SB 1087 (Pr. No. 1544)

An Act establishing a joint legislative, executive and judicial commission on the child-welfare system.

HB 1233 (Pr. No. 3188) (Amended)

An Act amending the act of July 9, 1976 (P.L.817, No.143), known as the Mental Health Procedures Act, in general provisions, further providing for scope of act, providing for definitions, further providing for individualized treatment plan, and assisted outpatient treatment implementation by counties; in involuntary examination and treatment, further providing for persons subject, for persons for whom application may be made, and for additional periods of court-ordered involuntary treatment; and adding provisions relating to assisted outpatient treatment.

HB 1869 (Pr. No. 2592)

An Act establishing the Maternal Mortality Review Committee and providing for its powers and duties; providing for duties of the Department of Health; and imposing a penalty.

Senator WAGNER. Mr. President, I rise to request a ruling from the Chair. I seek a ruling from the Chair pursuant to Rule 20 as to whether I can vote on Senate Bill No. 761 as a candidate for Governor.

The PRESIDENT. Thank you, Senator Wagner. Give me one moment and I will give you a ruling.

As to your inquiry, Senator Wagner, the Chair rules that there is no conflict of interest, and in accordance with Senate Rule 20(c)(2), the Senator must vote for two reasons. The first is that the Chair finds the gentleman, albeit a candidate for statewide office, is a member of a class of individuals who may or may not be affected. The gentleman has not even been nominated, so therefore, he is still part of a speculative class that may or may not be relevant. Second, the Chair does not find that any votes that the gentleman would cast would be particularly personal to the Senator or privately affect the Senator alone, so the Senator must vote.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I would like to thank the maker of the bill for his intent, and my amendment is intended to be a technical amendment, although I understand that some may believe it makes substantive changes. What I seek to do is offer language after the portion of the bill that defines victim. And what I suggest we do is that we say victim as judicially determined as opposed to simply saying as determined by statute. The reason for this is simple; anyone could try to avail themselves of the rights of a victim by filing a private criminal complaint, and in so doing, could then say that they are immune from inquiry by the true victim's parties. Let us say for instance, Mr. President, I was to mug you and you were to strike me and knock me out in the process, because you are a pretty robust guy, and I were to file a private criminal complaint against you, I could then assert my - even though a judge would determine that you were defending yourself, in the intervening period, I could claim protection against you, which would not be appropriate.

I had colleagues explain that in some places there is a district judge that would have to review these complaints and would immediately throw out that concern, so this is unnecessary. However, I point out to folks that for the nearly 1.6 million people who live in the city of Philadelphia, there are no district judges. We do not have district judges, and there would be no determination made until a later point, at which point in time a municipal judge would later consider this matter. Because a district judge is making a determination, I do not see how this would harm any other county and it would still preserve all of the great intent of this bill. However, it would resolve confusion to the people who live in a city of the first class and it would still allow us to move forward with all of the great protections that I applaud the maker of the bill for putting forth.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Reschenthaler.

Senator RESCHENTHALER. Mr. President, my colleague, Senator Street, has definitely raised an important question, but I believe that for a private criminal complaint, in most counties, a DA has to sign off on that, and typically a district judge is there at the time that decision is made, or quickly thereafter.

But I believe that our criminal justice system, and this is supported by statute, already provides for the definition of a victim. When a crime is committed, there is an investigation, and there is an affidavit of probable cause, and then charges are filed. I do not believe that defining who a victim is should therefore be left to the discretion of the courts when it is already provided in statute and in the affidavit of probable cause, it would be clear who the victim is. Victims groups, the District Attorneys Association, and I all agree this should be the role of the General Assembly in the criminal justice system to determine by statute who a victim is and the definition thereof. So, therefore, I ask my colleagues for a negative vote on this amendment.

Thank you, Mr. President.

The PRESIDENT. For the second time, the Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I point out that the process the gentleman outlines is correct for many counties, but as anyone can look, there are no district judges in the cities and counties of the first class. In fact, if a district judge is available, then that determination, the minor provision that I have included would be satisfied almost immediately by the maker's own words. Therefore, it has literally no impact, my amendment, on any other county other than the county that does not have district judges, and so I ask for an affirmative vote on the amendment.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Mr. President, just for the record, dealing with approval of private criminal complaints, when the affiant--and I point to Rule 506 of the PA Code: "When the affiant is not a law enforcement officer, the complaint shall be submitted to an attorney for the Commonwealth, who shall approve or disapprove it without unreasonable delay." That is codified. So, it would go to an attorney to be approved. Thank you.

The PRESIDENT. Without objection, for the third time, the Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I submit that in practice, in fact, there is significant delay when those determinations are made, perhaps because of the volume. I know we have district attorneys looking at improving that process, but as it stands now, I do not think that this would cause any harm for any other county, and it would add some additional protections.

So, again, while respectfully appreciating all of the comments others have made, I am just asking for a little help for city of the first class, and it does not really hurt anyone else. Thank you.

A Resolution honoring the life and accomplishments of physicist Stephen Hawking.

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Mensch.

Senator MENSCH. Mr. President, not too long ago we passed Senate Bill No. 21, which is the codification of the attempt for I Want to Work, which is funding for people with disabilities who have a greater skill than perhaps is physically apparent because they are wheelchair-bound or they are in some other way immobile. So, with the passing of Stephen Hawking, I thought it would be appropriate to recognize this man's great talent and the wonderful contributions that he has made to world society.

Stephen Hawking was one of the most brilliant theoretical physicists in history, and he died on March 14, 2018. He began studying physics at University College, University of Oxford, in 1959. After completing his initial degree, he went on to study cosmology, the study of the universe as a whole. In 1963, before his 21st birthday, Dr. Hawking was diagnosed with a motor neuron disease commonly known as Lou Gehrig's disease, or ALS. Given 2 years to live, he defied the odds. He attained his Ph.D., and he also forged new roads into the understanding of the universe in the decades since first attaining his Ph.D.

Dr. Hawking continued as a fellow at Cambridge University after his graduation, and in 1979 was appointed the Lucasian Professor of Mathematics at Cambridge University, a post once held by Sir Isaac Newton. Again, it is important to realize that this man, for 16 years, has been diagnosed with ALS. Speech is becoming very difficult, he lives in a wheelchair, he communicates very often with a touch talker computer, and yet he is achieving all of these wonderful achievements. Now, while ALS robbed him of his mobility and his speech, over the course of his career, his work on the origins and the structure of the universe from the Big Bang to black holes revolutionized the field. Dr. Hawking was, as I said, bound to a wheelchair, could not type, and yet he typed a book. He wore a device on his head, kind of like a pointer that we are familiar with, and working on a keyboard, was able to write and complete his book.

In 1988, he published his book called *A Brief History of Time*. I do not know how many people have read that. I have. It is fascinating work. It is very often presented as a primer. It is anything but a primer. It is very, very detailed, and it shows the brilliance of the man. He sold more than 10 million copies of that book. His other best-selling books have spread knowledge and insight to many readers who have not had his scientific background. As such, Stephen Hawking became an emblem of human determination, curiosity, and ability. Therefore, I ask that the Senate honor the life and accomplishments of this great man.

Senator CORMAN. Mr. President, yesterday, February 18, marked one month since the big reveal at THON 2018, and this is the first time we had the opportunity to come to the Senate floor since that moment. For those of you who are not familiar, THON is the largest-run student philanthropy organization in the world. It is pretty amazing that right here in Pennsylvania and at Penn State University, the largest student-run philanthropic event is held right here in Pennsylvania. THON is a 46-hour, no-sitting, no-sleeping, and lots-of-dancing event held every February. Seven-hundred-plus students are recognized as dancers for THON. The weekend entails them standing on their feet for the entire weekend. In total, more than 16,500 students were engaged in THON's year-long fundraising effort, and since 1977, THON has donated more than \$146 million to the Four Diamonds Fund. Again, one of the largest funds in the world right here in Pennsylvania. So, I want to take this opportunity to congratulate and thank all of the students for all of their hard work. Again, THON is one weekend, but the fundraising is all-year-round. While we all wish there was no need for THON, hopefully, this will go a long way to putting cancer in the past. Mr. President, I want to take a moment to recognize all of the students at Penn State University, all of the sponsors, and all of the folks who contribute to THON for this very, very worthy cause.
