

**EDWARD F. DRACH BRIDGE - DESIGNATION**  
**Act of Nov. 24, 1992, P.L. 717, No. 108**  
AN ACT

CL. 87

Designating the bridge on which Central Avenue crosses over the Tookany Creek in Cheltenham Township, Montgomery County, as the Edward F. Drach Bridge; and making repeals.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The bridge on which Central Avenue (L.R. 46121) crosses over the Tookany Creek in Cheltenham Township, Montgomery County, is hereby designated and shall be known as the Edward F. Drach Bridge.

Section 2. The Secretary of Transportation shall erect suitable markers in order to carry out this act.

Act of May 30, 1780 (1 Sm.L.506, Ch.899), entitled "A further supplement to an act, entitled 'An act for regulating and continuing the nightly watch; enlightening the streets, lanes and alleys in the city of Philadelphia, and for other purposes therein mentioned'; and to an act which is a supplement thereto, passed in the year of our Lord one thousand seven hundred and seventy-six."

Act of September 22, 1785 (2 Sm.L.350, Ch.1172), entitled "An act for regulating the measurement of corn and salt imported into the Port of Philadelphia."

Act of March 28, 1787 (2 Sm.L.401, Ch.1268), entitled "An act for securing the city of Philadelphia, and the neighbourhood thereof, from damage by gunpowder."

Act of December 5, 1789 (2 Sm.L.513, Ch.1461), entitled "An act to provide for the custody of prisoners committed under the authority of the United States."

Act of March 28, 1799 (3 Sm.L.359, Ch.2027), entitled "A supplement to an act, entitled 'An act to regulate hawkers and pedlars.'"

Act of April 11, 1799 (3 Sm.L.390, Ch.2080), entitled "An act to supply certain defects in the acts incorporating the city of Philadelphia, and sundry towns and boroughs within this commonwealth, and to explain and amend an act, entitled 'An act to alter and amend the several acts of the General Assembly of this commonwealth, incorporating the city of Philadelphia, and for other purposes.'"

Act of April 6, 1802 (P.L.265, No.91), entitled "An act authorizing the sale of Provisions, Vegetables and Fruit, in the markets of any city, borough or corporate town within this Commonwealth."

Act of April 2, 1822 (P.L.139, No.109), entitled "An act to regulate the sale of Stone Coal within the city and county of Philadelphia, and to prevent the adulteration of Linseed Oil."

Act of March 8, 1823 (P.L.62, No.50), entitled "An act vesting the corporation of the city of Philadelphia, and the corporations of the adjoining townships and districts in the county of Philadelphia, with additional powers."

Act of February 3, 1824 (P.L.18, No.18), entitled "An act relating to taxes on certain real estate, in the city and county of Philadelphia."

Act of February 8, 1848 (P.L.29, No.31), entitled "An act relative to the coroners of Berks and Lancaster counties."

Section 9 of the act of April 11, 1848 (P.L.504, No.352), entitled "An act relative to the Wills hospital for the relief of the indigent blind and lame; also in reference to the Mill Creek and Mine Hill railroad company; to the election of school directors in the first school district; to the division line between certain counties; to the introduction of powder into the city of Philadelphia, and to the townships of Fairfield and Summer Hill, Crawford county."

Act of April 10, 1849 (P.L.619, No.397), entitled "A supplement to an act, entitled 'An Act relative to the organization of courts of justice,' passed the fourteenth day of April, Anno Domini one thousand eight hundred and thirty-four."

Sections 2 and 4 of the act of May 15, 1850 (P.L.772, No.442), entitled "A supplement to an act, entitled 'An Act to create a sinking fund, and to provide for the gradual and certain extinguishment of the debt of the commonwealth;' and to authorize a loan."

Sections 9 and 10 of the act of April 12, 1851 (P.L.488, No.284), entitled "An act to incorporate the Union School and Children's Home Asylum, to provide for the taxation of non-resident venders of merchandize in the city and county of Philadelphia, and for the relief of Edward Hutchinson."

Section 9 of the act of April 14, 1851 (P.L.569, No.315), entitled "A further supplement to the act entitled 'An Act authorizing the Governor to incorporate the Bear Mountain Railroad Company,' and for other purposes, passed July thirteenth, one thousand eight hundred and forty-two, and relative to roads, streets, and alleys in the borough of Pottsville, in Schuylkill county, to hawkers and pedlars in Armstrong and Carbon counties, to the Bethany and Dingman's choice turnpike road, to the district of West Philadelphia, to the bottling of cider and malt liquors, licensing billiard rooms and bowling saloons, to the district of Moyamensing, and to authorize Charles B. Mench to sell certain real estate."

Section 5 of the act of March 20, 1852 (P.L.172, No.131), entitled "An act relative to the board of health of the city and county of Philadelphia; relative to shop taxes and tavern licenses in the burnt district of Philadelphia; authorizing J. Engle Negus and Edwin L. Poalk, trustees, to sell certain real estate; authorizing the trustees of the Bustleton Academy to lease or transfer said academy to the controllers of public schools; to the Waterford and Erie plank road; and to vacate Jasper street, in the county of Philadelphia."

Act of April 6, 1853 (P.L.312, No.209), entitled "An act to prohibit the deposit of filth in the vicinity of the Kensington and Richmond districts, in the county of Philadelphia."

Section 9 of the act of April 18, 1853 (P.L.574, No.336), entitled "An act authorizing the Governor to incorporate the Germantown and Wissahickon Turnpike Road company; authorizing Joseph Barr to sell certain ground rents; to authorize the sale of certain real estate of Maria Myers; to vacate a portion of

Timber Lane in the district of Penn, Philadelphia county; relative to the claim of Ann Weaver; authorizing the sale of certain church property in Millersburg, Dauphin county; and to prohibit the erection of Poudrette Pits in the district of Moyamensing, Philadelphia county."

Section 8 of the act of April 20, 1853 (P.L.645, No.361), entitled "An act to incorporate the Washington and Manor Turnpike Road company; legitimating Frank Jones of the city of Philadelphia; relative to the election of Directors of the Poor in Allegheny county; to the Warren County Mutual Insurance company; to the Lackawanna and Susquehanna Railroad; to advertising Lumber drifting upon islands in the Susquehanna river; and relative to Lanes and Alleys in the city of Pittsburg."

Sections 9, 10 and 11 of the act of May 11, 1853 (P.L.672, No.375), entitled "An act to incorporate the Woodbury and Broad Top Turnpike or Plank Road company; relative to sale of a school house in Fulton county; extending the provisions of the second section of the act regulating Boroughs to the borough of Pine Grove, Schuylkill county; extending the provisions of the act to encourage Manufacturing Operations to the manufacture of flour and meal, in the counties of Philadelphia and Beaver; to the will of Jacob Moyer, deceased, of Bedford county; to prohibit the keeping of Bagatelle Rooms in Allegheny county; relative to the mill dam of M. M'Cullough, of Allegheny county; authorizing the Pennsylvania Railroad company to construct a line of Telegraph along their road; and refunding certain money to Wunderlich and Nead, of Franklin county."

Donelson and John J. Williams; relative to premiums on Wolf Scalps in Clinton county; to authorize Swedes Ford Bridge Company to borrow money."

Act of May 2, 1855 (P.L.391, No.415), entitled "An act supplementary to the Health Laws of the city of Philadelphia."

Act of May 7, 1855 (P.L.491, No.525), entitled "A supplement to the act passed the twenty-ninth day of March, one thousand eight hundred and three, entitled 'An Act to establish a Board of Wardens for the port of Philadelphia, and for other purposes.'"

Act of May 8, 1855 (P.L.529, No.548), entitled "A supplement to an act to regulate the taking up of Lumber, passed March twentieth, one thousand eight hundred and twelve."

Act of April 9, 1856 (P.L.292, No.306), entitled "An act relating to Wharves upon the Canals of the Commonwealth."

Act of April 14, 1863 (P.L.431, No.429), entitled "A further supplement to an act supplementary to the acts relating to hawkers and pedlers, and regulating auctions in the county of Schuylkill."

Act of April 1, 1864 (P.L.187, No.182), entitled "An act to authorize the macadamizing of the streets, in certain portions of the city of Philadelphia."

Act of April 9, 1864 (P.L.375, No.308), entitled "A supplement to an act to provide for the taxation of non-resident venders of merchandize, in the city of Philadelphia, and for other purposes, approved the twelfth day of April, one thousand eight hundred and fifty-one."

Act of April 19, 1864 (P.L.480, No.414), entitled "An act to secure to the owners their lumber, when lost in the Delaware river."

Act of March 22, 1865 (P.L.564, No.548), entitled "An act supplementary to the health laws of the city of Philadelphia."

Act of March 27, 1865 (P.L.791, No.781), entitled "A further supplement to the act to incorporate the city of Philadelphia, authorizing the construction of sewers, or drains."

Act of March 12, 1866 (P.L.160, No.135), entitled "A supplement to an act, entitled 'An act relative to the manufacture of fire works, in the city of Philadelphia.'"

Section 5 of the act of March 21, 1866 (P.L.248, No.228), entitled "A further supplement to an act to incorporate the city of Philadelphia, relative to the election of additional school directors in the Twenty-third ward, and defining the duties thereof, in the Twenty-third and Twenty-fifth wards."

Act of April 11, 1866 (P.L.588, No.563), entitled "An act to secure to the owners their lumber, when lost in the Schuylkill and Delaware rivers."

Act of December 11, 1866 (P.L.1365, No.1281), entitled "An act declaratory of the law relating to taking up lumber, and prohibiting the floating of loose saw logs in the Susquehanna river, between the town of Northumberland and the line of the State of Maryland."

Act of January 10, 1867 (P.L.1371, No. 1286), entitled "A further supplement to an act, entitled 'An Act to incorporate the subscribers to the articles of association for the purpose of establishing and conducting an institution for the confinement and reformation of youthful delinquents, under the title of the House of Refuge,' passed March twenty-third, one thousand eight hundred and twenty-six."

Act of March 22, 1867 (P.L.532, No.517), entitled "An act relating to the coroner of the city and county of Philadelphia."

Act of April 8, 1867 (P.L.50, No.34), entitled "An act to permit disabled soldiers to peddle, by procuring a license therefor, without charge."

Act of April 10, 1867 (P.L.1129, No.1070), entitled "An act

to prohibit political procession after dark, ten days next preceeding any general election, in the city of Philadelphia."

Act of April 11, 1868 (P.L.849, No.789), entitled "An act to define the duties and liability of passenger railway corporations in the city of Philadelphia."

Act of April 17, 1869 (P.L.49, No.38), entitled "An act further supplemental to the act relative to the elections of this commonwealth."

Act of April 6, 1870 (P.L.958, No.883), entitled "An act to protect ship-owners, and regulate the licensing of stevedores in Philadelphia."

Act of April 7, 1870 (P.L.57, No.36), entitled "An act to enlarge the jurisdiction of the court of common pleas for the county of Dauphin, in cases wherein the Commonwealth may be plaintiff, and to provide for the issuing of writs of foreign attachment in such cases."

Act of May 27, 1871 (P.L.1255, No.1159), entitled "An act supplemental to an act, entitled 'An act to protect ship-owners and regulate the licensing of stevedores in Philadelphia,' approved the sixth day of April, Anno Domini one thousand eight hundred and seventy."

Act of April 28, 1873 (P.L.77, No.56), entitled "An act regulating the election of state treasurer."

Act of March 18, 1875 (P.L.11, No.11), entitled "An act to provide for the ordinary expenses of the executive, legislative and judicial departments of the commonwealth, interest on the public debt, and for common schools, for the year Anno Domini one thousand and eight hundred and seventy-five."

Act of April 12, 1875 (P.L.46, No.51), entitled "An act authorizing and regulating the making of local appropriations to schools commonly known as homes for friendless children."

Act of April 17, 1878 (P.L.23, No.25), entitled "An act to prohibit and prevent the having or using of fire and lights on board of vessels, whilst lying at any maritime wharf, on or near to which petroleum is stored or kept for export."

Act of April 22, 1879 (P.L.30, No.25), entitled "An act extending the powers and authority of county auditors, authorizing them to settle, audit and adjust the accounts of the directors of the poor of the several counties of the commonwealth."

Act of May 2, 1879 (P.L.46, No.43), entitled "A supplement to an act entitled 'An act to regulate the sale of clams and oysters,' approved the fourth day of May, Anno Domini one thousand eight hundred and seventy-one, and supplement thereto, approved April tenth, Anno Domini one thousand eight hundred and seventy-three."

Act of May 13, 1879 (P.L.60, No.62), entitled "An act for the protection of the aids to navigation established by the authority of the United States light house board within the state of Pennsylvania."

Act of May 22, 1879 (P.L.73, No.84), entitled "An act to regulate places of public amusement in cities of the first class."

Act of June 11, 1879 (P.L.142, No.151), entitled "An act to protect children from neglect and cruelty, and relating to their

employment, protection and adoption."

Act of June 11, 1879 (P.L.147, No.153), entitled "An act fixing the compensation of persons called to serve as coroner's jurors in this commonwealth."

Act of June 1, 1881 (P.L.37, No.45), entitled "An act providing a rate of taxation for the bonds of any county, issued for the payment of losses occasioned by a riot."

Sections 2 and 4 of the act of June 30, 1885 (P.L.193, No.162), entitled "A further supplement to an act, entitled 'An act to provide revenue by taxation,' approved the seventh of June, one thousand eight hundred and seventy-nine."

Act of May 12, 1887 (P.L.95, No.45), entitled "An act regulating the compensation of county auditors, within this Commonwealth."

Act of May 13, 1889 (P.L.200, No.219), entitled "An act regulating the payment of traveling expenses of directors of the poor and county commissioners within this Commonwealth."

A concurrent resolution of February 20, 1895 (P.L.647, No.15).

Act of June 26, 1895 (P.L.347, No.255), entitled "An act equalizing and fixing the compensation and mileage of the members of the several boards appointed under the provisions of the act approved June second, one thousand eight hundred and ninety-one, to examine candidates for appointment as inspectors, foremen and fire bosses, respectively, in the anthracite coal mines, and providing for the employment and compensation and mileage of a clerk to each of said boards."

Act of July 2, 1895 (P.L.428, No.306), entitled "An act to regulate and license public lodging-houses in the different cities in this Commonwealth."

Act of April 13, 1899 (P.L.46, No.45), entitled "An act entitled an act to extend the benefits of the Soldiers' Orphan Industrial School, and the Soldiers' Orphan Schools, to the children of honorably discharged soldiers, sailors and marines of the Spanish-American war."

Section 4. This act shall take effect immediately.
