6 The General Assembly finds and declares as follows:

7 (1) At-risk youth have engaged in or are at risk of  
8 engaging in conduct that can be a precursor to dropping out  
9 of school, engaging in criminal behavior, acquiring a low-  
10 paying job and being unemployed.

11 (2) Providing more or better opportunities for at-risk  
12 youth and leading them away from negative social activities  
13 will result in better outcomes and help prevent negative  
14 results.

15 (3) This subarticle is intended to provide at-risk youth  
16 with constructive opportunities and options.

23 of high crime, which shall be used by the commission in  
24 determining eligibility for allocation of funds.  
25 (ii) Provide for the maintenance and use of the  
26 fund.  
27 (4) No less than once a year, the commission shall  
28 review the statement of policy.
