4 (2) Satisfied the requirements of section 111.

5 (3) For a school entity, has been indemnified by the
6 school entity under 42 Pa.C.S. § 8548.

7 (4) For a nonpublic school, has been insured by the
8 nonpublic school for any liability arising from the
9 performance of the independent contractor's or individual's
10 duties.
