## AN ACT

- 1 Establishing the Distressed Hospital Grant Program to award
- grants to distressed hospitals to prevent the reduction of
- services or cessation of operations; and making an
- 4 appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Distressed
- 9 Hospital Grant Program Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- "Applicant." A distressed hospital that submits an
- 15 application under section 5(a) to the department for a grant
- 16 under the program.
- 17 "Department." The Department of Health of the Commonwealth.
- 18 "Designated medically underserved area." As defined in
- 19 section 1301 of the act of December 2, 1992 (P.L.741, No.113),

- 1 known as the Children's Health Care Act.
- 2 "Distressed hospital." A hospital that meets all of the
- 3 following criteria:
- 4 (1) The hospital had a negative profit margin for at
- 5 least the previous three consecutive calendar years or fiscal
- 6 years.
- 7 (2) The hospital is located more than 25 miles of travel
- 8 distance on a roadway to another hospital located within this
- 9 Commonwealth.
- 10 "Hospital." Any of the following:
- 11 (1) A hospital licensed by the department under section
- 12 808 of the act of July 19, 1979 (P.L.130, No.48), known as
- 13 the Health Care Facilities Act, that provides inpatient
- 14 medical care and other related services for surgery, acute
- 15 medical conditions or injuries.
- 16 (2) A hospital licensed by the department under section
- 17 808 of the Health Care Facilities Act that specializes in
- services exclusively to infants, children, adolescents and
- 19 young adults from birth up to 21 years of age.
- 20 "Program." The Distressed Hospital Grant Program established
- 21 under section 3.
- 22 "Rural county." A county of this Commonwealth where the
- 23 number of people per square mile within the county is less than
- 24 291.
- 25 Section 3. Establishment of program.
- The Distressed Hospital Grant Program is established within
- 27 the department for the purposes specified under this act.
- 28 Section 4. Awards of grants.
- 29 The department shall award grants under the program in
- 30 accordance with this act from money appropriated by the General

- 1 Assembly for the distribution of grants under the program.
- 2 Section 5. Applications for grants.
- 3 (a) Applications.--A distressed hospital may apply for a
- 4 grant under the program. The department shall develop the
- 5 application in a form determined by the department and make the
- 6 application available electronically on the department's
- 7 publicly accessible Internet website. To be eligible for a grant
- 8 under the program, a distressed hospital shall include any
- 9 information required by the department in the application,
- 10 including the certification under section 6.
- 11 (b) Consideration. -- No later than 45 days after the
- 12 effective date of this subsection, the department shall receive
- 13 and consider applications on a rolling basis until funding for
- 14 grants under this act has been completely expended, or until
- 15 December 31, 2029, whichever occurs first.
- 16 Section 6. Certification requirements.
- 17 (a) Certification. -- An applicant shall, in good faith,
- 18 certify all of the following to the department:
- 19 (1) The applicant is a distressed hospital and, if
- 20 applicable, meets one of the criteria specified under section
- 21 9 for a priority to receive a grant under the program.
- 22 (2) The distressed hospital will remain in operation and
- does not intend to reduce services or cease operations within
- 24 two years of the date of receipt of a grant under the
- 25 program.
- 26 (3) The grant will be used to prevent the distressed
- 27 hospital from reducing services or ceasing operations.
- 28 (4) The grant will not be used to pay a remuneration to
- 29 the distressed hospital's executives, administrators or
- 30 administrative support staff.

- 1 (5) The distressed hospital has not been awarded more 2 than one grant under the program during a calendar year or
- 3 fiscal year.
- 4 (6) The distressed hospital has taken measures to
  5 affiliate or enter into a business arrangement with another
  6 person to prevent the distressed hospital from reducing
  7 services or ceasing operations. The distressed hospital shall
  8 provide supporting documentation to the department for the
  9 measures required under this paragraph.
- 10 (7) The information provided in the application under
  11 section 5 and this section and all supporting documentation
  12 is true and accurate in all material aspects.
- 13 (b) False statements.—An applicant or an authorized
  14 representative of the applicant that knowingly makes a false
  15 statement to obtain a grant under the program shall be subject
  16 to 18 Pa.C.S. § 4904 (relating to unsworn falsification to
  17 authorities).
- 18 Section 7. Review of applications.
- 19 (a) Approval or disapproval. -- No later than 60 days after
- 20 the department has received a completed application under
- 21 section 5(a), the department shall approve or deny the
- 22 application for a grant under the program. The department shall
- 23 provide a notice to the applicant of any of the following:
- 24 (1) The application for a grant under the program is approved.
- 26 (2) The application for a grant under the program is 27 denied and the reasons for denying the application.
- 28 (3) The application for a grant under the program is 29 approved for an amount less than requested by the applicant 30 and the reasons for approving an amount less than requested

- 1 by the applicant.
- 2 (b) Grant agreements. -- Upon approving an application for a
- 3 grant under subsection (a), the department shall enter into a
- 4 grant agreement with the distressed hospital to award the grant
- 5 under the program. The grant agreement shall explain the terms
- 6 and conditions of the grant, including the applicable laws of
- 7 this Commonwealth and reporting requirements. The department,
- 8 the distressed hospital and any other applicable party may enter
- 9 the grant agreement via electronic signature.
- 10 Section 8. Distribution of grant money.
- 11 No later than 60 days after approving an application for
- 12 grant under section 7(a), the department shall distribute grant
- 13 money to the distressed hospital in accordance with this act.
- 14 The following shall apply:
- 15 (1) The distressed hospital may receive an amount equal
- to no more than 20% of the amount of money available for the
- 17 program.
- 18 (2) The department may award grants under the program to
- the distressed hospital in increments of \$1,000, subject to
- the limitation under paragraph (1).
- 21 (3) The department may not distribute grant money under
- the program to the distressed hospital unless the department,
- the distressed hospital and any other applicable party have
- fully executed a grant agreement under section 7(b).
- 25 Section 9. Priority of grant awards.
- In awarding grants under the program, the department shall
- 27 prioritize all of the following:
- 28 (1) A distressed hospital that has provided notice to
- the department that the distressed hospital will reduce
- 30 services or cease operations under 28 Pa. Code § 51.3

- 1 (relating to notification).
- 2 (2) A distressed hospital located in a designated
- 3 medically underserved area.
- 4 (3) A distressed hospital located in a rural county.
- 5 Section 10. Reports.
- 6 (a) Publication. -- No later than December 31 of each year,
- 7 the department shall publish a report on the department's
- 8 publicly accessible Internet website that contains the following
- 9 information:
- 10 (1) A list of each grant awarded under the program.
- 11 (2) The name and address of each grant recipient.
- 12 (3) The amount of the grant and a description of the
- financial impact to the grant recipient.
- 14 (b) Submission. -- The department shall submit the report
- 15 under subsection (a) to the following:
- 16 (1) The chair and minority chair of the Appropriations
- 17 Committee of the Senate.
- 18 (2) The chair and minority chair of the Appropriations
- 19 Committee of the House of Representatives.
- 20 (3) The chair and minority chair of the Health and Human
- 21 Services Committee of the Senate.
- 22 (4) The chair and minority chair of the Health Committee
- of the House of Representatives.
- 24 (c) Final report.--Upon disbursement of all money
- 25 appropriated for grants under the program, or December 31, 2029,
- 26 whichever is earlier, the department shall publish a final
- 27 report under subsection (a).
- 28 Section 11. Appropriation.
- The sum of \$100,000,000 is appropriated on a continuing basis
- 30 from the General Fund to the department for the award of grants

- 1 under the program. Money not expended in a fiscal year
- 2 shall not lapse and shall be available for use in the next
- 3 fiscal year until the disbursement of all money appropriated for
- 4 the program, or December 31, 2029, whichever is earlier.
- 5 Section 12. Effective date.
- 6 This act shall take effect immediately.
