10	WHEREAS, As in the past, the 1997 team was selected from the
11	Senior Scholars Law classes and coached by the teacher assigned
12	to those classes, Philip Beauchemin, Esquire; and
13	WHEREAS, Also instrumental in developing the 1997 team were
14	Attorney-Coach Erik Chizmar, Esquire, and Scholars Magnet
15	Coordinator, Bruce Eisenberg; and
16	WHEREAS, Overbrook's 1997 team defeated opponents from 44

public, private and parochial schools to win the Southeast
Regional Championship; and

3 WHEREAS, Tyray Miller was unanimously named Top Advocate, 4 while Timothy Carr and Chanae Smith were cited for Best 5 Performance and Best Witness, respectively; and 6 WHEREAS, Overbrook went on to compete with seven other regional champions from all over Pennsylvania and defeated them 7 8 to win the State Championship; and 9 WHEREAS, At the National Mock Trial Championship held in 10 Nashville, Tennessee, Overbrook finished in the top half of the 11 competition; therefore be it 12 RESOLVED, That the House of Representatives offer its 13 congratulations to the Overbrook High School Mock Trial Team for winning the Southeast Regional Mock Trial Championship and the 14 15 State Mock Trial Championship and for placing in the top half of

16 competitors in the National Mock Trial Championship.
