## AN ACT

- 1 Providing for Commonwealth support for the Agriculture Education
- 2 Loan Forgiveness Program for Pennsylvania residents who
- 3 graduate from institutions of higher education and who apply
- 4 their degrees in agriculture to family farms within this
- 5 Commonwealth.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Agriculture
- 10 Education Loan Forgiveness Act.
- 11 Section 2. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Agency." The Pennsylvania Higher Education Assistance
- 16 Agency.
- 17 "Agricultural products." Crops, livestock and livestock
- 18 products, and commodities, including, but not limited to:

- 1 (1) Field crops, including corn, wheat, oats, rye,
- 2 barley, hay, potatoes and dry beans.
- 3 (2) Fruits, including apples, peaches, grapes, cherries
- 4 and berries.
- 5 (3) Vegetables, including tomatoes, snap beans, cabbage,
- 6 carrots, beets, onions and mushrooms.
- 7 (4) Horticultural specialties, including nursery stock,
- 8 ornamental shrubs, ornamental trees and flowers.
- 9 (5) Cattle, sheep, hogs, goats, horses, poultry,
- 10 furbearing animals, milk, eggs and furs.
- 11 (6) Timber, wood and other wood products derived from
- 12 trees.
- 13 (7) Aquatic plants and animals and their by-products.
- 14 (8) Products derived from any of the above and other
- products derived from the business of farming, including such
- other products as may be manufactured, derived or prepared
- from the heretofore mentioned products, raw or processed,
- which are used as food for man or animals.
- 19 "Family farm." The real property of a farm owned by members
- 20 of an immediate family or by a family farm corporation used for
- 21 the production, for commercial purposes, of agricultural
- 22 products.
- 23 "Family farm corporation." A corporation of which at least
- 24 75% of its assets are devoted to the business of agriculture and
- 25 at least 75% of each class of stock of the corporation is
- 26 continuously owned by members of the immediate family.
- 27 "Immediate family member." A spouse, child, stepchild,
- 28 parent, stepparent, grandparent, brother, stepbrother, sister,
- 29 stepsister or like relative-in-law of an owner of real property.
- 30 "Practice of veterinary medicine." The practice in the field

- 1 of veterinary medicine by any person qualified by educational
- 2 training and experience in the science and techniques of
- 3 veterinary medicine and who is currently licensed to practice
- 4 veterinary medicine by the Pennsylvania State Board of
- 5 Veterinary Medicine under the act of December 27, 1974 (P.L.995,
- 6 No.326), known as the Veterinary Medicine Practice Act.
- 7 "Qualified applicant." A resident of this Commonwealth who
- 8 meets all of the following criteria:
- 9 (1) Holds a degree in a field related to the production
- of agricultural products or in the field of veterinary
- 11 medicine, from an institution of higher education located
- 12 within this Commonwealth, approved by the agency for
- 13 participation under this act.
- 14 (2) Is in the first year of full-time employment or work
- on a family farm or in the practice of veterinary medicine, a
- 16 portion of which activity must be for the protection and
- enhancement of agricultural animal health and productivity,
- 18 on or after July 1, 1989.
- 19 (3) Has borrowed through the agency-administered
- 20 Guaranteed Student Loan Programs.
- "Secretary." The Secretary of Agriculture of the
- 22 Commonwealth.
- 23 "Veterinary medicine." That branch of medicine which deals
- 24 with the diagnosis, prognosis, treatment, administration,
- 25 prescription, operation or manipulation or application of any
- 26 apparatus or appliance for any disease, pain, deformity, defect,
- 27 injury, wound or physical condition of any animal or for the
- 28 prevention of or the testing for the presence of any disease.
- 29 Section 3. Agriculture Education Loan Forgiveness Program.
- 30 Qualified applicants who are selected for the Agriculture

- 1 Education Loan Forgiveness Program, in accordance with this act,
- 2 shall be eligible for payment by the agency of a portion of the
- 3 debt incurred by the applicant through the agency-administered
- 4 Guaranteed Student Loan Programs for the education necessary to
- 5 receive a degree in an agriculturally related field. For each
- 6 year that the applicant is employed full time on a family farm
- 7 or works full time on a family farm, a portion of which must be
- 8 located within this Commonwealth, or is engaged in the practice
- 9 of veterinary medicine within this Commonwealth, a portion of
- 10 which activity must be for the protection and enhancement of
- 11 agricultural animal health and productivity, the agency shall
- 12 forgive a proportional part of the applicant's loan. No more
- 13 than \$2,000 shall be forgiven in any year, and no more than
- 14 \$10,000 shall be forgiven for any applicant. Payments shall be
- 15 made in accordance with the procedures established by the
- 16 agency.
- 17 Section 4. Loan forgiveness awards.
- 18 Recipients of the loan forgiveness awards shall be those
- 19 applicants who are approved by the Department of Agriculture.
- 20 Each applicant shall be required to submit such documentation of
- 21 continued eligibility as the agency may require.
- 22 Section 5. Funding.
- 23 Loan forgiveness awards shall be made to the extent that
- 24 funds are appropriated by the General Assembly.
- 25 Section 6. Responsibility of agency.
- 26 It shall be the responsibility of the agency to administer
- 27 the Agriculture Education Loan Forgiveness Program established
- 28 by this act and to adopt such regulations, policies, procedures
- 29 and forms as are necessary and not inconsistent with the
- 30 provisions of this act.

- 1 Section 7. Effective date.
- 2 This act shall take effect July 1, 1991.
