- § 1366. Special plates for recipients of Silver Star.
- 10 Upon application of any person who is a recipient of the
- Silver Star, accompanied by a fee of \$10 which shall be in 11

- 14 shall issue to the person a special registration plate

- 9 <u>shall issue to the person a special registration plate</u>
- 10 designating the vehicle so licensed as belonging to a person who
- 11 <u>is a recipient of the Bronze Star. The special registration</u>
- 12 plate may be used only on a passenger car or truck with a
- 13 registered gross weight of not more than 10,000 pounds.
- 14 § 1368. Special plates for recipient of Bronze Star for Valor.

- 16 Bronze Star for Valor, accompanied by a fee of \$10 which shall

- 19 shall issue to the person a special registration plate
- 20 designating the vehicle so licensed as belonging to a person who
- 21 is a recipient of the Bronze Star for Valor. The special
- 22 registration plate may be used only on a passenger car or truck
- 23 with a registered gross weight of not more than 10,000 pounds.
- 24 Section 2. This act shall take effect in $\frac{60}{120}$ 120 days.
