## AN ACT

Amending the act of April 14, 1972 (P.L.221, No.63), entitled 2 "An act establishing the Governor's Council On Drug and 3 Alcohol Abuse; imposing duties on the council to develop and coordinate the implementation of a comprehensive health, 5 education and rehabilitation program for the prevention and 6 treatment of drug and alcohol abuse and drug and alcohol 7 dependence; providing for emergency medical treatment; providing for treatment and rehabilitation alternatives to 8 the criminal process for drug and alcohol dependence; and 9 making repeals, "providing for a program on drug, alcohol and 10 11 tobacco abuse. 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. The act of April 14, 1972 (P.L.221, No.63), known as the "Pennsylvania Drug and Alcohol Abuse Control Act," is 15 16 amended by adding a section to read: 17 Section 6.1. Drug, Alcohol and Tobacco Abuse Programs. -- The commission shall develop a comprehensive Statewide program on 18 drug education by assuming the following functions: 19 20 (a) Assist in the development of model curricula for the 21 public schools on drug education and the effects of the abusive

- 1 use of tobacco, alcohol, dangerous drugs, and other controlled
- 2 <u>substances</u>.
- 3 (b) Identify innovative teaching methods for the instruction
- 4 of drug, alcohol and tobacco abuse education in the public
- 5 school system.
- 6 (c) Develop methods of evaluating the effectiveness of
- 7 <u>instruction in drug, alcohol and tobacco abuse education.</u>
- 8 (d) Serve as the depository for the results of all research
- 9 relative to drug, alcohol and tobacco abuse education.
- 10 (e) Develop and establish a drug, alcohol and tobacco abuse
- 11 education training program for teachers and administrators to
- 12 provide training at the local school district level.
- (f) Assist teacher training institutions in development of
- 14 courses on drug, alcohol and tobacco abuse education.
- 15 (g) Administer pilot projects on drug, alcohol and tobacco
- 16 <u>abuse education</u>.
- 17 (h) Assist in the development of adult education programs
- 18 which will include parents, students, community health agencies,
- 19 law enforcement agencies, and other community groups. This
- 20 program shall emphasize the development of coordinated school-
- 21 community programs relative to drug, alcohol and tobacco abuse
- 22 education.
- 23 (i) Provide annual reports of its activities and findings
- 24 regarding effective drug, alcohol and tobacco abuse education
- 25 programs to the Legislature, local school districts, appropriate
- 26 agencies and organizations.
- 27 Section 2. This act shall take effect in 60 days.
