AN ACT

1 Designating a portion of State Route 51 in the Borough of
2 Coraopolis, Allegheny County, as the Fred A. Trello Memorial
3 Boulevard.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Fred A. Trello Memorial Boulevard.

7 (a) Declaration of policy.--The General Assembly finds and
8 declares as follows:

9 (1) Representative Fred Trello was born on November 14,
10 1929, in the Borough of Coraopolis in Allegheny County.

11 (2) Representative Trello graduated from Coraopolis High
12 School in 1949 and earned degrees from the Air Force
13 Electronics School and Robert Morris College.

14 (3) Representative Trello served in the Korean War as a
15 member of the United States Air Force.

16 (4) Representative Trello began his political career as

1 a Democratic committeeman and councilman for the Borough of
2 Coraopolis.

3 (5) In 1974, Representative Trello was elected to the
4 Pennsylvania House of Representatives where he served the
5 45th legislative district until 2002.

6 (6) Representative Trello was a long-time member of
7 Knights of Columbus, the Coraopolis Lions Club, the ISDA Club
8 and the Saint Joseph's Roman Catholic Church.

9 (7) On March 28, 2006, Representative Fred Trello passed
10 away at the age of 76.

11 (b) Designation.--The section of State Route 51 North, known
12 as Fourth Avenue, that runs from Ferree Street (Segment 0690,
13 offset 0730) to Thorn Run Road (Segment 0720, offset 0720) and
14 the section of State Route 51 South, known as Fifth Avenue, that
15 runs from Thorn Run (Segment 0721, offset 0790) to Ferree Street
16 (Segment 0691, offset 0545), in the Borough of Coraopolis,
17 Allegheny County, is hereby designated as the Fred A. Trello
18 Memorial Boulevard.

19 (c) Signs.--The Department of Transportation shall erect and
20 maintain appropriate signs displaying the name of the highway to
21 traffic in both directions on the highway.

22 Section 2. Effective date.

23 This act shall take effect immediately.
