| 6           | Section 1. Section 1338(b) of Title 75, act of November 25,   |
| 7           | 1970 (P.L.707, No.230), known as the Pennsylvania Consolidated  |
| 8           | Statutes, is amended and a subsection is added to read:   |
| 9           | § 1338. Handicapped plate and placard.  |

| 11          | (b) Handicapped parking placardOn the application of any  |
| 12          | person who meets the qualifications of subsection (a), the  |
| 13          | department shall issue one special parking placard of such size   |
| 14          | and design as the department shall specify, designating the   |
| 15          | vehicle in which it is displayed as being used for the  |
| 16          | transportation of a handicapped person. Such placard shall be   |
| 17          | prominently displayed on the right front dash of the vehicle  |

18 when it is in use for the transportation of such person. The

name and address of the owner of the placard shall not be placed 1 on the placard, BUT A NUMBER ASSIGNED BY THE DEPARTMENT SHALL BE 2 <-----3 PLACED ON THE FRONT OF EACH PLACARD. 4 (c) Penalty. -- Any person not entitled to a handicapped 5 parking placard who uses the placard to park in a handicapped parking space or who otherwise misuses a handicapped parking 6 7 placard in violation of subsection (b) commits a summary offense 8 and shall, upon conviction, be sentenced to pay a fine not 9 exceeding \$50 or to imprisonment not exceeding ten days, or 10 both. 11 Section 2. This act shall take effect in 60 days. <----SECTION 2. SECTION 1510 OF TITLE 75 IS AMENDED TO READ: 12 <----13 § 1510. ISSUANCE AND CONTENT OF DRIVER'S LICENSE. 14 (A) GENERAL RULE. -- THE DEPARTMENT SHALL, UPON PAYMENT OF THE 15 REQUIRED FEE, ISSUE TO EVERY QUALIFIED APPLICANT A DRIVER'S LICENSE INDICATING THE TYPE OR GENERAL CLASS OF VEHICLES THE 16 17 LICENSEE IS AUTHORIZED TO DRIVE, WHICH LICENSE SHALL CONTAIN A 18 DISTINGUISHING NUMBER IDENTIFYING THE LICENSEE, THE ACTUAL NAME, 19 DATE OF BIRTH, RESIDENCE ADDRESS, A COLOR PHOTOGRAPH OF THE 20 LICENSEE, SUCH OTHER INFORMATION AS MAY BE REQUIRED BY THE 21 DEPARTMENT, AND EITHER A FACSIMILE OF THE SIGNATURE OF THE 22 LICENSEE OR A SPACE UPON WHICH THE LICENSEE SHALL WRITE HIS 23 USUAL SIGNATURE WITH PEN AND INK. A MEDICAL DOCTOR MAY HAVE THE 24 CAPITAL LETTERS M.D. PLACED AFTER HIS NAME. PERSONAL MEDICAL DATA AND OTHER INFORMATION FOR USE IN AN EMERGENCY MAY BE 25 26 INCLUDED AS A PART OF THE LICENSE. INFORMATION OTHER THAN THAT 27 REQUIRED TO IDENTIFY THE LICENSEE, THE DISTINGUISHING NUMBER AND 28 THE CLASS OF LICENSE ISSUED MAY BE INCLUDED IN MICRODATA FORM. 29 NO DRIVER'S LICENSE SHALL BE VALID UNTIL IT HAS BEEN SIGNED BY 30 THE LICENSEE.

(B) IDENTIFICATION CARD. -- THE DEPARTMENT SHALL, UPON PAYMENT 1 2 OF THE REQUIRED FEE, ISSUE AN IDENTIFICATION CARD TO ANY PERSON 3 WHO HAS MADE APPLICATION THEREFOR IN SUCH MANNER AS THE 4 DEPARTMENT SHALL PRESCRIBE. THE IDENTIFICATION CARD SHALL HAVE 5 SUBSTANTIALLY THE SAME CONTENT AS A DRIVER'S LICENSE BUT SHALL CLEARLY INDICATE THAT IT IS NOT A DRIVER'S LICENSE. UPON FAILURE 6 7 OF ANY PERSON TO PASS ANY EXAMINATION REQUIRED UNDER SECTION 8 1514 (RELATING TO EXPIRATION AND RENEWAL OF DRIVERS' LICENSES), THE DEPARTMENT SHALL, WHERE APPROPRIATE, ISSUE A COMPLIMENTARY 9 10 IDENTIFICATION CARD AS AN EXPRESSION OF GRATITUDE FOR YEARS OF 11 SAFE DRIVING. THE CARD SHALL ONLY BE ISSUED UPON RECEIPT OF THE 12 PERSON'S DRIVER'S LICENSE.

(C) ANATOMICAL DONORS. -- ANY PERSON WHO IS REGISTERED AS AN 13 ANATOMICAL ORGAN DONOR AND WHO HAS IN HIS POSSESSION A CARD 14 15 ISSUED BY THE RECIPIENT ORGANIZATION MAY ATTACH THE CARD TO THE 16 REVERSE SIDE OF HIS DRIVER'S LICENSE OR IDENTIFICATION CARD IN 17 SUCH A WAY AS TO PERMIT THE REMOVAL OF THIS CARD SHOULD THE 18 PERSON NO LONGER DESIRE TO BE DESIGNATED AS AN ANATOMICAL DONOR. 19 INFORMATION CONCERNING REGISTERED DONOR STATUS MAY BE INCLUDED 20 AS A PART OF THE PERSON'S PERSONAL MEDICAL DATA.

(D) MEDICAL HISTORY RECORD. -- ANY PERSON MAY ATTACH TO THE
REVERSE SIDE OF HIS DRIVER'S LICENSE OR IDENTIFICATION CARD
INFORMATION RELATING TO HIS PERSONAL MEDICAL HISTORY.

24 SECTION 3. THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
