AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in registration of vehicles, providing for Blue
3 Star Family plate.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Title 75 of the Pennsylvania Consolidated
7 Statutes is amended by adding a section to read:

8 § 1366.2. Blue Star Family plate.

9 (a) General rule.--Upon application of a family member of a
10 person who is an active duty service member in the military,
11 INCLUDING A RESERVE COMPONENT OR NATIONAL GUARD, accompanied by <--
12 a fee of \$23 which shall be in addition to the annual
13 registration fee and by such documentation as the department
14 shall require, the department shall issue to the family member a
15 special registration plate designating the vehicle so licensed
16 as belonging to a family member of a person serving on active

1 duty in the military, INCLUDING A RESERVE COMPONENT OR NATIONAL <--
2 GUARD. The department shall design and produce the special
3 registration plate carrying the Blue Star which signifies that a
4 family member is an active duty service member, INCLUDING A <--
5 RESERVE COMPONENT OR NATIONAL GUARD. The words "Blue Star
6 Family" shall be clearly displayed along the bottom of the
7 plate. The special registration plate may be used only on a
8 passenger car or truck with a registered gross weight of not
9 more than 14,000 pounds.

10 (b) Documentation required.--An applicant for a Blue Star
11 Family plate shall certify on a form approved by the department
12 that the applicant is a family member of a person who is an
13 active duty service member in the military, INCLUDING A RESERVE <--
14 COMPONENT OR NATIONAL GUARD.

15 (c) Construction.--Nothing in this section shall be
16 construed to require:

17 (1) A person issued a Blue Star Family plate to return
18 the plate to the department if a family member no longer
19 serves on active duty in the military, INCLUDING A RESERVE <--
20 COMPONENT OR NATIONAL GUARD.

21 (2) The department to periodically verify that a person
22 issued a Blue Star Family plate has a family member serving
23 on active duty in the military, INCLUDING A RESERVE COMPONENT <--
24 OR NATIONAL GUARD, after the initial issuance of the plate.

25 (d) Definition.--As used in this section, the term "family
26 member" includes the following:

27 (1) Mother.

28 (2) Father.

29 (3) Stepmother.

30 (4) Stepfather.

- 1 (5) Mother through adoption.
- 2 (6) Father through adoption.
- 3 (7) Foster mother in loco parentis.
- 4 (8) Foster father in loco parentis.
- 5 (9) Son.
- 6 (10) Daughter.
- 7 (11) Stepson.
- 8 (12) Stepdaughter.
- 9 (13) Son by adoption.
- 10 (14) Daughter by adoption.
- 11 (15) Brother.
- 12 (16) Sister.
- 13 (17) Half-brother.
- 14 (18) Half-sister.
- 15 (19) Grandfather.
- 16 (20) Grandmother.
- 17 (21) Spouse.
- 18 Section 2. This act shall take effect in 120 days.
