1 2 3 4 5 6 7	To the act of April 1, 1863 (P.L.213, No.227), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated.
8	The General Assembly of the Commonwealth of Pennsylvania
9	hereby enacts as follows:
10	Section 1. In order to carry into effect the act of
11	Congress, approved July 2, 1862, granting public land to the
12	several states for educational purposes, and subsequent acts of
13	Congress related thereto, and the act of the General Assembly of
14	Pennsylvania accepting the provisions and conditions of said
15	acts of Congress and pledging the faith of the State to carry
16	the same into effect, the following sums, or as much thereof as
17	may be necessary, are hereby appropriated to the Trustees of The
18	Pennsylvania State University for the fiscal year July 1, 1987,
19	to June 30, 1988, for the purposes and in the amounts as shown:

(1) For educational and general expenses..... \$142,763,000

1	(2) For cost of research
2	(3) For instruction - Doctor of Medicine only. 3,970,000
3	(4) For cost of agricultural research 14,851,000
4	(5) For cost of agricultural extension
5	services
6	(6) For the cost of operating Elizabethtown
7	Hospital
8	(7) To enhance the recruitment and retention
9	of disadvantaged students
10	Section 2. Payments to The Pennsylvania State University on
11	account of the appropriations for all items as provided in
12	section 1 shall be made on the basis of costs during the fiscal
13	year.
14	Section 3. If necessary, The Pennsylvania State University
15	may transfer funds among the appropriations listed in section
16	1(1), (2), (4) and (5): Provided, That the aggregate amount
17	transferred into or out of each appropriation during the fiscal
18	year shall not exceed 5% of the amount specifically appropriated
19	for that purpose.

- 5 Section 6. (a) The Pennsylvania State University shall

- 8 proper records showing the application of such moneys. Not later
- 9 than 120 days after the close of the fiscal year to which this
- 10 act relates, The Pennsylvania State University shall file, with

- 12 General of the Commonwealth, a statement setting forth the
- 13 amounts and purposes of all expenditures made from moneys
- 14 appropriated by this act and other university accounts during

- 17 (b) Such statement of expenditures and costs shall be
- 18 reviewed by the Auditor General of the Commonwealth, and he
- 19 shall have the right, in respect to the moneys appropriated by
- 20 this act, to audit and disallow expenditures made for purposes
- 21 not permitted by this act and to cause such sums to be recovered
- 22 and paid by The Pennsylvania State University to the State
- 23 Treasurer. In respect to expenditures made by the university
- 24 from moneys other than those appropriated by this act, the
- 25 Auditor General shall have the right to review only, and he
- 26 shall file annually with the General Assembly such information
- 27 concerning such expenditures as the General Assembly or any of
- 28 its committees may require.
- 29 Section 7. A report shall be submitted to the Governor and
- 30 the Appropriations and Education Committees of the Senate and

- 1 House of Representatives and shall include data for all programs
- 2 except the Doctor of Medicine program. The report, to be
- 3 submitted prior to September 1, 1988, shall cover the 12-month
- 4 period beginning with the summer term 1987 and shall include:
- 5 (1) The following counts and distributions for each term
- 6 during the period:
- 7 (i) The definitions and numbers of faculty members employed
- 8 full time, of faculty members employed part time, of full-time
- 9 students enrolled in graduate courses, of full-time students
- 10 enrolled in undergraduate courses, of part-time students
- 11 enrolled in graduate courses and of part-time students enrolled
- 12 in undergraduate courses.
- 13 (ii) The total numbers of undergraduate student credit
- 14 hours, divided into lower division and upper division course
- 15 levels, and of graduate student credit hours, divided into three
- 16 course levels--master's, first professional and doctoral.
- 17 (iii) The number of different courses scheduled by level of
- 18 instruction and the number of sections of individual instruction
- 19 scheduled by level of instruction, each further subdivided by
- 20 two-digit Classification of Instructional Program (CIP)
- 21 categories of instructional programs of higher education as
- 22 defined by the National Center for Education Statistics, United
- 23 States Department of Education.
- 24 (iv) The number of terms scheduled and the dates thereof.
- 25 (2) For the summer term and the following academic year in
- 26 total and for each two-digit CIP program category, a
- 27 classification of faculty members or other professional
- 28 employees by title, including: professor, associate professor,
- 29 assistant professor, instructor, lecturer, research associate,
- 30 librarian and academic administrator; faculty members or other

- 1 professional employees under each title to be subdivided by type
- 2 of assignment: teaching and nonteaching, and each such set of
- 3 faculty members or other professional employees to be further
- 4 subdivided by type of employment: full-time or part-time and the
- 5 following aggregates for each such subdivided classification:
- 6 (i) The number of faculty and other professional employees
- 7 and their full-time equivalence in instructional and
- 8 noninstructional functions.
- 9 (ii) The sum of credits assigned to undergraduate classroom
- 10 courses and the sum of credits assigned to graduate classroom
- 11 courses taught, divided into lower division, upper division,
- 12 master's, first professional and doctoral course levels.
- 13 (iii) The sum of credits assigned to undergraduate
- 14 individual instruction courses and the sum of credits assigned
- 15 to graduate individual instruction courses taught, divided into
- 16 lower division, upper division, master's, first professional and
- 17 doctoral course levels.
- 18 (iv) The sum of undergraduate classroom student credit hours
- 19 and the sum of graduate classroom student credit hours
- 20 generated, divided into lower division, upper division,
- 21 master's, first professional and doctoral course levels.
- 22 (v) The sum of undergraduate individual instruction student
- 23 credit hours and the sum of graduate individual instruction
- 24 student credit hours generated, divided into lower division,
- 25 upper division, master's, first professional and doctoral course
- 26 levels.
- 27 (vi) The total salary paid for instructional functions and
- 28 for noninstructional functions and the amount of this salary
- 29 paid for each of these functions from university funds, Federal
- 30 funds and other funds.

- 1 (3) For each term of the period covered for each faculty
- 2 member employed full time identified by two-digit CIP program
- 3 category and title, the report shall contain an analysis of the
- 4 average hours per week spent in university-related activities,
- 5 stating specifically hours spent in undergraduate classroom
- 6 contact and graduate classroom contact, hours spent in
- 7 preparation, hours spent in research and hours spent in public
- 8 service.
- 9 Section 8. In addition to the requirements in section 7
- 10 relative to this appropriation, the report covering the 12-month
- 11 period beginning with the summer term 1987 shall include for all
- 12 programs of the university:
- 13 (1) Minimum number of credits required for a baccalaureate
- 14 degree and for a master's degree.
- 15 (2) Number of bachelor's degrees, master's degrees, first
- 16 professional degrees and doctoral degrees awarded in 1985, 1986,
- 17 1987 and estimated 1988.
- 18 Section 9. The Pennsylvania State University shall provide
- 19 such information as may be necessary to carry out the provisions
- 20 of this act and in such form and manner as the Department of
- 21 Education shall prescribe.
- 22 Section 10. The Pennsylvania State University shall report
- 23 its revenues and expenditures and present its financial
- 24 statements required under the provisions of this act in
- 25 accordance with generally accepted accounting principles and
- 26 procedures for educational institutions as set forth in the
- 27 "Higher Education Finance Manual, United States Department of
- 28 Health, Education and Welfare (1980)" and the "Commonwealth of
- 29 Pennsylvania Budget Instructions for the State System of Higher
- 30 Education, State Related Universities and Non State Related

- 1 Colleges and Universities."
- 2 Section 11. This act shall take effect July 1, 1987, or
- 3 immediately, whichever is later.
