AN ACT

1 Designating a bridge in CLARKS SUMMIT, Lackawanna County, as the
2 John E. Fitzgerald MEMORIAL Bridge. ←

3 The General Assembly of the Commonwealth of Pennsylvania
4 hereby enacts as follows:

5 ~~Section 1. The bridge on the Northeast Extension of the~~ ←
6 ~~Pennsylvania Turnpike located in Clarks Summit, which crosses~~
7 ~~over Routes 6 and 11 in Lackawanna County, is hereby designated~~
8 ~~and shall be known as the John E. Fitzgerald Bridge.~~

9 ~~Section 2. The Department of Transportation shall erect~~
10 ~~appropriate signs to indicate the designation under section 1.~~

11 SECTION 1. JOHN E. FITZGERALD MEMORIAL BRIDGE. ←

12 (A) FINDINGS.--JOHN E. FITZGERALD WAS A CIVIL ENGINEER WHO
13 WORKED ON THE CONSTRUCTION OF THE DESIGNATED BRIDGE AND LATER
14 BECAME THE FIRST SUPERINTENDENT OF THE NORTHEAST EXTENSION OF
15 THE PENNSYLVANIA TURNPIKE. HE SERVED IN THAT CAPACITY FOR 13

1 YEARS BEFORE RETIRING.

2 (B) DESIGNATION.--THE BRIDGE ON THE NORTHEAST EXTENSION
3 LOCATED IN CLARKS SUMMIT, WHICH CROSSES OVER ROUTES 6 AND 11 IN
4 LACKAWANNA COUNTY, IS HEREBY DESIGNATED AND SHALL BE KNOWN AS
5 THE JOHN E. FITZGERALD MEMORIAL BRIDGE.

6 (C) SIGNS.--THE PENNSYLVANIA TURNPIKE COMMISSION SHALL ERECT
7 AND MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE
8 TO TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.

9 Section 3 2. This act shall take effect in 60 days.
