AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 4 5 departments, boards, commissions, and officers thereof, 6 including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative 8 departments, boards, and commissions; defining the powers and 9 10 duties of the Governor and other executive and administrative 11 officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the 12 13 Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, 17 and commissions; and prescribing the manner in which the 18 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 19 20 commissions shall be determined, " reestablishing the 21 Industrial Board; providing for its composition, powers and 22 duties; further providing for the powers and duties of the Department of Labor and Industry; providing for a Policy, 23 24 Planning and Evaluation Advisory Committee; making an 25 editorial change; and making repeals.

- 26 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 27
- 28 Section 1. As much as applies to the Department of Labor and

- 1 Industry in section 203 of the act of April 9, 1929 (P.L.177,
- 2 No.175), known as The Administrative Code of 1929, amended
- 3 December 3, 1970 (P.L.834, No.275), is amended to read:
- 4 Section 203. Advisory Boards and Commissions. -- The following

- 19 provisions of the Constitution of the Commonwealth of
- 20 Pennsylvania and, by and with the advice and consent of a
- 21 majority of the members elected to the Senate appoint persons to
- 22 fill the following positions:

- 24 (2) Those members which he is authorized to appoint to the

- 13 (P.L.1865, No.373), is amended to read:
- 14 Section 445. The Industrial Board.--(a) The Industrial
- 15 Board shall consist of the Secretary of Labor and Industry[, and
- 16 four additional members, one of whom shall be an employer of
- 17 labor, one a wage earner and one a woman. The Secretary of Labor
- 18 and Industry shall be the chairman of the board.
- 19 Three members of the board shall be a quorum.
- The members of the Industrial Board, other than the chairman,
- 21 shall receive fifteen dollars per day while in the performance
- 22 of their official duties.] or his designee and six additional
- 23 members appointed by the Governor, one of whom shall be a
- 24 <u>licensed architect, one a licensed engineer, one a</u>
- 25 representative of the building industry with experience in
- 26 <u>building safety, one a representative of an employe organization</u>
- 27 with experience in building safety and two representatives of

- 29 (b) The Secretary of Labor and Industry or his designee

- 4 action of the board or any panel provided for in subsection (g).
- 5 (e) All members other than the Secretary of Labor and
- 6 Industry or his designee shall be appointed for terms of four
- 7 years, such terms to run concurrent with that of the Governor.
- 8 Senate confirmation shall not be required. AND UNTIL SUCCESSORS <-
- 9 ARE APPOINTED AND QUALIFIED. Any member appointed to fill a
- 10 vacancy created otherwise than by expiration of term shall be
- 11 appointed for the unexpired term of the member whom he is to
- 12 succeed.
- (f) Board members, other than the Secretary of Labor and
- 14 Industry or his designee, shall receive one hundred dollars per
- 15 diem while actually attending to the work of the board. Members
- 16 <u>shall also receive the amount of reasonable traveling, hotel and</u>
- 17 other necessary expenses incurred in the performance of their
- 18 duties in accordance with Commonwealth regulations.
- 19 (q) The board may, at the discretion of the chairman, hear
- 20 appeals or perform its other duties in panels of three members,
- 21 including the chairman, one of the professional members (the
- 22 architect, engineer or representative of the building industry)
- 23 and one member representing an employe organization or a public
- 24 member. Panels may hold hearings in the various regions of this
- 25 Commonwealth for the convenience of petitioners or other
- 26 <u>witnesses</u>. Decisions of the panels shall be final unless the
- 27 chairman or another panel member refers the matter to the full

- 24 work of the department and issue reports, and may request the
- 25 department to investigate or survey any subject within the
- 26 <u>department's jurisdiction</u>. The committee may also study any
- 27 issue area relevant to the department's jurisdiction and make
- 28 reports.
- 29 (e) The director of the Office of Policy, Planning and
- 30 Evaluation within the department shall serve as Executive

- 1 Director of the committee. The Executive Director shall be
- 2 responsible for providing the committee with such materials and
- 3 <u>information</u> as may be necessary for the conduct of the
- 4 committee's business.
- 5 (f) Committee and subcommittee members shall receive the
- 6 amount of reasonable traveling, hotel and other necessary
- 7 expenses incurred in the performance of their duties in
- 8 accordance with Commonwealth regulations.

- 12 (a) To meet at least once each month for the purpose of

- 14 Secretary of Labor and Industry shall request;
- 15 (b) To hold hearings with reference to the application by
- 16 the department of the laws [affecting labor] specified in
- 17 <u>subsection (h)</u>, upon appeal either of employes or employers or

- 1 within its jurisdiction arising out of the enforcement actions
- 2 of the department consistent with the powers granted to the
- 3 board by section 14 of the act of June 2, 1913 (P.L.396,
- 4 No.267), entitled "An act creating a Department of Labor and
- 5 Industry; defining its powers and duties; establishing an
- 6 Industrial Board; providing for the appointment of a
- 7 Commissioner of Labor, inspectors, statisticians, clerks, and
- 8 others to enforce the provisions of this act, and providing
- 9 salaries for the same; prescribing a standard of reasonable and
- 10 adequate protection to be observed in the rooms, buildings, and

- 26 <u>duties</u>, including, but not limited to, a Fire and Panic Advisory
- 27 Board, an Elevator Advisory Board and a Boiler Advisory Board;
