AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania 2 Consolidated Statutes, providing for crimes against race, 3
- color, ANCESTRY OR NATIONAL ORIGIN, creed or religion by
- 4 prohibiting certain acts.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- Section 1. Title 18, act of November 25, 1970 (P.L.707,
- No.230), known as the Pennsylvania Consolidated Statutes, is 8
- amended by adding a section to read:
- 10 § 2710. Ethnic terrorism.
- 11 (a) Fear of bodily violence. -- A person is quilty of a
- misdemeanor of the first degree if he purposely, knowingly or 12
- recklessly puts or attempts to put another in fear of bodily 13
- 14 violence by placing on public or private property a symbol, an
- object, a characterization, an appellation or grafitti that 15

- 1 exposes another to threats of violence, contempt or hatred on
- 2 the basis of race, color, ANCESTRY OR NATIONAL ORIGIN, creed or <-
- 3 religion, including, but not limited to a burning cross or Nazi
- 4 swastika. A person shall not be quilty of an attempt unless his
- 5 <u>actions cause a serious and imminent likelihood of causing fear</u>
- 6 <u>of unlawful bodily violence.</u>
- 7 (b) Damaging of property. -- A person is guilty of a
- 8 <u>misdemeanor of the second degree if he purposely defaces or</u>
- 9 damages, without authorization of the owner or tenant, any
- 10 private premises or property primarily used for religious,
- 11 educational, residential, memorial, charitable, or cemetery
- 12 purposes, or for assembly by persons of a particular race,
- 13 color, ANCESTRY OR NATIONAL ORIGIN, creed or religion by placing <---

- 14 thereon a symbol, an object, a characterization, an appellation,
- 15 or grafitti that exposes another to threat of violence, contempt
- 16 or hatred on the basis of race, color, ANCESTRY OR NATIONAL
- 17 ORIGIN, creed or religion, including but not limited to, a
- 18 burning cross or Nazi swastika.
- 19 Section 2. This act shall take effect immediately.
