## AN ACT

- Amending the act of June 24, 1931 (P.L.1206, No.331), entitled "An act concerning townships of the first class; amending, 2
- revising, consolidating, and changing the law relating
- 4 thereto, "further providing for the sale of land to a
- volunteer fire company, volunteer ambulance service or volunteer rescue squad located within the township; and

- providing for the sale of land to a redevelopment authority.
- The General Assembly of the Commonwealth of Pennsylvania 8
- hereby enacts as follows:
- 10 Section 1. Section 1501 of the act of June 24, 1931
- 11 (P.L.1206, No.331), known as The First Class Township Code,
- 12 reenacted and amended May 27, 1949 (P.L.1955, No.569), amended
- September 28, 1978 (P.L.805, No.157) and amended October 28, 13
- 1983 (P.L.191, No.50), is amended to read: 14
- 15 Section 1501. Suits; Property. -- Townships of the first class
- may--16
- 17 Sue and be sued.
- Purchase, acquire by gift, or otherwise, hold, lease, 18 II.
- let and convey, by sale or lease, such real and personal 19
- 20 property as shall be deemed to be to the best interest of the

- 1 township: Provided, That no real estate owned by the township
- 2 shall be sold for a consideration in excess of one thousand five
- 3 hundred dollars except to the highest bidder after due notice by
- 4 advertisement for bids in one newspaper of general circulation
- 5 in the township. Such advertisement shall be published once not
- 6 less than ten days prior to the date fixed for the opening of
- 7 bids, and such date for opening bids shall be announced in such
- 8 advertisement. The acceptance of bids shall be made only by
- 9 public announcement at a regular or special meeting of the board
- 10 of township commissioners. All bids shall be accepted on the
- 11 condition that payment of the purchase price in full shall be
- 12 made within sixty days of the acceptance of bids.
- 13 Except as otherwise hereinafter provided in the case of
- 14 personal property of an estimated sale value of less than two
- 15 hundred dollars, no township personal property shall be disposed
- 16 of, by sale or otherwise, except upon approval of the board of
- 17 township commissioners, by ordinance or resolution. In cases
- 18 where the board of township commissioners shall approve a sale
- 19 of such property, it shall estimate the sale value of the entire
- 20 lot to be disposed of. If the board of township commissioners
- 21 shall estimate the sale value to be two hundred dollars or more,
- 22 the entire lot shall be advertised for sale once, in at least
- 23 one newspaper of general circulation in the township, not less
- 24 than ten days prior to the date fixed for the opening of bids or
- 25 public auction, and such date of opening of bids or public
- 26 auction shall be announced in such advertisement, and sale of
- 27 the property so advertised shall be made to the best responsible
- 28 bidder. The board of township commissioners shall have
- 29 authority, by resolution, to adopt a procedure for the sale of
- 30 surplus personal property of an estimated sale value of less

- 1 than two hundred dollars and the approval of the board of
- 2 township commissioners shall not be required for any individual
- 3 sale that shall be made in conformity to such procedure.
- 4 The provisions of this clause shall not be mandatory where
- 5 township property is to be traded in or exchanged for new
- 6 township property.
- 7 The provisions of this clause shall not prohibit the sale or
- 8 exchange of township property to public utilities.
- 9 The provisions of this clause requiring advertising for bids
- 10 and sale to the highest bidder shall not apply where township
- 11 real or personal property is to be sold to a county, city,
- 12 borough, town, township, institution district, school district,
- 13 <u>a volunteer fire company, volunteer ambulance service or</u>
- 14 <u>volunteer rescue squad located within the township</u>, or municipal
- 15 authority pursuant to the Municipality Authorities Act of 1945,
- 16 or to a nonprofit corporation engaged in community industrial
- 17 development or where real property is to be sold to a person for
- 18 his exclusive use in an industrial development program or where
- 19 real property is to be sold to a redevelopment authority created
- 20 pursuant to the act of May 24, 1945 (P.L.991, No.385), known as
- 21 the "Urban Redevelopment Law," or where real property is to be
- 22 sold to a nonprofit corporation organized as a public library,
- 23 or where real property is to be sold to a nonprofit medical
- 24 service corporation as authorized by clause LXXII of section
- 25 1502, or where real property is to be sold to a nonprofit
- 26 housing corporation as authorized by clause LXXIII of section
- 27 1502. When real property is to be sold to a nonprofit
- 28 corporation organized as a public library or to a nonprofit
- 29 medical service corporation or to a nonprofit housing
- 30 corporation the board of township commissioners may elect to

- 1 accept such nominal consideration for such sale as it shall deem
- 2 appropriate. Real property sold pursuant to this clause to a
- 3 <u>volunteer fire company, volunteer ambulance service or volunteer</u>
- 4 rescue squad, nonprofit medical service corporation or to a
- 5 nonprofit housing corporation shall be subject to the condition
- 6 that when the property is not used for the purposes of the
- 7 company, service, squad or the corporation the property shall
- 8 revert to the township.
- 9 Any officer who sells and each officer who votes in favor of
- 10 selling any township property, either real or personal, without
- 11 the provisions of this section having been complied with, shall
- 12 be subject to surcharge in the amount of any loss sustained by
- 13 the township by reason of such sale.
- 14 Section 2. This act shall take effect immediately.
