AN ACT

- 1 Amending the act of August 26, 1971 (P.L.351, No.91), entitled
- 2 "An act providing for a State Lottery and administration
- 3 thereof; authorizing the creation of a State Lottery
- 4 Commission; prescribing its powers and duties; disposition of
- funds; violations and penalties therefor; exemption of prizes
- 6 from State and local taxation and making an appropriation,"
- 7 further providing for PACE and PACENET eligibility.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 503 of the act of August 26, 1971
- 11 (P.L.351, No.91), known as the State Lottery Law, amended
- 12 November 26, 2003 (P.L.212, No.37), is amended to read:
- 13 Section 503. Determination of eligibility.
- 14 (a) The department shall adopt regulations relating to the
- 15 determination of eligibility of prospective claimants and
- 16 providers, including dispensing physicians and certified
- 17 registered nurse practitioners when acting in accordance with

- 1 rules and regulations promulgated by the State Board of Nursing
- 2 as required by the act of May 22, 1951 (P.L.317, No.69), known
- 3 as The Professional Nursing Law, and the State Board of Pharmacy
- 4 minimum standards of practice, and the determination and
- 5 elimination of program abuse. To this end, the department shall
- 6 establish a compliance unit staffed sufficiently to fulfill this
- 7 responsibility. The department shall have the power to declare
- 8 ineligible any claimant or provider who abuses or misuses the
- 9 established prescription plan. The department shall have the
- 10 power to investigate cases of suspected provider or recipient
- 11 fraud.
- 12 (b) Social Security cost-of-living adjustment.--
- 13 Notwithstanding any other provision of this act to the contrary,
- 14 persons who, as of December 31, 2007, are enrolled in the PACE
- 15 or PACENET program shall remain eligible for the PACE or PACENET
- 16 program if the maximum income limit is exceeded due solely to a
- 17 <u>Social Security cost-of-living adjustment</u>. Eligibility in the
- 18 PACE or PACENET program pursuant to this subsection shall expire
- 19 on December 31, 2010.
- 20 Section 2. This act shall take effect immediately.
