AN ACT

- Amending the act of September 23, 1959 (P.L.970, No.400),
- entitled "An act providing for the creation, maintenance and operation of an employes' retirement system in cities of the

- class A," further providing for credit for military service.
- The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 12 of the act of September 23, 1959
- (P.L.970, No.400), referred to as the Second Class A City 10
- 11 Employe Pension Law, amended July 15, 1968 (P.L.342, No.167), is
- amended to read: 12
- 13 Section 12. Credit for Military Service; Payment into Fund;
- 14 Reimbursement. -- Any city employe who, on or after September 16,
- 15 1940, has been employed by the city for a period of six months
- 16 and who, on or subsequent to such date, shall have enlisted or
- been inducted into the military service of the United States in 17
- 18 time of war, armed conflict or national emergency so proclaimed

- 1 by the President or the Congress of the United States, shall
- 2 have credited to his employment record, for retirement benefits,
- 3 all of the time spent by him in such military service during the
- 4 continuance of such war, armed conflict, or national emergency,
- 5 and such payments as were heretofore or shall hereafter be
- 6 required to be made during such period by such city employe into
- 7 the city employes' retirement fund shall be paid into such fund
- 8 by the city. Any employes who have made payments into the city
- 9 employes' retirement fund, for which payments the city is liable
- 10 under the provisions of this act, shall be reimbursed by the
- 11 city to the full extent of such payments or be given credit
- 12 towards future payments under this act.
- Any member of the pension fund who is a contributor and who
- 14 served in the armed forces of the United States subsequent to
- 15 September 1, 1940, and who was not a member of the pension fund
- 16 prior to such military service, and who commenced employment in
- 17 city service [within three years from] after the date of release
- 18 from active duty, [may, as the city or school district shall
- 19 determine,] shall be entitled to have full credit for each year
- 20 or fraction thereof, not to exceed five years of such service
- 21 upon his payment to the pension fund an amount equal to that
- 22 which he would have paid had he been a member during the period
- 23 for which he desires credit, computed with reference to the
- 24 compensation he received upon entry into city service and his
- 25 current percentage of salary deductions, and an additional
- 26 amount as the equivalent of the contributions of the city and
- 27 school district on account of such military service, which
- 28 amount may be paid in a lump sum or by installments as may be
- 29 approved by the board.
- 30 Section 2. This act shall take effect immediately.
