AN ACT

Amending the act of November 24, 1998 (P.L.882, No.111), 2 entitled "An act providing for victims' rights; imposing penalties; establishing remedies; establishing the Office of 3 Victim Advocate, the Bureau of Victims' Services, the Victims' Services Advisory Committee, the State Offender Supervision Fund and other funds; and making repeals," 5 6 7 further providing for the definitions of "crime" and 8 "personal injury crime." 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1.
