1 2 3 4 5	Amending the act of June 9, 1997 (P.L.169, No.14), entitled "An act providing for Statewide nurse aide training programs relating to nursing facilities," providing for training for long-term care, for criteria for nurse aides and for limitation on department.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. The act of June 9, 1997 (P.L.169, No.14), known
9	as the Nurse Aide Resident Abuse Prevention Training Act, is
10	amended by adding sections to read:
11	Section 3.1. Training for long-term care.
12	(a) Duties of department The department shall:
13	(1) Develop and implement a long-term care curriculum
14	for nurse aides.
15	(2) Establish qualifications for individuals to conduct
16	training of the long-term care curriculum. The qualifications
17	shall include, at a minimum, that an instructor must be a
18	registered nurse or a licensed practical nurse under the

1	supervision of a registered nurse as defined in 49 Pa. Code §
2	21.1 (relating to definitions).
3	(3) Establish a training program to implement a train-
4	the-trainer model so that trainers are able to deliver the
5	long-term care curriculum to nurse aides in this
6	Commonwealth. If the training of a nurse aide is performed by
7	a registered nurse or a licensed practical nurse under the
8	general supervision of a registered nurse:
9	(i) the registered nurse must be available to the
10	licensed practical nurse; and
11	(ii) the registered nurse must have a minimum of two
12	years of nursing experience, with at least 12 months of
13	employment in a long-term care nursing facility.
14	(4) Review an application for approval to enroll in a
15	training program. If the department fails to approve an
16	initial application within 45 calendar days of receipt, the
17	application shall be deemed approved. If the department fails
18	to approve a revised application within 15 days of receipt,
19	the application shall be deemed approved.
20	(b) Eligibility for admittance to examination
21	Notwithstanding any other provision of law to the contrary, an
22	individual who is a student nurse or graduate nurse shall be
23	admitted to sit for the nurse aide examination if the individual
24	demonstrates that the individual has completed courses through a
25	nursing program that is equivalent to the requirements of the
26	nurse aide training program.
27	Section 3.2. Criteria for nurse aides.
28	(a) General rule In order to become a nurse aide in this
29	Commonwealth, an individual must:
30	(1) Successfully complete a State-approved nurse aide

2	curriculum for nurse aides and achieve a minimum score,
3	established by the department, on the nurse aide competency
4	examination, which shall consist of:
5	(i) a written portion that may be taken, at the
6	option of the individual, in person or remotely over the
7	<pre>Internet; and</pre>
8	(ii) a skills-demonstrated portion approved by the
9	department and administered at a site and instructor
10	approved by the department.
11	(2) Be a graduate of an accredited registered nurse or
12	licensed practical nursing program and achieve a minimum
13	score, established by the department, on the nurse aide
14	<pre>competency examination.</pre>
15	(3) Be a student of an accredited registered nurse or
16	licensed practical nursing program who obtains a passing
17	grade in a fundamentals of nursing course or equivalent and
18	achieves a minimum score, established by the department, on
19	the nurse aide competency examination.
20	(b) Facility proctoring of the competency evaluation
21	(1) The competency evaluation may, at the nurse aide's
22	option, be conducted at the facility in which the nurse aide
23	is or will be employed unless the facility is described in 42
24	CFR 483.151(b)(2) (relating to state review and approval of
25	nurse aide training and competency evaluation programs).
26	(2) The department may permit the competency evaluation
27	to be proctored by facility personnel if the department finds
28	that the procedure adopted by the facility ensures that the
29	<pre>competency evaluation program:</pre>
30	(i) is secure from tampering;

1 <u>curriculum and training program or the long-term care</u>

1	(ii) is standardized and scored by a testing,
2	educational or other organization approved by the
3	department; and
4	(iii) requires no scoring by facility personnel.
5	Section 3.3. Limitation on department.
6	The department may not impose on a provider of a State-
7	approved nurse aide program a waiting period between approval of
8	the training program and the offering of any portion of the
9	training online.
10	Section 2. This act shall take effect in six months.
