5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 75 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:

11	Upon application of any person who is currently serving as an
12	active member of the armed forces of the United States or a
13	reserve component of the armed forces or an active member of the
14	Pennsylvania National Guard, within the meaning of 51 Pa.C.S.
15	(relating to military affairs), accompanied by a fee of \$20
16	which shall be in addition to the registration fee and by such

1	documentation as the department shall require, the department	
2	shall issue to the person a special registration plate	
3	designating the vehicle as belonging to a person who is an	
4	active member of the armed forces of the United States. The	
5	special registration plate may be used only on a passenger car	
6	or truck with a registered gross weight of not more than 14,000_

- 2 <u>BE USED ON A PASSENGER CAR OR TRUCK WITH A REGISTERED GROSS</u>
- 3 WEIGHT OF NOT MORE THAN 14,000 POUNDS.
- 4 Section 2. This act shall take effect in 120 days.
