AN ACT

- 1 Providing for a State Lottery and administration thereof;
- 2 authorizing the creation of a State Lottery Commission;
- 3 prescribing its powers and duties; disposition of funds;
- 4 violations and penalties therefor; exemption of prizes from
- 5 State and local taxation and making an appropriation.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short Title. -- This act shall be known and may be
- 9 cited as the "State Lottery Law."
- 10 Section 2. Statement of Purpose. -- This act is enacted to
- 11 establish a lottery to be operated by the State, the net
- 12 proceeds of which are to be used exclusively for the purpose of
- 13 providing property tax relief for the elderly. It is further
- 14 intended to provide a means through which to curb illegal
- 15 gambling operations in Pennsylvania.
- 16 Section 3. Definitions.--As used in this act:
- 17 (1) "Commission" shall mean the State Lottery Commission
- 18 established by this act.
- 19 (2) "Division" shall mean the Division of the State Lottery

- 1 created by this act.
- 2 (3) "Lottery" or "State lottery" shall mean the lottery
- 3 established and operated pursuant to this act.
- 4 (4) "Director" shall mean the Director of the Division of
- 5 the State Lottery.
- 6 (5) "Secretary" shall mean the Secretary of Revenue.
- 7 Section 4. State Lottery Commission; Chairman.--There is
- 8 hereby created within the Department of Revenue a Division of
- 9 the State Lottery which shall include a State Lottery
- 10 Commission.
- 11 The commission shall consist of a chairman and four members,
- 12 all of whom shall be citizens and residents of the State. No
- 13 more than three of the five members shall belong to the same
- 14 political party. The chairman shall be appointed by the
- 15 Governor, by and with the advice and consent of two-thirds of
- 16 all the members of the Senate, and shall hold office at the
- 17 pleasure of the Governor. The members of the commission shall be
- 18 appointed by the Governor, by and with the advice and consent of
- 19 two-thirds of all the members of the Senate. The members of the
- 20 commission shall hold office for four years , and until their
- 21 successors are. NO MEMBER, UPON THE EXPIRATION OF HIS TERM,
- 22 SHALL CONTINUE TO HOLD OFFICE UNTIL HIS SUCCESSOR IS appointed

- 23 and qualified. Of the members first taking office, two shall be
- 24 appointed for a term of one year and two for a term of two
- 25 years. The members of the commission shall receive actual and
- 26 necessary expenses incurred by them in the performance of their
- 27 duties, together with a per diem allowance to be paid by the
- 28 Governor's Office for each day spent in the performance of their
- 29 duties. Vacancies in the commission occurring otherwise than by
- 30 expiration of term shall be filled for the unexpired term in the

- 1 same manner as original appointments. Any member of the
- 2 commission, other than the chairman, may, after notice and
- 3 opportunity to be heard, be removed by the Governor for neglect
- 4 of duty, misfeasance, malfeasance or nonfeasance in office.
- 5 Three of the members of the commission shall constitute a
- 6 quorum to do business.
- 7 The director shall act as secretary and executive officer of
- 8 the commission.
- 9 Section 5. Powers and Duties of Commission. -- The commission
- 10 shall advise and make recommendations to the Secretary of
- 11 Revenue regarding the functions and operations of the State
- 12 lottery.
- 13 Section 6. Powers and Duties of the Secretary of Revenue. --
- 14 (a) In addition to the powers and duties provided by law and
- 15 "The Administrative Code of 1929," the Secretary of Revenue
- 16 shall have the power and it shall be his duty to operate and
- 17 administer the lottery, and to promulgate rules and regulations
- 18 governing the establishment and operation thereof, including but
- 19 not limited to:
- 20 (1) The type of lottery to be conducted.
- 21 (2) The price, or prices, of tickets or shares in the
- 22 lottery.
- 23 (3) The numbers and sizes of the prizes on the winning
- 24 tickets or shares.
- 25 (4) The manner of selecting the winning tickets or shares.
- 26 (5) The manner of payment of prizes to the holders of
- 27 winning tickets or shares.
- 28 (6) The frequency of the drawings or selections of winning
- 29 tickets or shares, without limitation.
- 30 (7) Without limit as to number, the type or types of

- 1 locations at which tickets or shares may be sold.
- 2 (8) The method to be used in selling tickets or shares.
- 3 (9) The licensing of agents to sell tickets or shares
- 4 provided that no person under the age of twenty-one shall be
- 5 licensed as an agent.
- 6 (10) The manner and amount of compensation, if any, to be
- 7 paid licensed sales agents necessary to provide for the adequate
- 8 availability of tickets or shares to prospective buyers and for
- 9 the convenience of the public.
- 10 (11) The apportionment of the total revenues accruing from
- 11 the sale of lottery tickets or shares and from all other sources
- 12 among (i) the payment of prizes to the holders of winning
- 13 tickets or shares; (ii) the payment of costs incurred in the
- 14 operation and administration of the lottery, including the
- 15 expenses of the division and the costs resulting from any
- 16 contract or contracts entered into for promotional, advertising
- 17 or operational services or for the purchase or lease of lottery
- 18 equipment and materials; (iii) for the repayment of the moneys
- 19 appropriated to the State Lottery Fund pursuant to section 16 of
- 20 this act; and (iv) for property tax relief for the elderly as
- 21 provided in section 12 of this act: Provided, however, That no
- 22 less than thirty per cent of the total revenues accruing from
- 23 the sale of lottery tickets or shares shall be dedicated to
- 24 subclause (iv) above.
- 25 (12) Such other matters necessary or desirable for the
- 26 efficient and economical operation and administration of the
- 27 lottery and for the convenience of the purchasers of tickets or
- 28 shares and the holders of winning tickets or shares.
- 29 (b) To report monthly to the Governor and the Legislature
- 30 the total lottery revenues, prize disbursements and other

- 1 expenses for the preceding month, and to make an annual report,
- 2 which shall include a full and complete statement of lottery
- 3 revenues, prize disbursements and other expenses, to the
- 4 Governor and the Legislature, and including such recommendations
- 5 for changes in this act as the secretary deems necessary or
- 6 desirable.
- 7 Section 7. Lottery Sales Agents; Qualifications;
- 8 Prohibitions.--(a) No license as an agent to sell lottery
- 9 tickets or shares shall be issued to any person to engage in
- 10 business exclusively as a lottery sales agent. Before issuing
- 11 such license the secretary shall consider such factors as:
- 12 (1) The financial responsibility and security of the person
- 13 and his business or activity;
- 14 (2) The accessibility of his place of business or activity
- to the public; (3) The sufficiency of existing licenses to
- serve the public convenience; and
- 17 (4) The volume of expected sales.
- 18 For the purposes of this section, the term "person" shall be
- 19 construed to mean and include an individual, association,
- 20 corporation, club, trust, estate, society, company, joint-stock
- 21 company, receiver, trustee, assignee, referee, or any other
- 22 person acting in a fiduciary or representative capacity, whether
- 23 appointed by a court or otherwise, and any combination of
- 24 individuals. "Person" shall also be construed to mean and
- 25 include all departments, commissions, agencies and
- 26 instrumentalities of the State, including counties and
- 27 municipalities and agencies and instrumentalities thereof.
- 28 (b) If the secretary shall find that the experience,
- 29 character and general fitness of the applicant are such that the
- 30 participation of such person as a lottery sales agent will be

- 1 consistent with the public interest, convenience and necessity,
- 2 it may thereupon grant a license.
- 3 Without limiting the generality of the foregoing, the
- 4 secretary may refuse to issue a license pursuant to this
- 5 section, or may suspend or revoke a license so issued if it
- 6 shall find that the applicant or licensee:
- 7 (1) Has been convicted of a crime involving moral turpitude.
- 8 (2) Has engaged in bookmaking or other form of illegal
- 9 gambling.
- 10 (3) Has been found guilty of any fraud or misrepresentation
- 11 in any connection.
- 12 (4) Has violated any rule, regulation or order of the
- 13 secretary.
- 14 (c) The secretary may refuse to grant a license or may
- 15 suspend or revoke a license issued pursuant to this section to a
- 16 corporation, if it shall determine that:
- 17 (1) Any officer, director, member or stockholder of such
- 18 corporation applying for a license or of any corporation which
- 19 owns stock in or shares in the profits, or participates in the
- 20 management of the affairs of such applicant: (i) has been
- 21 convicted of a crime involving moral turpitude, (ii) has engaged
- 22 in bookmaking or other forms of illegal gambling, (iii) has been
- 23 found guilty of any fraud or misrepresentation in any
- 24 connection, or (iv) has violated any rule, regulation or order
- 25 of the secretary.
- 26 (2) The experience, character, or general fitness of any
- 27 officer, director, or stockholder of any of the aforesaid
- 28 corporations is such that the participation of such person as a
- 29 lottery sales agent would be inconsistent with the public
- 30 interest, convenience or necessity, but if the secretary

- 1 determines that the interest of any stockholder referred to in
- 2 this clause or in clause (1) of this subsection is sufficient,
- 3 in the opinion of the secretary, to affect adversely the conduct
- 4 of a lottery sales agency by such corporation in accordance with
- 5 the provisions of this act, the secretary may disregard such
- 6 interest in determining whether or not to grant a license to
- 7 such corporation.
- 8 (3) The applicant is not the owner or the lessee of the
- 9 business at which it will conduct a lottery sales agency
- 10 pursuant to the license applied for, or that any person, firm,
- 11 association, or corporation other than the applicant shares, or
- 12 will share, in the profits of the applicant, other than by
- 13 dividends as a stockholder, or participates, or will
- 14 participate, in the management of the affairs of the applicant.
- 15 (d) Pending final determination of any question under this
- 16 section, the secretary may issue a temporary license upon such
- 17 terms and conditions as it may deem necessary, desirable or
- 18 proper to effectuate the provisions of this act.
- 19 Section 8. Assignability of Prizes Drawn. -- No right of any
- 20 person to a prize drawn shall be assignable, except that payment
- 21 of any prize drawn may be paid to the estate of a deceased prize
- 22 winner, and, except that any person pursuant to an appropriate
- 23 judicial order may be paid the prize to which the winner is
- 24 entitled. The secretary shall be discharged of all further
- 25 liability upon payment of a prize pursuant to this section.
- 26 Section 9. Sales of Tickets in Excess of Regulated Price;
- 27 Sales by Non-licensed Persons; Penalties. -- (a) No person shall
- 28 sell a ticket or share at a price greater than that fixed by
- 29 rule or regulation of the commission.
- 30 (b) No person other than a licensed lottery sales agent

- 1 shall sell lottery tickets or shares, except that nothing in
- 2 this section shall be construed to prevent any person from
- 3 giving lottery tickets or shares to another as a gift.
- 4 Any person convicted of violating this section shall be
- 5 guilty of a misdemeanor and upon conviction thereof, shall be
- 6 sentenced to pay a fine not exceeding five hundred dollars
- 7 (\$500).
- 8 Section 10. Sales to Certain Persons Prohibited; Penalty. --
- 9 No ticket or share shall be sold to any person under the age of
- 10 twenty-one years. The identification card issued by the Liquor
- 11 Control Board shall constitute proof of age. For the purpose of
- 12 making a gift, a person twenty-one years of age or older may
- 13 purchase a ticket or share for the benefit of a person less than
- 14 that age.
- 15 Any agent or employe of any agent who knowingly sells a
- 16 lottery ticket or share to any person under the age of twenty-
- 17 one years shall be guilty of a misdemeanor, and upon conviction
- 18 thereof, shall be sentenced to pay a fine not exceeding five
- 19 hundred dollars (\$500).
- 20 No ticket or share shall be sold to and no prize shall be
- 21 awarded to any officer or employe of the Department of Revenue
- 22 or any spouse, child, brother, sister or parent residing as a
- 23 member of the same household in the principal place of abode of
- 24 any of the foregoing persons.
- 25 Section 11. Other Laws Inapplicable. -- No other law providing
- 26 any penalty or disability for the sale of lottery tickets or
- 27 shares or any acts done in connection with a lottery shall apply
- 28 to the sale of tickets or shares or acts performed pursuant to
- 29 this act.
- 30 Section 12. Disposition of Funds from Sale of Tickets or

- 1 Shares.--(a) All moneys received from the operation of the State
- 2 lottery shall be deposited in a State Lottery Fund which is
- 3 hereby created. Such moneys shall be used to the extent
- 4 necessary for the payment of lottery prizes but the amount so
- 5 used shall not be less than forty per cent of the amount of
- 6 which tickets or shares have been sold. All payments of lottery
- 7 prizes and for expenses of operation of the lottery shall be
- 8 made as provided by law. All moneys remaining after payment of
- 9 prizes and operating expenses shall be allocated for the
- 10 exclusive purpose of providing property tax relief for the
- 11 elderly pursuant to the provisions of the act of March 11, 1971
- 12 (Act No. 3), known as the "Senior Citizens Property Tax
- 13 Assistance Act." In the event sufficient funds are not available
- 14 from the lottery receipts to meet the requirements of the act of
- 15 March 11, 1971 (Act No. 3), known as the "Senior Citizens
- 16 Property Tax Assistance Act," additional funds to fulfill this
- 17 obligation shall be appropriated from the General Fund for this
- 18 purpose.
- 19 (b) The moneys in said State Lottery Fund shall be
- 20 appropriated only:
- 21 (1) For the payment of prizes to the holders of winning
- 22 lottery tickets or shares;
- 23 (2) For the expenses of the division in its operation of the
- 24 lottery;
- 25 (3) For property tax relief for the elderly as provided
- 26 under section 12 of this act; and
- 27 (4) For the repayment to the General Fund of the amount
- 28 appropriated to the fund pursuant to section 16 of this act.
- 29 Section 13. Exemption of Lottery Prizes from State and Local
- 30 Taxation. -- No State or local taxes of any kind whatsoever shall

- 1 be imposed upon the proceeds from a prize awarded by the State
- 2 lottery.
- 3 Section 14. Unclaimed Prize Money. -- Unclaimed prize money on
- 4 a winning lottery ticket or share shall be retained by the
- 5 secretary for payment to the person entitled thereto for one
- 6 year after the drawing in which the prize was won. If no claim
- 7 is made within such period, the prize money shall be paid into
- 8 the State Lottery Fund and used for purposes as otherwise herein
- 9 provided.
- 10 Section 15. Bank Deposits and Control of Lottery
- 11 Transactions. -- The secretary may, in his discretion, require any
- 12 or all lottery sales agents to deposit to the credit of the
- 13 State Lottery Fund in banks, designated by the State Treasurer,
- 14 all moneys received by such agents from the sale of lottery
- 15 tickets or shares, less the amount, if any, retained as
- 16 compensation for the sale of the tickets or shares, and to file
- 17 with the secretary or his designated agents reports of their
- 18 receipts and transactions in the sale of lottery tickets in such
- 19 form and containing such information as he may require. The
- 20 secretary may make such arrangements for any person, including a
- 21 bank, to perform such functions, activities or services in
- 22 connection with the operation of the lottery as he may deem
- 23 advisable pursuant to this act and the rules and regulations of
- 24 the department, and such functions, activities or services shall
- 25 constitute lawful functions, activities and services of such
- 26 person.
- 27 Section 16. Appropriation. -- There is hereby appropriated the
- 28 sum of one million dollars (\$1,000,000), or so much thereof as
- 29 is necessary for the establishment of the State lottery and the
- 30 Division of the State Lottery in the Department of Revenue. The

- Department of Revenue shall reimburse the General Fund from 1
- receipts from sale of lottery tickets or shares the actual
- 3 amount of money expended from said appropriation within one year
- of the date of the first lottery drawing. 4
- 5 Section 17. Effective Date. -- This act shall take effect
- 6 immediately except that no sale of tickets or shares shall be
- made or drawings for prizes held before July 1, 1971.
