## A JOINT RESOLUTION

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania providing for a change in the date of the first annual session meeting.
PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE COMMONWEALTH OF PENNSYLVANIA, REDUCING THE NUMBER OF REPRESENTATIVE DISTRICTS OF THE GENERAL ASSEMBLY.

The General Assembly of the Commonwealth of Pennsylvania hereby resolves as follows:

Section 1. The following amendment to the Constitution of the Commonwealth of Pennsylvania is proposed in accordance with the provisions of the eleventh article thereof:

That section four, article two of the Constitution of the
Commonwealth of Pennsylvania be amended to read:
Section 4. Sessions.-The Genexal Assembly shall be a continuing body during the term for which its Representatives are elected. It shall meet at twelve o'clock noon on the first Tuesday following the first day of January of each year. Special

sessions shall be called by the Governor on petition of a
majority of the members elected to each House or may be called
by the Governor whenever in his opinion the public interest
requires.
    THAT SECTION SIXTEEN, ARTICLE TWO OF THE CONSTITUTION OF THE
COMMONWEALTH OF PENNSYLVANIA BE AMENDED TO READ:
    SECTION 16. LEGISLATIVE DISTRICTS.--THE COMMONWEALTH SHALL
BE DIVIDED INTO FIFTY SENATORIAL AND [TWO HUNDRED THREE] ONE
HUNDRED TWENTY-ONE REPRESENTATIVE DISTRICTS, WHICH SHALL BE
COMPOSED OF COMPACT AND CONTIGUOUS TERRITORY AS NEARLY EQUAL IN
POPULATION AS PRACTICABLE. EACH SENATORIAL DISTRICT SHALL ELECT
ONE SENATOR, AND EACH REPRESENTATIVE DISTRICT ONE
REPRESENTATIVE. UNLESS ABSOLUTELY NECESSARY NO COUNTY, CITY,
INCORPORATED TOWN, BOROUGH, TOWNSHIP OR WARD SHALL BE DIVIDED IN
FORMING EITHER A SENATORIAL OR REPRESENTATIVE DISTRICT.
