AN ACT

1 Amending the act of May 26, 1949 (P.L.1844, No.547), entitled
2 "An act establishing the Pennsylvania State Firemen's
3 Training School in or adjacent to the borough of Lewistown;
4 providing for its operation and maintenance by the Department
5 of Public Instruction; authorizing the acquisition of a site
6 either by gift or purchase by the Commonwealth or by The
7 General State Authority, or the use of land now owned by the
8 Commonwealth; providing for the erection or construction and
9 the furnishing and equipping of the buildings and structures
10 by The General State Authority, and the leasing thereof by
11 the Commonwealth; and conferring powers and imposing duties
12 upon the Department of Public Instruction and the Public
13 Service Institute Board," providing for certain weekend
14 classes and making an appropriation.

15 The General Assembly of the Commonwealth of Pennsylvania
16 hereby enacts as follows:

17 Section 1. The act of May 26, 1949 (P.L.1844, No.547),
18 entitled "An act establishing the Pennsylvania State Firemen's
19 Training School in or adjacent to the borough of Lewistown;
20 providing for its operation and maintenance by the Department of
21 Public Instruction; authorizing the acquisition of a site either
22 by gift or purchase by the Commonwealth or by The General State
23 Authority, or the use of land now owned by the Commonwealth;
24 providing for the erection or construction and the furnishing

1 and equipping of the buildings and structures by The General
2 State Authority, and the leasing thereof by the Commonwealth;
3 and conferring powers and imposing duties upon the Department of
4 Public Instruction and the Public Service Institute Board," is
5 amended by adding a section to read:

6 Section 3.1. Weekend Classes; Appropriation.--(a) The
7 Department of Education and the Bureau of Vocational Education
8 shall commence instruction in the Pennsylvania State Firemen's
9 Training School on weekends during the period March 1 to
10 November 15 for the purpose of instructing local volunteer fire
11 companies.

12 (b) The sum of \$12,000 is hereby appropriated to the Bureau
13 of Vocational Education in the Department of Education for the
14 purpose of operating the Pennsylvania State Firemen's Training
15 School on weekends.

16 Section 2. This act shall take effect immediately.
