AN ACT

- Amending the act of March 31, 1937 (P.L.160, No.43), entitled 2 "An act creating a commission to be known as the Pennsylvania 3 Public Utility Commission; defining in part the powers and duties of such commission; abolishing The Public Service 5 Commission of the Commonwealth of Pennsylvania, terminating the terms of the members thereof, and transferring to the 6 7 Pennsylvania Public Utility Commission the records, employes, 8 property, and equipment of The Public Service Commission of the Commonwealth of Pennsylvania; authorizing the 9 10 Pennsylvania Public Utility Commission to appear in and 11 complete all pending proceedings, legal or otherwise, 12 instituted before, by or against The Public Service 13 Commission of the Commonwealth of Pennsylvania; providing 14 that all certificates of public convenience, contracts, 15 orders, and rules and regulations of the latter commission 16 shall remain effective until repealed, changed or modified by 17 the Pennsylvania Public Utility Commission, and transferring 18 and appropriating to the Pennsylvania Public Utility 19 Commission any unexpended balance of any existing 20 appropriation to The Public Service Commission of the 21 Commonwealth of Pennsylvania, " providing for the election of 22 commissioners by districts. The General Assembly of the Commonwealth of Pennsylvania

- hereby enacts as follows:
- 25 Section 1. Subsections (a) and (b) of section 1, act of
- March 31, 1937 (P.L.160, No.43), entitled "An act creating a 26
- 27 commission to be known as the Pennsylvania Public Utility

- 2 commission; abolishing The Public Service Commission of the

- 14 modified by the Pennsylvania Public Utility Commission, and
- 15 transferring and appropriating to the Pennsylvania Public
- 16 Utility Commission any unexpended balance of any existing
- 17 appropriation to The Public Service Commission of the
- 18 Commonwealth of Pennsylvania, " subsection (a) amended March 31,
- 19 1943 (P.L.32, No.17), are amended to read:
- 20 Section 1. (a) A commission to be known as the Pennsylvania
- 21 Public Utility Commission is hereby created. The commission
- 22 shall consist of five members who shall be [appointed by the
- 23 Governor, by and with the advice and consent of two-thirds of
- 24 all the members of the Senate] <u>elected as hereinafter provided.</u>
- 25 The <u>present</u> commissioners [first appointed under this act,]
- 26 shall continue in office for [terms of two, four, six, eight,
- 27 and ten years, respectively, from the effective day of this act]
- 28 the balance of the terms for which they have been appointed, but
- 29 their successors shall each be [appointed] <u>elected</u> for a term of
- 30 [ten] five years. [No commissioner, upon the expiration of his

- 1 term as aforesaid, shall continue to hold office until his
- 2 successor shall be duly appointed or shall be qualified. Each
- 3 commissioner, at the time of his appointment and qualification,
- 4 shall be a resident of the Commonwealth of Pennsylvania, and
- 5 shall have been a qualified elector therein for a period of at
- 6 least one year next preceding his appointment, and shall also be
- 7 not less than thirty years of age.]
- 8 At the first municipal election after a vacancy occurs in the
- 9 present membership a commissioner shall be elected from the 1st
- 10 <u>district for a term of five years. Upon the occurrence of</u>
- 11 <u>additional vacancies commissioners shall be elected from the</u>
- 12 2nd, 3rd, 4th and 5th districts in that order. Upon the
- 13 <u>expiration of the term of an elected commissioner the electors</u>
- 14 in that district shall elect a commissioner for a term of five
- 15 years. Each commissioner shall be a resident of the district and
- 16 <u>shall have been a qualified elector therein for a period of at</u>
- 17 <u>least one year next preceding his nomination. Each commissioner</u>
- 18 shall be at least twenty-five years old.
- 19 The 1st district shall consist of Senate districts 21, 25,
- 20 <u>30, 33, 34, 35, 41, 47, 49 and 50. The 2nd district shall</u>
- 21 consist of Senate districts 32, 37, 38, 39, 40, 42, 43, 44, 45
- 22 and 46. The 3rd district shall consist of Senate districts 1, 2,
- 23 3, 4, 5, 6, 7, 8, 26 and 36. The 4th district shall consist of
- 24 Senate districts 9, 10, 11, 12, 13, 16, 17, 18, 19 and 24. The
- 25 5th district shall consist of Senate districts 14, 15, 20, 22,
- 26 23, 27, 28, 29, 31 and 48.
- 27 (b) [A member designated by the Governor shall be the
- 28 chairman of the commission during such member's term of office.]
- 29 A chairman of the commission shall be elected annually by the
- 30 commissioners at their first January meeting. When present, the

- 1 chairman shall preside at all meetings, but in his absence a
- 2 member, designated by the chairman, shall preside and shall
- 3 exercise, for the time being, all the powers of the chairman.
- 4 * * *
- 5 Section 2. Section 2 of the act is amended to read:
- 6 Section 2. When a vacancy shall occur in the office of any
- 7 commissioner, [a commissioner shall, in the manner aforesaid, be
- 8 appointed for the residue of the term. If the Senate shall not
- 9 be in session when any vacancy occurs, any appointment made by
- 10 the Governor to fill the vacancy shall be subject to the
- 11 approval of the Senate, when convened. No vacancy in the
- 12 commission shall impair the right of a quorum of the
- 13 commissioners to exercise all the rights and perform all the
- 14 duties of the commission.] the Governor shall issue a writ of
- 15 election to fill such vacancy with a person from the same
- 16 district for the remainder of the term.
- 17 Section 3. This act shall take effect immediately.
