AN ACT

- 1 Amending Title 15 (Corporations and Unincorporated Associations)
- of the Pennsylvania Consolidated Statutes, permitting
- 3 fraternal benefit societies to pay certain dividends.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 7546 and 7553 of Title 15, act of
- 7 November 25, 1970 (P.L.707, No.230), known as the Pennsylvania
- 8 Consolidated Statutes, amended November 15, 1972 (P.L.1063,
- 9 No.271), are amended to read:
- 10 § 7546. Income from corporate activities.
- 11 A nonprofit corporation whose lawful activities involve among
- 12 other things the charging of fees or prices for its services or
- 13 products, shall have the right to receive such income and, in so
- 14 doing, may make an incidental profit. All such incidental
- 15 profits shall be applied to the maintenance and operation of the
- 16 lawful activities of the corporation, and in no case shall be
- 17 divided or distributed in any manner whatsoever among the
- 18 members, directors, or officers of the corporation. As used in

- 1 this section the terms fees or prices do not include rates of
- 2 contribution, fees or dues levied under an insurance certificate

- 3 issued by a fraternal benefit society, SO LONG AS THE
- 4 <u>DISTRIBUTION OF PROFITS ARISING FROM SAID FEES OR PRICES IS</u>
- 5 LIMITED TO THE PURPOSES SET FORTH HEREIN AND SECTION 7553.
- 6 § 7553. Dividends prohibited; compensation and certain payments
- 7 authorized.
- 8 (a) General rule. -- A nonprofit corporation shall not pay
- 9 dividends or distribute any part of its income or profits to its
- 10 members, directors, or officers. Nothing herein contained shall
- 11 prohibit a fraternal benefit society operating under the
- 12 <u>insurance laws of Pennsylvania from paying dividends or refunds</u>
- 13 by whatever name known pursuant to the terms of its insurance
- 14 contracts.
- 15 (b) Reasonable compensation for services. -- A nonprofit
- 16 corporation may pay compensation in a reasonable amount to
- 17 members, directors, or officers for services rendered.
- 18 (c) Certain payments authorized. -- A nonprofit corporation
- 19 may confer benefits upon members or nonmembers in conformity
- 20 with its purposes, may repay capital contributions, and may
- 21 redeem its subvention certificates or evidences of indebtedness,
- 22 as authorized by this article, except when the corporation is
- 23 currently insolvent or would thereby be made insolvent or
- 24 rendered unable to carry on its corporate purposes, or when the
- 25 fair value of the assets of the corporation remaining after such
- 26 conferring of benefits, payment or redemption would be
- 27 insufficient to meet its liabilities. A nonprofit corporation
- 28 may make distributions of cash or property to members upon
- 29 dissolution or final liquidation as permitted by this article.
