## AN ACT

- 1 Amending the act of February 1, 1966 (1965 P.L.1656, No.581),
- entitled "An act concerning boroughs, and revising, amending
- and consolidating the law relating to boroughs," increasing
- 4 amount of levy permitted for fire protection.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Clause (6) of section 1302, act of February 1,
- 8 1966 (1965 P.L.1656, No.581), known as "The Borough Code," is
- 9 amended to read:
- 10 Section 1302. Tax Levy. -- The council of the borough shall
- 11 have power, by ordinance, to levy and collect annually, a tax,
- 12 not exceeding thirty mills for general borough purposes and in
- 13 addition thereto any of the following taxes:
- 14 \* \* \*
- 15 (6) For the purchase of fire engines, fire apparatus and
- 16 fire hose for the use of the borough, or for assisting any fire
- 17 company in the borough in the purchase, renewal or repair of any
- 18 of its fire engines, fire apparatus or fire hose, for the

- 1 purposes of making appropriations to fire companies both within
- 2 and without the township and of contracting with adjacent
- 3 <u>municipalities for fire protection</u>, or for the purchase of land
- 4 upon which to erect a fire house, or for the erection and
- 5 maintenance of a fire house or fire houses, not exceeding three
- 6 mills. [, such additional millage permitted only following a
- 7 favorable referendum on the matter held in accordance with the
- 8 provisions of the act of April 18, 1923 (P.L.70). No.46, as
- 9 amended; If an annual tax for the purposes specified in this
- 10 clause is proposed to be set at a level higher than three mills,
- 11 the question shall be submitted to the voters of the borough,
- 12 and the county board of elections shall frame the question in
- 13 <u>accordance with the election laws of the Commonwealth for</u>
- 14 submission to the voters of the borough.

- 16 Section 2. This act shall take effect in 60 days.
