AN ACT

- Authorizing the Department of Property and Supplies to acquire, 2
- on behalf of the Department of Military Affairs, a tract of
- 3 land and the buildings thereon comprising the Valley Forge
- Army General Hospital Complex in Charlestown and Schuylkill
- 5 Townships, Chester County, for use as a State Veterans' Home;
- and making an appropriation.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 The Department of Property and Supplies is hereby Section 1.
- authorized to acquire, on behalf of the Department of Military 10
- Affairs, for use as a State Veterans' Home, the following tracts 11
- of land and buildings thereon, in Charlestown and Schuylkill 12
- 13 Townships, Chester County, Pennsylvania, bounded and described
- as follows: 14

1 Tract No. 1

- 2 Beginning at the center of the intersection of Kimberton Road
- 3 and Bridge Street, thence north 43 degrees 30 minutes east along
- 4 Bridge Street, for a distance of 1287.60 feet to the point of
- 5 beginning, thence north 46 degrees 30 minutes west 268 feet to a
- 6 point on the center line of First Avenue, thence south 43
- 7 degrees 30 minutes west 70 feet more or less, to a point on
- 8 center line of N. Plaza, thence north 46 degrees 30 minutes west
- 9 along center line of N. Plaza 258 feet to a point thence north
- 10 43 degrees 30 minutes east 46 feet to a point on center line of
- 11 driveway, thence north 32 degrees 30 minutes east 265 feet more
- 12 or less, to a point on the southerly edge of parking area,
- 13 thence north 46 degrees 30 minutes west 120 feet more or less,
- 14 along parking area to a point on center line of Second Avenue.
- 15 Thence north 43 degrees 30 minutes east 280 feet along center
- 16 line of Second Avenue to a point, thence south 46 degrees 30
- 17 minutes east 387.78 feet to a point on center line of First
- 18 Avenue, thence north 43 degrees 30 minutes east 40 feet to a
- 19 point on center line of First Avenue, thence south 46 degrees 30
- 20 minutes east 60 feet to a point thence north 43 degrees 30
- 21 minutes east 40 feet more or less, to a point on center line of
- 22 Sewage Station No. 1 driveway, thence north 46 degrees 30
- 23 minutes west 60 feet along center line of said driveway to a
- 24 point on center line of First Avenue, thence north 43 degrees 30
- 25 minutes east 70 feet along said center line to a point, thence
- 26 south 46 degrees 30 minutes east 220 feet to a point, thence
- 27 north 43 degrees 30 minutes east 30 feet to a point, thence
- 28 north 46 degrees 30 minutes west 220 feet to a point on center
- 29 line of First Avenue, thence along said center line north 43
- 30 degrees 30 minutes east 370 feet more or less, to a point on

- 1 property line, thence north 46 degrees 30 minutes west 1230 feet
- 2 along said property line to a point, thence south 43 degrees 30
- 3 minutes west 415 feet along property line to a point, thence
- 4 south 23 degrees east 65 feet more or less, to a point on the
- 5 center line of Fourth Avenue and J Street. Thence south 79
- 6 degrees west 181.57 feet along center line to a point of curve,
- 7 thence 102.68 feet on an arc to right, 111 feet radius to a
- 8 point of tangent, thence south 44 degrees west 74.25 feet to a
- 9 point on center line of H Street, thence south 46 degrees east
- 10 66 feet to a point of curve, thence 56 degrees 55 minutes on an
- 11 arc to right, a 35 foot radius to a point of tangent, thence
- 12 south 44 degrees west 260 feet to a point of curve, thence 48.7
- 13 feet on an arc to right, a 30 foot radius to a point of tangent,
- 14 thence north 46 degrees west 86 feet to a point, thence south 44
- 15 degrees west 25 feet to a point on center line of G Street,
- 16 thence along center line of G Street north 46 degrees west
- 17 495.04 feet to center of intersection of G Street and Fifth
- 18 Avenue, thence south 44 degrees west 635 feet more or less, to
- 19 southerly edge of sidewalk, thence south 46 degrees east along
- 20 said sidewalk for a distance of 620 feet more or less, to a
- 21 point on the westerly edge of sidewalk, thence south 44 degrees
- 22 west 210 feet more or less, to a point on the center line of E
- 23 Street, thence south 46 degrees east along said center line 300
- 24 feet more or less, to center of intersection of E Street and
- 25 south Third Avenue thence south 44 degrees west 110 feet more or
- 26 less, to a point on center line of D Street, thence south 46
- 27 degrees east 190 feet to a point, thence north 44 degrees east
- 28 110 feet to a point on center line of E Street, thence south 46
- 29 degrees east 714.89 feet along said center line, to a point of
- 30 curve, thence 47.9 feet on an arc to left 61 foot radius to a

- 1 point of tangent, thence north 88 degrees east 200.88 feet to a
- 2 point of curve, thence 47.90 feet on an arc to left, 61 foot
- 3 radius to a point of tangent, thence north 43 degrees 30 minutes
- 4 east, 356.73 feet to south edge of S Plaza, thence south 46
- 5 degrees 30 minutes east 268 feet more or less, to a point on the
- 6 center of Bridge Street, thence north 43 degrees 30 minutes east
- 7 300 feet to the point of beginning.
- 8 Tract No. 2
- 9 Beginning at the center of the intersection of Township Line
- 10 Road and F Street, for a distance of 190 feet along the center
- 11 line of Township Line Road to the point of beginning, thence
- 12 south 45 degrees 21 minutes east 160 feet to a point, thence
- 13 north 44 degrees 39 minutes east 70 feet to a point, thence
- 14 north 45 degrees 21 minutes west 166.12 feet more or less, to a
- 15 point on center line of Township Line Road, thence south 39
- 16 degrees 39 minutes west 70.26 feet to the point of beginning.
- 17 Tract No. 3
- 18 Parcel I
- 19 All that certain parcel of land located in Charlestown
- 20 Township, Chester County, being a part of the property of the
- 21 Frank B. Foster Estate, known as "Cold Stream Farm" lying on the
- 22 south side of Kimberton Road, and described as follows:
- 23 Beginning at a point on the center line of right-of-way for
- 24 water line hereinafter described (said point being south 42
- 25 degrees 22 minutes west a distance of 1627 feet from the center
- 26 line of Kimberton Road at a point 205.5 feet, more or less,
- 27 southwest from the center line of the culvert carrying the
- 28 overflow from the dam); thence (1) south 47 degrees 38 minutes
- 29 east a distance of 165 feet to a point; thence (2) south 42
- 30 degrees 22 minutes west a distance of 200 feet to a point;

- 1 thence (3) north 47 degrees 38 minutes west a distance of 200
- 2 feet to a point; thence (4) north 42 degrees 22 minutes east a
- 3 distance of 200 feet to a point; thence (5) south 47 degrees 38
- 4 minutes east a distance of 35 feet to the point of beginning,
- 5 containing therein 40,000 square feet, and including therewith
- 6 the right of ingress and egress to said land from Kimberton
- 7 Road.
- 8 Parcel II
- 9 A perpetual easement for the location, construction,
- 10 operation and maintenance of water pipe line in, over and under
- 11 the following land: Said easement is to be 10 feet in width, the
- 12 center line of which is described as follows:
- Beginning at a point on the center line of right-of-way for
- 14 water line hereinafter described (said point being south 42
- 15 degrees 22 minutes west a distance of 1627 feet from the center
- 16 line of Kimberton Road at a point 205.5 feet, more or less,
- 17 southwest from the center line of the culvert carrying the
- 18 overflow from the dam); thence (1) south 47 degrees 38 minutes
- 19 east a distance of 165 feet to a point; thence (2) south 42
- 20 degrees 22 minutes west a distance of 50 feet to the true point
- 21 of beginning: thence eastwardly at right angles to the last
- 22 described line for a distance of 200 feet, more or less, to the
- 23 bottom of a ravine.
- 24 Parcel III
- 25 A perpetual easement for the location, construction,
- 26 operation and maintenance of a water pipe line is, over and
- 27 under the following land: Said easement is to be 10 feet in
- 28 width, center line of which is described as follows:
- 29 Beginning at a point in the center line of Kimberton Road
- 30 said point being 9.90 feet south 89 degrees 8 minutes west of a

- 1 railroad spike at an angle in said Kimberton Road (said spike
- 2 being 195.5 feet west of a culvert under Kimberton Road carrying
- 3 the overflow of the dam); thence, south 42 degrees 22 minutes
- 4 west a distance of 1627 feet to a point on the north line of
- 5 Parcel No. I hereinafter described and intersecting said north
- 6 line of Parcel No. I at a point approximately 35 feet east of an
- 7 existing fence line.
- 8 Section 2. The premises shall not be acquired until the
- 9 title and conveyance documents have been approved by the
- 10 Department of Justice.
- 11 Section 3. This act shall take effect immediately.
