AN ACT

Creating the Department of Human Resources and transferring to it the powers and duties of the Department of Public Welfare; providing that the Secretary of Public Welfare shall be ex officio, the Secretary of Human Resources; and transferring personnel, appropriations, allocations, contracts, agreements, equipment, files, obligations and other material from the Department of Public Welfare to the Department of Human Resources.

9 The General Assembly of the Commonwealth of Pennsylvania

10 hereby enacts as follows:

11 Section 1. There is hereby created a Department of Human

12 Resources. All of the functions, powers and duties of the

13 Department of Public Welfare are hereby transferred to the

14 Department of Human Resources.

15 Section 2. The Department of Human Resources shall be

16 administered by a Secretary of Human Resources. The Secretary of

17 Public Welfare shall ex officio be the Secretary of Human

18 Resources.

19 Section 3. (a) Whenever in any law reference is made to the

Department of Public Welfare such reference shall be deemed to
refer to and include the Department of Human Resources.

3 (b) Whenever in any law reference is made to the Secretary 4 of Public Welfare or to the Secretary of Human Resources, such 5 reference shall be deemed to refer to the Secretary of Public 6 Welfare as ex officio Secretary of Human Resources.

7 Section 4. All personnel, appropriations, allocations, 8 contracts, agreements, equipment, files, obligations and other material which relate to the administration and enforcement of 9 10 the laws of this Commonwealth as they relate to the Department 11 of Public Welfare are hereby transferred to the Department of Human Resources with the same force and effect as if the 12 13 appropriations had been made to the Department of Human Resources in the first instance, and said contracts, agreements, 14 15 and obligations of the Department of Public Welfare had been 16 incurred or entered into by said Department of Human Resources. 17 Section 5. This act shall take effect immediately.
