AN ACT

1 Amending the act of June 30, 1975 (No.8-A), entitled "An act to
2 provide for the expenses of the Executive, Legislative and
3 Judicial Departments of the Commonwealth, the public debt and
4 for the public schools for the fiscal period July 1, 1975 to
5 June 30, 1976, and for the payment of bills incurred and
6 remaining unpaid at the close of the fiscal period ending
7 June 30, 1975," increasing the appropriations to the
8 Department of Public Welfare for the administration of the
9 "Mental Health and Mental Retardation Act of 1966," for
10 mental health and mental retardation community services and
11 for interim care.

12 The General Assembly of the Commonwealth of Pennsylvania
13 hereby enacts as follows:

14 Section 1. As much as relates to the appropriations to the
15 Department of Public Welfare for the administration of the
16 "Mental Health and Mental Retardation Act of 1966," and for
17 grants to counties provided for community based care, treatment
18 and training for the mentally retarded in section 2, act of June
19 30, 1975 (No.8-A), known as the "General Appropriation Act of
20 1975," are amended to read:

21 Section 2. The following sums, or as much thereof as may be
22 necessary, are hereby specifically appropriated from the General

1 Fund to the several hereinafter named agencies of the Executive,
2 Legislative and Judicial Departments of the Commonwealth for the
3 payment of the salaries, wages or other compensation and travel
4 expense of the duly elected or appointed officers and employees
5 of the Commonwealth, for payment of fees of contractual services
6 rendered, for the purchase or rental of goods, services,
7 printing, equipment, land and buildings and for payment of any
8 other expenses, as provided by law or by this act, necessary for
9 the proper conduct of the duties, functions and activities and
10 for the purposes hereinafter set forth for the fiscal period
11 beginning July 1, 1975 and for the payment of bills incurred and
12 remaining unpaid at the close of the fiscal period ending June
13 30, 1975.

28 be retroactive to July 1, 1975.
