In the House of Representatives, April 29, 1975

- 1 WHEREAS, The Philadelphia State Hospital at Byberry has
- 2 become a center of controversy.
- 3 WHEREAS, This institution is charged with the care of the
- 4 mentally retarded AND THE MENTALLY ILL.
- 5 WHEREAS, It has been reported that illegal administration of
- 6 drugs on patients has taken place; the qualifications of the
- 7 staff doctors are dubious; incidents of racial discrimination
- 8 are occurring frequently and the lack of social programs on
- 9 weekends is resulting in a rampant rise in homosexuality.
- 10 WHEREAS, It is further reported that the criminally insane
- 11 are placed in this institution together with the mental
- 12 patients.
- 13 WHEREAS, This Legislature should also be concerned with this
- 14 matter. Such concern should not revolve about any of the
- 15 personalities in this controversy, but rather should be directed
- 16 to the basic issue of the quality of care being provided the

- 1 mentally retarded patients at Byberry and the need for remedial
- 2 legislation or other positive action by this Legislature to
- 3 assure such quality of care; therefore be it
- 4 RESOLVED, That the Speaker of the House of Representatives
- 5 appoint a committee of nine members of the House of
- 6 Representatives, five of whom shall be members of the majority
- 7 party and four of whom shall be members of the minority party,
- 8 to investigate the controversy at the Philadelphia State
- 9 Hospital at Byberry relative to the quality of care given to the
- 10 mentally retarded AND MENTALLY ILL patients of this institution

- 11 to determine what legislative action is needed to assure quality
- 12 care of such patients; and be it further
- 13 RESOLVED, That the committee may hold public hearings, take
- 14 testimony, and make its study at such places as it deems
- 15 necessary within this Commonwealth. It may issue subpoenas under
- 16 the hand and seal of its chairman commanding any person to
- 17 appear before it and answer questions touching matters properly
- 18 being inquired into by the committee and to produce such books,
- 19 papers, records and documents as the committee deems necessary.
- 20 Such subpoenas may be served upon any person and shall have the
- 21 force and effect of subpoenas issued out of the courts of this
- 22 Commonwealth. Any person who wilfully neglects or refuses to
- 23 testify before the committee or to produce any books, papers,
- 24 records or documents, shall be subject to the penalties provided
- 25 by the laws of the Commonwealth in such case. Each member of the
- 26 committee shall have power to administer oaths and affirmations
- 27 to witnesses appearing before the committee; and be it further
- 28 RESOLVED, That within thirty calendar days after the
- 29 committee has made its report, the chairman of the committee
- 30 shall cause a record of all expenses incurred by the committee,

- 1 or the members thereof, which are payable at Commonwealth
- 2 expense, to be filed with the Speaker of the House and the
- 3 Speaker shall cause the same to be entered in the journal
- 4 thereof. No expenses incurred by the committee or any member
- 5 thereof shall be reimbursable by the Chief Clerk unless such
- 6 expense shall first have been included as an expense item in the
- 7 record heretofore required; and be it further
- 8 RESOLVED, That the committee shall report its findings and
- 9 any suggestive SUGGESTED legislation to the General Assembly as <-
- 10 soon as possible.
