In the House of Representatives, July 23, 1975

- 1 WHEREAS, There is a critical shortage of replacement jar lids
- 2 for home canning making it difficult to obtain new lids for used
- 3 jars. This shortage should be investigated in order to determine
- 4 the reasons behind the low supply of replacement canning lids
- 5 and what steps can be taken to insure that an adequate supply of
- 6 replacement lids is made available; therefore be it
- 7 RESOLVED, That the Speaker of the House of Representatives
- 8 appoint the members of the Agriculture Committee and the
- 9 Consumer Protection Committee of the House of Representatives to
- 10 investigate the cause of and find a solution to the shortage of
- 11 replacement jar lids for home canning; and be it further
- 12 RESOLVED, That the committee may hold hearings, take
- 13 testimony, and make its investigations at such places as it
- 14 deems necessary. It may issue subpoenas under the hand and seal
- 15 of its chairman commanding any person to appear before it and to
- 16 answer questions touching matters properly being inquired into
- 17 by the committee and to produce such books, papers, records and

- 1 documents as the committee deems necessary. Such subpoenas may
- 2 be served upon any person and shall have the force and effect of
- 3 subpoenas issued out of the courts of this Commonwealth. Any
- 4 person who wilfully neglects or refuses to testify before the
- 5 committee or to produce any books, papers, records or documents,
- 6 shall be subject to the penalties provided by the laws of the
- 7 Commonwealth in such case. Each member of the committee shall
- 8 have power to administer oaths and affirmations to witnesses
- 9 appearing before the committee; and be it further
- 10 RESOLVED, That within 30 calendar days after the committee
- 11 has made its report, the chairman of the committee shall cause a
- 12 record of all expenses incurred by the committee, or the members
- 13 thereof, which are payable at Commonwealth expense, to be filed
- 14 with the Speaker of the House and the Speaker shall cause the
- 15 same to be entered in the journal thereof. No expenses incurred
- 16 by the committee or any member thereof shall be reimbursable by
- 17 the Chief Clerk unless such expense shall first have been
- 18 included as an expense item in the record heretofore required;
- 19 and be it further
- 20 RESOLVED, That the committee report its findings and proposed
- 21 legislation, if such be necessary, to the General Assembly as
- 22 soon as possible.
