- AN ACT To regulate the sale and distribution for agricultural purposes 2 of ground limestone, burned and hydrated lime and related 3 products in the Commonwealth of Pennsylvania; conferring 4 powers and imposing duties on the Secretary of Agriculture; 5 establishing fees; making an appropriation and prescribing 6 penalties. 7 TABLE OF CONTENTS Section 1. - 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the "Agricultural
- 9 Liming Materials Act."
- 10 Section 2. Enforcing official.
- 11 This act shall be administered by the Pennsylvania Secretary
- 12 of Agriculture hereinafter referred to as the "Secretary".
- 13 Section 3. Definitions.
- 14 The following words and phrases when used in this act shall
- 15 have, unless the context clearly indicates otherwise, the
- 16 meanings given to them in this section:
- 17 "Agricultural liming materials." A product whose calcium and
- 18 magnesium compounds are capable of neutralizing soil acidity.
- 19 "Brand." The term, designation, trademark, product name or
- 20 other specific designation under which individual agricultural
- 21 liming material is offered for sale.
- 22 "Bulk." In nonpackaged form.
- 23 "Burnt lime." A material made from limestone which consists
- 24 predominantly of calcium oxide or combination of calcium oxide
- 25 with magnesium oxide.
- 26 "Calcium carbonate equivalent." The acid neutralizing
- 27 capacity of an agricultural liming material expressed as weight
- 28 percentage of calcium carbonate.
- 29 "Effective neutralizing power." A value representing the
- 30 product of particle size of the limestone sample times its

- 1 calcium and magnesium carbonate content.
- 2 "EFFECTIVE NEUTRALIZING POWER." A RELATIVE VALUE USING THE

- 3 CALCIUM OXIDE CONTENT, MAGNESIUM OXIDE CONTENT AND FINENESS, TO
- 4 EXPRESS THE EFFECTIVENESS OF A LIMESTONE IN NEUTRALIZING SOIL
- 5 ACIDITY.
- 6 "Fineness." The percentage by weight of the material which
- 7 will pass United States Standard sieves of specified sizes. (The
- 8 secretary shall promulgate regulations relating to fineness and
- 9 shall be guided by ASTM specification for sieve sizes).
- 10 "Hydrated lime." A material made from burnt lime which
- 11 consists predominantly of calcium hydroxide or a combination of
- 12 calcium hydroxide with magnesium oxide and/or magnesium
- 13 hydroxide.
- 14 "Industrial by-product." Any industrial waste or by-product
- 15 containing calcium or calcium and magnesium in forms that will
- 16 neutralize soil acidity.
- 17 "Label." Any written or printed matter on or attached to the
- 18 package or on the delivery slips which accompanies bulk
- 19 shipments.
- 20 "Limestone." A material consisting predominantly of calcium
- 21 carbonate with magnesium carbonate capable of neutralizing soil
- 22 acidity.
- 23 "Marl." A granular or loosely consolidated earthy material
- 24 composed predominantly of seashell fragments and calcium
- 25 carbonate.
- 26 "Percent" or percentage." By weight.
- 27 "Person." Individual, partnership, association, firm or
- 28 corporation.
- 29 "Secretary." The Secretary of Agriculture or his authorized
- 30 agent.

- 1 "Ton." A net weight of 2,000 pounds avoirdupois or 907
- 2 kilograms.
- 3 "Weight." The weight of undried material as offered for

- 4 sale.
- 5 Section 4. Labeling.
- 6 (a) Agricultural liming materials sold, offered or exposed
- 7 for sale in the Commonwealth shall have affixed to each package
- 8 in a conspicuous manner on the outside thereof a plainly
- 9 printed, stamped or otherwise marked label or tag, or, in the
- 10 case of bulk sales, a delivery slip setting forth at least the
- 11 following information:
- 12 (1) The name and principal office address of the
- 13 manufacturer or distributor.
- 14 (2) The brand or trade name of the material.
- 15 (3) The identification of the product as to the type of
- 16 the agricultural liming material.
- 17 (4) The net weight of the agricultural liming material.
- 18 (5) The minimum percentage of calcium oxide and
- 19 magnesium oxide and/or calcium carbonate and magnesium
- 20 carbonate.
- 21 (6) Calcium carbonate equivalent as determined by
- 22 methods prescribed by the Association of Official Analytical
- 23 Chemists. Minimum calcium carbonate equivalents as prescribed
- 24 by regulation.
- 25 (7) The minimum percent by weight passing through United
- 26 States Standard sieves as prescribed by regulations.
- 27 (b) No information or statement shall appear on any package,
- 28 label, delivery slip or advertising matter which is false or
- 29 misleading to the purchaser as to the quality, analysis, type or
- 30 composition of the agricultural liming material.

- 1 (c) If any material is added to any agricultural liming
- 2 material, excluding water, subsequent to packaging, labeling or
- 3 loading thereof and before delivery to the consumer, a plainly
- 4 marked notice to that effect shall be affixed by the vendor to
- 5 the package or delivery slip to identify the kind and degree of
- 6 such added material.
- 7 (d) At every site from which agricultural liming materials
- 8 are delivered in bulk and at every place where consumer orders
- 9 for bulk deliveries are placed, there shall be conspicuously
- 10 posted a copy of the delivery slip required by this section for
- 11 each brand of material.
- 12 (e) The secretary may, after a public hearing, require by
- 13 regulation thereafter that the minimum percentage of calcium
- 14 oxide and magnesium oxide shall be expressed in the following
- 15 form:
- 16 Total Calcium (Ca) percent
- Total Magnesium (Mg) _____percen
- 18 The secretary may not impose such regulatory standards if they
- 19 conflict with labeling requirements of other states and if they
- 20 would thereby constitute an economic hardship on the industry
- 21 due to dual labeling requirements. The effective date of said
- 22 regulation shall not be less than 18 months following the
- 23 adoption of regulations. For a period of two years following the
- 24 effective date of the regulations the equivalent of calcium and
- 25 magnesium may also be shown in the form of calcium oxide and
- 26 magnesium oxide.
- 27 Section 5. Effective neutralizing power.
- The Secretary of Agriculture shall MAY by rules and
- 29 regulations establish standards and procedures to be utilized in
- 30 the determination of the effective neutralizing power of

- 1 agricultural liming materials. Any agricultural liming material
- 2 that is below the standard of effective neutralizing power
- 3 established by the secretary shall not be sold or offered for
- 4 sale in the Commonwealth as an agricultural liming material
- 5 unless it is labeled "substandard." Such labeling shall not be
- 6 smaller than the largest labeling found elsewhere on the package
- 7 and shall be prominently visible to the buyer.
- 8 Section 6. Licensing.
- 9 No agricultural liming materials shall be manufactured or
- 10 distributed in this Commonwealth until a license has been
- 11 obtained by both the manufacturer and the person whose name
- 12 appears on the label of the agricultural liming material. The
- 13 annual license fee shall be \$25 payable on or before July 1 of
- 14 each year or prior to the distribution in such year.
- 15 Section 7. Denial or revocation of a license.
- 16 The secretary may refuse to issue or may revoke a license
- 17 issued pursuant to this act if he finds, after a hearing, that
- 18 the applicant or the license holder has violated any provisions
- 19 of this act or the rules and regulations adopted hereunder.
- 20 Section 8. Inspection fee; report of tonnage.
- 21 (a) Each licensee whose name appears on the label of
- 22 agricultural liming material shall file, with the secretary, a
- 23 semiannual statement not later than the last day of January and
- 24 July of each year in a form prescribed by the secretary setting
- 25 forth the number of net tons of agricultural liming material
- 26 distributed in this Commonwealth during the prior six months'
- 27 period. Upon filing such statement the licensee whose name
- 28 appears on the label shall pay an inspection fee at the rate of
- 29 3ç per ton, except that no semiannual payment shall be less than
- 30 \$12.50. Failure to make an accurate statement of tonnage or to

- 1 pay the control fee shall constitute sufficient cause for the
- 2 revocation of the license.
- 3 (b) Sales of agricultural liming materials to manufacturers
- 4 or exchanges between them are hereby exempted from the control
- 5 fee.
- 6 (c) If the tonnage report is not filed by February 15 or
- 7 August 15, a penalty amounting to 10% of the inspection fee or
- 8 \$10, whichever is greater, shall be added to the amount of the
- 9 inspection fee when payment is made. This penalty fee shall not
- 10 prevent the secretary from taking other actions as provided in
- 11 this act.
- 12 Section 9. Inspection, sampling, analysis.
- 13 (a) It shall be the duty of the secretary to sample,
- 14 inspect, make analyses of and test agricultural liming materials
- 15 distributed within this Commonwealth and to determine whether
- 16 such agricultural liming materials are in compliance with the
- 17 provisions of this act. The secretary is authorized to enter
- 18 upon any public or private premises or carriers at any
- 19 reasonable time in order to have access to the agricultural
- 20 liming materials and to the records relating to their
- 21 distribution.
- 22 (b) The methods of analysis and sampling shall be those
- 23 approved by the secretary, and he shall be guided by the
- 24 Association of Analytical Chemists procedures.
- 25 (c) The secretary shall publish annually the results of the
- 26 official analysis of agricultural liming material samples.
- 27 Section 10. Stop sale orders.
- 28 When the secretary finds that agricultural liming material is
- 29 being offered or exposed for sale in violation of any of the
- 30 provisions of this act, the secretary may issue a written or

- 1 printed "Stop Sale, use, or removal" order to the owner or
- 2 custodian of such agricultural liming material. The secretary
- 3 shall not release the agricultural liming material so withdrawn
- 4 until the requirements of the provisions of this act have been
- 5 complied with and all costs and expense incurred in connection
- 6 with the withdrawal have been paid by the violator.
- 7 Section 11. Prohibited acts.
- 8 (a) No agricultural liming material shall be sold or offered
- 9 for sale in this Commonwealth unless it complies with provisions
- 10 of this act and the secretary's rules and regulations.
- 11 (b) No agricultural liming material shall be sold or offered
- 12 for sale in this Commonwealth which contains toxic materials in
- 13 quantities injurious to plants or animals.
- 14 Section 12. Rules and regulations.
- 15 The secretary is empowered to promulgate and enforce such
- 16 reasonable rules and regulations relating to the sale of
- 17 agricultural liming materials as is deemed necessary to carry
- 18 out the provisions of this act.
- 19 Section 13. Penalties.
- 20 (a) Any person violating any of the provisions of this act
- 21 or the rules and regulations issued thereunder, upon conviction
- 22 thereof in a summary proceeding, shall be fined not less than
- 23 \$100 nor more than \$300 for the first violation, and not less
- 24 than \$500 nor more than \$1,000 for subsequent violations. In all
- 25 prosecutions under this act involving the composition of a lot
- 26 of agricultural liming materials, a certified copy of the
- 27 official analysis signed by the secretary shall be accepted as
- 28 prima facie evidence of the composition.
- 29 (b) Public notice shall be made of violations resulting in
- 30 convictions.

- 1 Section 14. Disposition of fees and fines.
- 2 All licensing and inspection fees and fines, when collected,
- 3 shall be paid into the State Treasury, and shall be credited to
- 4 the general government operations appropriation of the
- 5 Department of Agriculture for the payment of the costs of
- 6 inspection, sampling, analysis and other expenses necessary for
- 7 the administration of this act.
- 8 Section 15. Repeal.
- 9 The act of August 8, 1961 (P.L.971, No.435), known as the
- 10 "Pennsylvania Agricultural Lime Act," is repealed.
- 11 Section 16. Effective date.
- 12 This act shall take effect July 1, 1977. However, registrants
- 13 shall be allowed not more than one year to use existing
- 14 inventories of labeled or labeling materials.
