AN ACT Amending Title 15 (Corporations and Unincorporated Associations) 2 of the Pennsylvania Consolidated Statutes, PROVIDING FOR NAME 3 CHANGES FOR CHURCHES AND adding provisions relating to certain nonprofit corporations. 4 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 Section 1. Title 15, act of November 25, 1970 (P.L.707, 8 No.230), known as the Pennsylvania Consolidated Statutes, is 9 amended by adding sections to read: 10 § 7907. CHANGE OF NAME OF CHURCH. 11 (A) GENERAL RULE. -- ANY CORPORATION FORMED FOR RELIGIOUS 12 PURPOSES WHICH DESIRES TO CHANGE ITS CORPORATE NAME BECAUSE OF OR AS A RESULT OF A UNION, MERGER OR CONSOLIDATION OF THE 13 14 NATIONAL OR INTERNATIONAL CHURCH BODY WITH WHICH SUCH RELIGIOUS 15 CORPORATION IS AN AFFILIATE, SUBSIDIARY OR COMPONENT PART, IS

HEREBY AUTHORIZED TO FILE A CERTIFICATE OF CHANGE OF NAME WITH

THE DEPARTMENT, WHICH CERTIFICATE SHALL SET FORTH THE NAME AND

18 REGISTERED OFFICE OF THE CORPORATION AND THE NAME THE

19 CORPORATION INTENDS TO ASSUME.

- 1 (B) DEPARTMENTAL APPROVAL.--IF THE DEPARTMENT FINDS THAT THE
- 2 PROPOSED NAME IS AVAILABLE FOR CORPORATE USE, IT SHALL REGISTER
- 3 THE NAME AND SHALL ISSUE TO THE CORPORATION OR ITS
- 4 REPRESENTATIVE A CERTIFICATE THAT THE PROPOSED CHANGE OF NAME
- 5 HAS BEEN DULY REGISTERED.
- 6 (C) EFFECT OF CHANGE.--UPON REGISTRATION OF THE CERTIFICATE
- 7 OF CHANGE OF NAME BY THE DEPARTMENT SUCH RELIGIOUS CORPORATION
- 8 SHALL THEREAFTER BE KNOWN AS AND BEAR THE NAME SET FORTH IN ITS
- 9 CERTIFICATE OF CHANGE OF NAME; BUT SUCH CHANGE OF NAME SHALL NOT
- 10 IN ANY RESPECT CHANGE THE IDENTITY OF OR AFFECT, ABATE, DEFEAT,
- 11 ALTER OR AMEND ANY OF THE POWERS, RIGHTS, PRIVILEGES, PROPERTY,
- 12 DUTIES, LIABILITIES OR OBLIGATIONS OF ANY SUCH RELIGIOUS
- 13 CORPORATION, ALL OF WHICH SHALL REMAIN IN FULL FORCE AND EFFECT
- 14 AS THOUGH ITS NAME HAD NOT BEEN SO CHANGED.
- 15 (D) FEE.--THE FEE OF THE DEPARTMENT OF STATE FOR ALL
- 16 TRANSACTIONS FOR CHANGE OF THE CORPORATE NAME OF A CHURCH SHALL
- 17 BE \$10.
- 18 § 8102. Housing corporations.
- 19 (a) Corporations chartered in District of Columbia. -- A
- 20 nonprofit cooperative corporation chartered in the District of
- 21 Columbia for the purpose of owning and operating a low or
- 22 moderate income housing project shall be deemed a foreign
- 23 corporation not-for-profit within this title.
- 24 (b) Name. -- A nonprofit cooperative corporation chartered in
- 25 the District of Columbia, and registered in Pennsylvania
- 26 pursuant to this title, may use the word "cooperative" in its
- 27 corporate name but shall use with its corporate name in this
- 28 Commonwealth, to be placed immediately under or following such
- 29 <u>name, the words "a District of Columbia Corporation."</u>
- 30 § 8103. Payments in lieu of taxes.

- 1 (a) Duty to pay. -- It shall be the duty of each foreign
- 2 <u>corporation not-for-profit doing business in this Commonwealth</u>
- 3 to pay to local political subdivisions an amount equal to the
- 4 <u>local taxes levied by the respective political subdivisions for</u>
- 5 which the corporation would otherwise be liable if it were a
- 6 corporation for profit.
- 7 (b) Collection and enforcement. -- Every political subdivision
- 8 entitled to receive payments in lieu of taxes under this section
- 9 is authorized to employ the same tax collection methods and
- 10 remedies as provided by law.
- 11 (c) Rights preserved. -- Every corporation required to make
- 12 payments in lieu of taxes under this section shall have all the
- 13 rights of any taxpayer as provided by law.
- 14 Section 2. The provisions of section SECTIONS 7907 AND 8102 <--
- 15 shall take effect in 60 days. The provisions of section 8103
- 16 shall take effect on January 1 next following the date of final
- 17 enactment, and shall be applicable to tax years beginning on and
- 18 after that date.
