AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 2 3 special and primary elections, the nomination of candidates, 4 primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 9 10 11 elections," further providing for candidates for political 12 office AND FURTHER PROVIDING FOR THE FILING OF NOMINATION 13 PETITIONS. 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. The act of June 3, 1937 (P.L.1333, No.320), known 17 as the "Pennsylvania Election Code," is amended by adding a 18 section to read: Section 951.1. Limitations on Eligibility of Candidates .--19 20 Any person who is a registered and enrolled member of January 15 is ineligible to be a candidate of a political body 21 22 in an election in the same year. ANY PERSON WHO IS A REGISTERED

- 1 AND ENROLLED MEMBER OF A PARTY THIRTY DAYS BEFORE THE PRIMARY
- 2 SHALL BE INELIGIBLE TO APPEAR ON A BALLOT AS AN INDEPENDENT
- 3 <u>CANDIDATE IN A GENERAL ELECTION HELD IN THAT SAME YEAR.</u>
- 4 Section 2. This act shall take effect immediately.

- 19 SECTION 3. THIS ACT SHALL TAKE EFFECT IMMEDIATELY. FOR
- 20 CALENDAR YEAR 1978 NO SIGNATURE AFFIXED TO A NOMINATION PAPER
- 21 SHALL BE COUNTED UNLESS IT BEARS A DATE AFFIXED NOT LATER THAN
- 22 30 DAYS FROM THE DATE OF ENACTMENT OF THIS ACT; AND ALL
- 23 NOMINATION PAPERS MUST BE FILED NOT LATER THAN 30 DAYS FROM THE
- 24 DATE OF ENACTMENT OF THIS ACT.
