AN ACT

- Amending the act of November 8, 1971 (P.L.532, No.136), entitled
 "An act providing assistance to persons suffering damage from
 mine subsidence," establishing the Mine Subsidence Fund as a
 source of funds for home owners to repair or replace homes
- 4 source of funds for home owners to repair or replace homes
- damaged or destroyed by mine subsidence and making an
- 6 appropriation.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1, act of November 8, 1971 (P.L.532,
- 10 No.136), entitled "An act providing assistance to persons
- 11 suffering damage from mine subsidence," is amended to read:
- 12 Section 1. [Whenever the Governor finds as a fact that
- 13 conditions of emergency exist as a result of mine subsidence, he
- 14 shall have power to transfer any unused funds not exceeding two
- 15 million dollars (\$2,000,000) which may have been appropriated
- 16 for the ordinary expenses of the government to a special account
- 17 in the General Fund for emergency mine subsidence relief; and,
- 18 the funds are hereby appropriated to the Department of

- 1 Environmental Resources.] The Mine Subsidence Fund is hereby
- 2 <u>created as an emergency fund for relief of persons suffering</u>
- 3 damage from mine subsidence. The fund shall be administered by
- 4 the Department of Environmental Resources. The funds [so
- 5 transferred] shall be used to match any Federal funds available
- 6 for mine subsidence relief, to move persons whose homes are
- 7 destroyed or endangered until the homes are repaired or there is
- 8 no further danger of subsidence or a new permanent residence is
- 9 found to fill voids from mine subsidence and to provide a source
- 10 of funds from which home owners can obtain funds at interest
- 11 rates not to exceed [two] three per cent for the repair or
- 12 replacement of homes damaged or destroyed by mine subsidence.
- 13 The funds obtained pursuant to this act shall be repaid into the
- 14 fund in accordance with regulations of the Department of
- 15 Environmental Resources.
- Section 2. The sum of \$500,000 from the appropriation to the
- 17 Department of Environmental Resources for land protection in the
- 18 act of August 20, 1977 (No.11-A), known as the "General
- 19 Appropriation Act of 1977," is hereby reappropriated to the
- 20 Department of Environmental Resources to be deposited in the
- 21 Mine Subsidence Fund and used for purposes of the fund.
- 22 Section 3. This act shall take effect immediately.
