AN ACT

- Amending the act of July 9, 1976 (P.L.586, No.142), entitled "An act amending Titles 42 (Judiciary and Judicial Procedure), 15 3 (Corporations and Unincorporated Associations), 18 (Crimes and Offenses) and 71 (State Government) of the Pennsylvania 5 Consolidated Statutes, adding revised, codified and compiled provisions relating to judiciary and judicial procedure, 7 including certain judicially enforceable rights, duties, 8 immunities and liabilities and separately enacting certain related provisions of law, " further providing fees charged by 9 the office of the clerk of the court of common pleas of all 10 counties of the second class. 11
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Subsection (e) of section 24, act of July 9, 1976
- 15 (P.L.586, No.142), known as the "Judiciary Act of 1976," is
- 16 amended to read:
- 17 Section 24. Financial matters.--* * *
- 18 (e) Until otherwise provided by statute, the prothonotary
- 19 and the clerk of the orphans' court division of all counties of
- 20 the second class shall set apart [the sum of 50¢] from the fees
- 21 fixed under or pursuant to 42 Pa.C.S. § 1725 or under any other
- 22 statute and collected by them on the following actions,

- 1 proceedings and appeals and remit monthly the total collected to
- 2 the county treasurer for the exclusive use and benefit of the
- 3 public law library in the county:
- 4 (1) [All] The sum of \$1.00 for all appeals to the court
- of common pleas from any administrative [boards, agencies,
- 6 commissions, authorities, ordinances of local government
- bodies, or other entities] <u>agency</u>, <u>independent agency</u>,
- 8 government unit, government agency, or Commonwealth agency.
- 9 (2) [Any] The sum of \$1.00 for any and all other appeals
- 10 which are filed with or are to be heard by the court of
- 11 common pleas which are not specifically set forth in
- paragraph (1), including, but not limited to appeals from
- district justices, the Pittsburgh Magistrates Court and the
- 14 Traffic Court of Pittsburgh.
- 15 (3) [Appointments] The sum of \$1.00 for appointments of
- 16 Boards of View.
- 17 (4) [Certiorari] The sum of \$1,00 for certiorari to
- district justices and [magistrates] the Pittsburgh
- 19 Magistrates Court and the Traffic Court of Pittsburgh.
- 20 (5) [Commencement] The sum of \$1.00 for the commencement
- of any civil action or proceeding.
- 22 (6) [Filing practipes] The sum of \$1.00 for the filing
- 23 <u>of a praecipe</u> for and issuance of [writs] <u>a writ</u> of execution
- 24 <u>or attachment.</u>
- 25 (7) [Entry] The sum of \$1.00 for the entry of any
- judgment by confession or otherwise.
- 27 (8) [Filing] The sum of \$1.00 for the filing of
- adversary and amicable scire facias proceedings.
- 29 (9) The sum of \$1.00 for every filing with respect to
- fictitious names, whether individual or corporate.

- 1 (10) The sum of \$1.00 for the probate of any will, the
- 2 issuance of letters of administration, or any petition for
- 3 <u>disposition of decedents estates independent of the issuance</u>
- 4 <u>of letters testamentary or of administration.</u>
- 5 (11) The sum of \$1.00 for the filing of any account of
- 6 any fiduciary in the office of the clerk of the orphans'
- 7 <u>court division or in the office of the prothonotary.</u>
- 8 (12) The sum of \$1.00 for the filing of any petition for
- 9 <u>a writ of habeas corpus for the custody of a minor child or</u>
- any petition for the award of custody of a minor child.
- [(9) Miscellaneous] (13) The sum of \$1.00 for the
- filing of any praecipe for the issuance of any miscellaneous
- writs or for the filing of any petition for a citation or the
- 14 <u>filing of any caveat</u> not specifically provided for <u>in this</u>
- 15 subsection.

- 17 Section 2. This act shall take effect on July 1, 1979.
