## AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the 4 Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, 6 including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 12 boards, commissions, and officers; fixing the salaries of the 13 Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the 17 18 number and compensation of the deputies and all other 19 assistants and employes of certain departments, boards and 20 commissions shall be determined, "increasing the membership on the State Board of Education. 21
- 22 The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:
- 24 Section 1. Section 408.1, act of April 9, 1929 (P.L.177,
- 25 No.175), known as "The Administrative Code of 1929," amended
- 26 October 18, 1972 (P.L.935, No.224), is amended to read:
- 27 Section 408.1. The State Board of Education.--The State

- 1 Board of Education shall consist of [seventeen] twenty one
- 2 members, [eight] ten of whom shall also serve as members of the
- 3 Council of Basic Education, and [eight] ten of whom shall also
- 4 serve as members of the Council of Higher Education. The member
- 5 designated by the Governor as Chairman of the State Board of
- 6 Education shall also serve as a member of the Council of Basic
- 7 Education and of the Council of Higher Education. Members at
- 8 large on the effective date of this act may be assigned by the
- 9 Governor to either council. [Each] Except the legislative
- 10 members, each member shall be appointed by the Governor, by and
- 11 with the advice and consent of two-thirds of all the members of
- 12 the Senate, and shall, except as hereinafter provided, hold
- 13 office for terms of six years each and until his successor has
- 14 been appointed and has qualified. The majority and minority
- 15 <u>chairmen of the House of Representatives and Senate Education</u>
- 16 Committees shall serve as ex officio members of the board and
- 17 shall serve as members for as long as they hold their respective
- 18 positions. Members shall receive no salary but shall be entitled
- 19 to travel and other necessary expenses incurred in the
- 20 performance of their duties as members of the board.
- 21 [Nine] <u>Eleven</u> members shall constitute a quorum provided that
- 22 at least [four] five members serving on each of the councils are
- 23 present. The affirmative vote of a majority of all the members
- 24 of the board duly recorded showing how each member voted shall
- 25 be required in order to take action adopting policies,
- 26 standards, rules and regulations. The board shall meet at least
- 27 five times a year at such times and places as it shall
- 28 determine. Special meetings may be called by the chairman or at
- 29 the request of a majority of the members of the board.
- 30 Of the members first appointed, three shall be appointed for

- 1 a term of one year, three shall be appointed for a term of two
- 2 years, three shall be appointed for a term of three years, three
- 3 shall be appointed for a term of four years, three shall be
- 4 appointed for a term of five years, and two shall be appointed
- 5 for a term of six years. Thereafter, all terms shall be for six
- 6 years, except that an appointment to fill a vacancy shall be for
- 7 the unexpired term.
- 8 The Governor shall designate, to serve at his pleasure, a
- 9 member as Chairman of the State Board of Education.
- 10 Except for the chairman, not more than two members serving on
- 11 each council shall be employed either in a school system in the
- 12 Department of Education or by any educational institution. At
- 13 least two members serving on each council shall have had
- 14 previous experience with technical education or training.
- 15 For the purpose of formulating policy proposals applicable to
- 16 elementary, secondary, vocational-technical education and higher
- 17 education in the Commonwealth, there shall be two councils to
- 18 consist of [nine] ten members of the board each, the chairman of
- 19 the board being a member of both councils, and to be known as
- 20 the Council of Basic Education and the Council of Higher
- 21 Education. The Governor shall designate to serve at his pleasure
- 22 a member serving on each council to act as chairman of the
- 23 council. Each council shall meet at the call of its chairman or
- 24 at the request of a majority of the members of the council. The
- 25 chairman of the board may appoint special joint committees from
- 26 among the members of the board to formulate policy proposals in
- 27 those areas which fall within the purview of both of the
- 28 councils. The board shall employ and fix the compensation of
- 29 such staff as is deemed necessary to perform the duties of the
- 30 board. The board shall assign a member of the staff to each of

- 1 the councils to serve as secretary.
- 2 The Secretary of Education, or his designated representative,
- 3 shall be the chief executive officer of the State Board of
- 4 Education and shall be entitled to attend all meetings of the
- 5 board and the councils, and shall have the right to speak on all
- 6 matters before the board and the councils but not to vote.
- 7 Section 2. This act shall take effect in 60 days.
