AN ACT

1 Amending the act of November 22, 1978 (No.272), entitled "An act
2 amending the act of March 11, 1971 (P.L.104, No.3), entitled,
3 as amended, 'An act providing property tax or rent rebate to
4 certain senior citizens, widows, widowers and permanently
5 disabled persons with limited incomes; establishing uniform
6 standards and qualifications for eligibility to receive a
7 rebate; and imposing duties upon the Department of Revenue,'
8 extending the time for filing claims, making editorial
9 changes and substituting a declaration for an affidavit of
10 widow or widower status," further providing for claims.

11 The General Assembly of the Commonwealth of Pennsylvania
12 hereby enacts as follows:

13 Section 1. Section 2, act of November 22, 1978 (No.272),
14 entitled "An act amending the act of March 11, 1971 (P.L.104,
15 No.3), entitled, as amended, 'An act providing property tax or
16 rent rebate to certain senior citizens, widows, widowers and
17 permanently disabled persons with limited incomes; establishing
18 uniform standards and qualifications for eligibility to receive
19 a rebate; and imposing duties upon the Department of Revenue,'

1 extending the time for filing claims, making editorial changes
2 and substituting a declaration for an affidavit of widow or
3 widower status," is amended to read:

4 Section 2. This act shall take effect immediately and the
5 amendments to [sections 4 and 5] section 4 shall be retroactive
6 to taxes or rent paid on or after January 1, 1978 and the
7 amendments to section 5 shall be retroactive to taxes or rent
8 paid on or after January 1, 1977.

9 Section 2. This act shall take effect immediately.
