AN ACT

1 Providing additional funds to several agencies of the Executive
2 Department for bills incurred and remaining unpaid at the
3 close of the fiscal period ending June 30, 1979.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. The following sums, or as much thereof as may be
7 necessary, are hereby specifically appropriated from the General
8 Fund to the several hereinafter named agencies of the Executive,
9 Legislative and Judicial Departments of the Commonwealth for the
10 payment of salaries, wages or other compensation and travel
11 expense of the duly elected or appointed officers and employees
12 of the Commonwealth, for payment of fees of contractual services
13 rendered, for the purchase or rental of goods, services,
14 printing, equipment, land and buildings and for the payment of
15 any other expenses, as provided by law or by this act, necessary
16 for the proper conduct of the duties, functions and activities
17 and for the purposes hereinafter set forth for the fiscal period
18 beginning July 1, 1979 and for the payment of bills incurred and
19 remaining unpaid at the close of the fiscal period ending June

1 30, 1979.
