SECTION 1. AS MUCH AS RELATES TO THE DEPARTMENT OF AGING,
THE DEPARTMENT OF HEALTH, THE PENNSYLVANIA EMERGENCY MANAGEMENT
AGENCY, THE PENNSYLVANIA HISTORICAL AND MUSEUM COMMISSION AND
THE DEPARTMENT OF PUBLIC WELFARE IN SECTION 201, ACT OF JUNE 18,
1980 (NO.17A), KNOWN AS THE "GENERAL APPROPRIATION ACT OF 1980,"
ARE AMENDED TO READ:

8 SECTION 201. THE FOLLOWING SUMS, OR AS MUCH THEREOF AS MAY 9 BE NECESSARY, ARE HEREBY SPECIFICALLY APPROPRIATED FROM THE 10 GENERAL FUND TO THE SEVERAL HEREINAFTER NAMED AGENCIES OF THE EXECUTIVE, LEGISLATIVE AND JUDICIAL DEPARTMENTS OF THE 11 12 COMMONWEALTH FOR THE PAYMENT OF SALARIES, WAGES OR OTHER 13 COMPENSATION AND TRAVEL EXPENSE OF THE DULY ELECTED OR APPOINTED 14 OFFICERS AND EMPLOYEES OF THE COMMONWEALTH, FOR PAYMENT OF FEES 15 OF CONTRACTUAL SERVICES RENDERED, FOR THE PURCHASE OR RENTAL OF 16 GOODS, SERVICES, PRINTING, EQUIPMENT, LAND AND BUILDINGS AND FOR 17 PAYMENT OF ANY OTHER EXPENSES, AS PROVIDED BY LAW OR BY THIS 18 ACT, NECESSARY FOR THE PROPER CONDUCT OF THE DUTIES, FUNCTIONS 19 AND ACTIVITIES AND FOR THE PURPOSES HEREINAFTER SET FORTH FOR 20 THE FISCAL PERIOD BEGINNING JULY 1, 1980 AND FOR THE PAYMENT OF 21 BILLS INCURRED AND REMAINING UNPAID AT THE CLOSE OF THE FISCAL 22 PERIOD ENDING JUNE 30, 1980.
