## AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Governor and the Department of
- 3 Transportation, to sell and convey to the Clarion Fire
- 4 Department a parcel of land in the Township of Clarion,
- 5 Clarion County, Pennsylvania.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The Department of General Services, with the
- 9 approval of the Governor and the Department of Transportation,
- 10 is hereby authorized and directed on behalf of the Commonwealth
- 11 of Pennsylvania to sell to the Clarion Fire Department for the
- 12 sum of \$1, the following described tract of land situate in the
- 13 Township of Clarion, County of Clarion, Commonwealth of
- 14 Pennsylvania, bounded and described as follows:
- 15 All that certain piece or parcel of land situated in Clarion
- 16 Township, Clarion County, Pennsylvania, more specifically
- 17 described as follows:
- 18 Beginning at a point located at the southeast corner of the
- 19 tract herein described; thence along lands of Denio, Lonenz,

- 1 Noll and Flanagan and Merryman north 65 degrees 52 minutes 49
- 2 seconds west a distance of 600 feet to a point; thence north 30
- 3 degrees 00 minutes east along lands of Flanagan and Merryman a
- 4 distance of 175 feet to a point; thence south 65 degrees 52
- 5 minutes 49 seconds east along lands of the Commonwealth of
- 6 Pennsylvania a distance of 600 feet to a point located on the
- 7 right-of-way of Second Avenue Extension, also known as Township
- 8 Road 438; thence south 30 degrees 00 minutes west along said
- 9 right-of-way a distance of 175 feet to a point and the place of
- 10 beginning.
- 11 Containing 105,000 square feet, more or less.
- Being a part of the same piece or parcel of land conveyed to
- 13 the Commonwealth of Pennsylvania, more specifically described in
- 14 Clarion County Deed Book 151, Page 285.
- 15 Section 2. The Deed of Conveyance shall be approved by the
- 16 Office of the Attorney General and by the Office of the General
- 17 Counsel and shall be executed by the Secretary of General
- 18 Services in the name of the Commonwealth of Pennsylvania. Title
- 19 to the tract of land described in section 1 shall revert to the
- 20 Commonwealth when the Clarion Fire Department or a similar
- 21 successor organization ceases to use the same for nonprofit
- 22 purposes.
- 23 Section 3. This act shall take effect immediately.
