AN ACT

Amending the act of February 1, 1966 (1965 P.L.1656, No.581), 2 entitled "An act concerning boroughs, and revising, amending 3 and consolidating the law relating to boroughs, " further 4 providing for filling of vacancies in certain borough 5 offices. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. Section 901, act of February 1, 1966 (1965 P.L.1656, No.581), known as "The Borough Code," amended June 15, 10 1978 (P.L.473, No.68), is amended to read: 11 Section 901. Filling Vacancies in Elective Borough Offices.--(A) If any vacancy shall occur in the office of the 12 mayor, member of council, **EXCEPT AS PROVIDED IN SECTION 901.1**, 13 auditor, controller, assessor, or tax collector, by death, 14 resignation, removal from the borough, or from a ward in the 15 16 case of a ward office, or by failure to take the required oath or to give bond as provided by law or ordinance, or in any other 17 manner whatsoever, [the borough council shall fill such vacancy 18

- 1 within thirty days] SUCH VACANCY SHALL BE FILLED BY THE
- 2 CITIZENS' VACANCY BOARD. THIS BOARD SHALL CONSIST OF SEVEN
- 3 REGISTERED ELECTORS WHO RESIDE IN THE BOROUGH. THESE MEMBERS
- 4 SHALL BE APPOINTED AT-LARGE FROM WITHIN THE BOROUGH BY THE
- 5 EXISTING MEMBERS OF COUNCIL THEN IN OFFICE AT THE COUNCIL'S
- 6 FIRST MEETING EACH CALENDAR YEAR. COUNCIL SHALL ALSO APPOINT ONE
- 7 MEMBER TO SERVE AS CHAIRMAN OF THE CITIZENS' VACANCY BOARD.
- 8 WHENEVER A VACANCY OCCURS, THE CITIZENS' VACANCY BOARD SHALL
- 9 SUBMIT TO COUNCIL WITHIN FIFTEEN DAYS OF THE VACANCY THE NAMES
- 10 OF THREE REGISTERED ELECTORS OF THE BOROUGH TO FILL THE VACANCY.
- 11 THE MEMBERS OF THE CITIZENS' VACANCY BOARD ARE PROHIBITED FROM
- 12 SUBMITTING THE NAME OF ANY EXISTING MEMBER OF THE CITIZENS'
- 13 VACANCY BOARD TO FILL A VACANCY. THE COUNCIL SHALL FILL THE
- 14 <u>VACANCY WITHIN FIFTEEN DAYS</u> by appointing, by resolution, a
- 15 registered elector of the borough, or of the ward in case of a
- 16 ward office, to hold such office, if the term thereof continues
- 17 so long, until the first Monday in January after the first
- 18 municipal election occurring more than sixty days after the
- 19 vacancy occurs, at which election an eligible person shall be
- 20 elected to the office for the remainder of the term.
- 21 The person appointed shall give bond if required by law or
- 22 ordinance.
- 23 In cases where the person elected to the office shall fail to
- 24 give bond, if any, required or to take the required oath, the
- 25 borough council, before making the appointment, shall declare
- 26 the office vacant.
- 27 If the council of any borough shall refuse, fail or neglect,
- 28 or be unable, for any reason whatsoever, to fill any vacancy
- 29 within thirty days after the vacancy happens, as provided in
- 30 this section, then the vacancy shall be filled within fifteen

- 1 additional days by [a] the vacancy board. [to] Such board shall
- 2 consist of the borough council exclusive of the mayor, and one
- 3 registered elector of the borough who shall be [elected]
- 4 appointed by the borough council at [each reorganizational
- 5 meeting of the council the council's first meeting each
- 6 calendar year or as soon thereafter as practical and who shall
- 7 act as chairman of the vacancy board. The board shall appoint a
- 8 registered elector of the borough, (or ward in the case of a
- 9 ward office), to hold such office, if the term thereof continues
- 10 so long, until the first Monday in January after the first
- 11 municipal election occurring more than sixty days after the
- 12 vacancy occurs, at which election an eligible person shall be
- 13 elected to the office for the remainder of the term.
- 14 If the vacancy is not filled by the vacancy board within
- 15 fifteen days, the chairman shall or in the case of a vacancy in
- 16 the chairmanship the remaining members of the vacancy board
- 17 <u>shall</u> petition the court of common pleas to fill the vacancy by
- 18 the appointment of a registered elector of the borough (or ward
- 19 in the case of a ward), to hold such office, if the term thereof
- 20 continues so long, until the first Monday in January after the
- 21 first municipal election occurring more than sixty days after
- 22 the vacancy occurs, at which election an eligible person shall
- 23 be elected to the office for the remainder of the term. In the
- 24 <u>case where there are vacancies in more than a majority of the</u>
- 25 offices of council, the court of common pleas shall fill such
- 26 vacancies upon presentation of petition signed by not less than
- 27 fifteen registered electors of the borough.
- 28 [IF THE COUNCIL OF ANY BOROUGH SHALL REFUSE, FAIL OR NEGLECT,
- 29 OR BE UNABLE, FOR ANY REASON WHATSOEVER, TO FILL ANY VACANCY
- 30 WITHIN THIRTY DAYS AFTER THE VACANCY HAPPENS, AS PROVIDED IN

- 1 THIS SECTION, THEN THE VACANCY SHALL BE FILLED WITHIN FIFTEEN
- 2 ADDITIONAL DAYS BY A VACANCY BOARD, TO CONSIST OF THE BOROUGH
- 3 COUNCIL EXCLUSIVE OF THE MAYOR, AND ONE REGISTERED ELECTOR OF
- 4 THE BOROUGH WHO SHALL BE ELECTED BY THE BOROUGH COUNCIL AT EACH
- 5 REORGANIZATIONAL MEETING OF THE COUNCIL AND WHO SHALL ACT AS
- 6 CHAIRMAN OF THE VACANCY BOARD. THE BOARD SHALL APPOINT A
- 7 REGISTERED ELECTOR OF THE BOROUGH, (OR WARD IN THE CASE OF A
- 8 WARD OFFICE), TO HOLD SUCH OFFICE, IF THE TERM THEREOF CONTINUES
- 9 SO LONG, UNTIL THE FIRST MONDAY IN JANUARY AFTER THE FIRST
- 10 MUNICIPAL ELECTION OCCURRING MORE THAN SIXTY DAYS AFTER THE
- 11 VACANCY OCCURS, AT WHICH ELECTION AN ELIGIBLE PERSON SHALL BE
- 12 ELECTED TO THE OFFICE FOR THE REMAINDER OF THE TERM.
- 13 IF THE VACANCY IS NOT FILLED BY THE VACANCY BOARD WITHIN
- 14 FIFTEEN DAYS, THE CHAIRMAN SHALL PETITION THE COURT OF COMMON
- 15 PLEAS TO FILL THE VACANCY BY THE APPOINTMENT OF A REGISTERED
- 16 ELECTOR OF THE BOROUGH (OR WARD IN THE CASE OF A WARD), TO HOLD
- 17 SUCH OFFICE, IF THE TERM THEREOF CONTINUES SO LONG, UNTIL THE
- 18 FIRST MONDAY IN JANUARY AFTER THE FIRST MUNICIPAL ELECTION
- 19 OCCURRING MORE THAN SIXTY DAYS AFTER THE VACANCY OCCURS, AT
- 20 WHICH ELECTION AN ELIGIBLE PERSON SHALL BE ELECTED TO THE OFFICE
- 21 FOR THE REMAINDER OF THE TERM.]
- 22 (B) WHENEVER THE COUNCIL SHALL FAIL TO FILL A VACANCY WITHIN
- 23 FIFTEEN DAYS OF RECEIVING THE LIST OF NAMES FROM THE CITIZENS'
- 24 VACANCY BOARD, THE LIST SHALL BE SUBMITTED BY THE CITIZENS'
- 25 <u>VACANCY BOARD TO THE COURT OF COMMON PLEAS. FROM THIS LIST THE</u>
- 26 COURT SHALL APPOINT A REGISTERED ELECTOR OF THE BOROUGH (OR WARD
- 27 IN THE CASE OF A WARD OFFICE), TO HOLD SUCH OFFICE, IF THE TERM
- 28 THEREOF CONTINUES SO LONG, UNTIL THE FIRST MONDAY IN JANUARY
- 29 AFTER THE FIRST MUNICIPAL ELECTION OCCURRING MORE THAN SIXTY
- 30 DAYS AFTER THE VACANCY OCCURS, AT WHICH ELECTION AN ELIGIBLE

- 1 PERSON SHALL BE ELECTED TO THE OFFICE FOR THE REMAINDER OF THE
- 2 TERM.
- 3 (C) WHENEVER THE CITIZENS' VACANCY BOARD FAILS TO SUBMIT A
- 4 LIST OF REGISTERED ELECTORS TO COUNCIL WITHIN FIFTEEN DAYS THE
- 5 COURT OF COMMON PLEAS SHALL FILL THE VACANCY UPON PRESENTATION
- 6 OF A PETITION SIGNED BY NOT LESS THAN FIFTEEN REGISTERED
- 7 ELECTORS OF THE BOROUGH. THE COURT OF COMMON PLEAS SHALL FILL
- 8 THE VACANCY BY THE APPOINTMENT OF A REGISTERED ELECTOR OF THE
- 9 BOROUGH TO HOLD SUCH OFFICE IF THE TERM CONTINUES SO LONG, UNTIL
- 10 THE FIRST MONDAY IN JANUARY AFTER THE FIRST MUNICIPAL ELECTION
- 11 OCCURRING MORE THAN SIXTY DAYS AFTER THE VACANCY OCCURS, AT
- 12 WHICH ELECTION AN ELIGIBLE PERSON SHALL BE ELECTED TO THE OFFICE
- 13 FOR THE REMAINDER OF THE TERM.
- 14 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ:
- 15 <u>SECTION 901.1. EMERGENCY ACTION; VACANCIES OF A MAJORITY</u>
- 16 NUMBER OF COUNCIL. -- (A) WHERE THERE ARE VACANCIES IN MORE THAN
- 17 A MAJORITY OF THE OFFICES OF COUNCIL, THE VACANCIES SHALL BE
- 18 FILLED BY THE CITIZENS' VACANCY BOARD. THE BOARD SHALL SUBMIT TO
- 19 THE EXISTING MEMBERS OF COUNCIL THEN IN OFFICE THE NAME OR NAMES
- 20 OF A REGISTERED ELECTOR OR ELECTORS OF THE BOROUGH TO FILL THE
- 21 <u>VACANCY OR VACANCIES. THE NUMBER OF NAMES SUBMITTED BY THE BOARD</u>
- 22 SHALL EXCEED BY TWO THE NUMBER OF APPOINTEES NECESSARY TO FILL
- 23 THE VACANCIES. FROM THIS LIST THE EXISTING MEMBERS OF COUNCIL
- 24 THEN IN OFFICE SHALL FILL VACANCIES BY APPOINTING BY RESOLUTION
- 25 REGISTERED ELECTORS OF THE BOROUGH TO HOLD SUCH OFFICES, IF THE
- 26 TERM THEREOF CONTINUES SO LONG, UNTIL THE FIRST MONDAY IN
- 27 JANUARY AFTER THE FIRST MUNICIPAL ELECTION OCCURRING MORE THAN
- 28 SIXTY DAYS AFTER THE VACANCIES OCCUR, AT WHICH ELECTION AN
- 29 ELIGIBLE PERSON SHALL BE ELECTED TO THE OFFICE FOR THE REMAINDER
- 30 OF THE TERM.

- 1 (B) IF THE EXISTING MEMBERS OF COUNCIL THEN IN OFFICE SHALL
- 2 FAIL TO FILL THE VACANCIES WITHIN FIFTEEN DAYS OF RECEIVING THE
- 3 LIST FROM THE CITIZENS' VACANCY BOARD, THE LIST SHALL BE
- 4 SUBMITTED BY THE BOARD TO THE COURT OF COMMON PLEAS AND THE
- 5 VACANCIES FILLED AS PROVIDED IN SUBSECTION (B) OF SECTION 901.
- (C) WHENEVER THERE ARE NO EXISTING MEMBERS OF COUNCIL IN 6
- 7 OFFICE TO APPOINT A CITIZENS' VACANCY BOARD, THE COURT OF COMMON
- 8 PLEAS SHALL FILL SUCH VACANCY OR VACANCIES AS PROVIDED IN
- SUBSECTION (C) OF SECTION 901.
- 10 (D) WHENEVER THE CITIZENS' VACANCY BOARD FAILS TO SUBMIT A
- 11 LIST OF REGISTERED ELECTORS TO COUNCIL WITHIN FIFTEEN DAYS, THE

- 12 COURT OF COMMON PLEAS SHALL FILL THE VACANCIES AS PROVIDED IN
- 13 SUBSECTION (C) OF SECTION 901.
- 14 Section 2 3. This act shall take effect in 60 days.
