JUNE 22, 1981

AN ACT

1 Authorizing the incurring of indebtedness, with approval of the
2 electors, of \$300,000,000 for the repair, CONSTRUCTION, <—
3 reconstruction, rehabilitation, EXTENSION and improvement of <—
4 community water supply systems, and for the repair,
5 reconstruction or rehabilitation of flood control facilities,
6 dams and port facilities and providing the allotment of
7 proceeds from borrowing hereunder.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. The question of incurring indebtedness of
11 \$300,000,000 for loans for the repair, CONSTRUCTION, <—
12 reconstruction, rehabilitation, EXTENSION and improvement of <—
13 community water supply systems, and for the repair,
14 reconstruction or rehabilitation of flood control facilities,

1 dams and port facilities shall be submitted to the electors at
2 the next primary, municipal or general election following
3 enactment of this act.

4 Section 2. The Secretary of the Commonwealth shall forthwith
5 certify the question to the county boards of election.

6 Section 3. The question shall be in substantially the
7 following form:

8 Do you favor the incurring of indebtedness by the
9 Commonwealth of \$300,000,000 for use as loans to repair,
10 CONSTRUCT, reconstruct, rehabilitate, EXTEND and <—
11 improve water supply systems, or to repair, reconstruct or
12 rehabilitate flood control facilities, dams and port
13 facilities in order to improve the health, safety and
14 economic well-being of the people of the Commonwealth?

15 Section 4. The election shall be conducted in accordance
16 with the act of June 3, 1937 (P.L.1333, No.320), known as the
17 "Pennsylvania Election Code," except that the time limits for
18 advertisement of notice of the election may be waived as to the
19 question.

20 Section 5. Proceeds of borrowing shall be used through loans
21 to provide for repairs, CONSTRUCTION, reconstruction, <—
22 rehabilitation, EXTENSION and improvement of water supply <—
23 systems, and for the repair, reconstruction and rehabilitation
24 of flood control facilities, dams and port facilities necessary
25 to insure compliance with State and Federal health and safety
26 standards and to promote the Commonwealth's economic
27 development.

28 Section 6. This act shall take effect immediately.
