## AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth, providing for a welfare
- 4 scrip program subject to legislative oversight.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The definition of "assistance" in section 402,
- 8 act of June 13, 1967 (P.L.31, No.21), known as the "Public
- 9 Welfare Code, " amended July 15, 1976 (P.L.993, No.202), is
- 10 amended to read:
- 11 Section 402. Definitions.--As used in this article:
- 12 "Assistance" means money, scrip, services, goods, shelter,
- 13 burial and medical, chiropractic and other health care,
- 14 including nursing home care provided from or with State,
- 15 Federal, county, county institution district or municipal funds,
- 16 for needy persons who reside in Pennsylvania and need assistance
- 17 to provide for themselves and their dependents a decent and
- 18 healthful standard of living, and for needy homeless or

- 1 transient persons.
- 2 \* \* \*
- 3 Section 2. The act is amended by adding sections to read:
- 4 <u>Section 475. Welfare Scrip Program. -- (a) For the year</u>
- 5 January 1, 1982 to December 31, 1982, the department shall make
- 6 general assistance cash grant payments by check for fifty
- 7 percent of the grant and by welfare scrip for the remaining
- 8 fifty percent of the grant or by welfare scrip for one hundred
- 9 percent in a pilot program involving approximately fifteen
- 10 percent of its caseload. The department shall determine whether
- 11 to apply the pilot program Statewide or in a given area of the
- 12 <u>Commonwealth</u>.
- (b) Welfare scrip shall not be accepted in State liquor
- 14 stores, establishments having liquor or malt and brewed beverage
- 15 <u>licenses or for the purchase of firearms.</u>
- 16 (c) Welfare scrip shall be printed by the department by a
- 17 <u>nonduplicable method</u>.
- 18 (d) The recipient of the welfare scrip shall record his or
- 19 her social security number on the scrip when signing the scrip
- 20 over to the receiver.
- 21 (e) The department shall issue and from time to time revise
- 22 a general list of acceptable receivers of welfare scrip who
- 23 shall be approved recipients.
- 24 (f) The department may adopt preliminary rules and
- 25 regulations for the operation of its pilot welfare scrip program
- 26 which need not be promulgated pursuant to the act of July 31,
- 27 1968 (P.L.769, No.240), referred to as the Commonwealth
- 28 Documents Law and 45 Pa.C.S. Part II (relating to publication
- 29 and effectiveness of Commonwealth documents). Such preliminary
- 30 rules and regulations shall however be furnished to the Senate

- 1 Public Health and Welfare Committee and the Health and Welfare
- 2 Committee of the House of Representatives. The department shall
- 3 <u>likewise furnish such committees with monthly bulletins on the</u>
- 4 operation of the welfare scrip program. By October 1, 1982 the
- 5 committees shall evaluate the welfare scrip program and submit
- 6 to their respective Houses, reports including minority reports,
- 7 <u>if any, of such evaluations and a recommendation for its</u>
- 8 <u>expansion and continuance or for its discontinuance.</u>
- 9 (g) On or before November 1, 1982 the department shall
- 10 promulgate and adopt rules and regulations for expansion of the
- 11 welfare scrip program to a one hundred percent scrip program
- 12 Statewide.
- 13 <u>Section 476. Legislative Oversight of Proposed</u>
- 14 Regulations. -- (a) All rules and regulations, or amendments
- 15 thereto, of the department implementing the provisions of, or
- 16 issued pursuant to the authority contained in section 375 of
- 17 this act shall be promulgated in accordance with the act of July
- 18 31, 1968 (P.L.769, No.240), referred to as the Commonwealth
- 19 Documents Law, and 45 Pa.C.S. Part II (relating to publication
- 20 <u>and effectiveness of Commonwealth documents</u>). After such rules
- 21 <u>or regulations have been adopted finally but before they take</u>
- 22 effect, they shall be submitted to the General Assembly for
- 23 review and approval as provided in this section. The text of all
- 24 rules and regulations subject to this section shall be printed
- 25 in the Pennsylvania Bulletin in the form finally adopted by the
- 26 <u>department prior to their submission to the General Assembly.</u>
- 27 For the purposes of this section, any section of a rule or
- 28 regulation which was printed in the Pennsylvania Bulletin at the
- 29 proposal stage need not be reprinted when adopted finally if
- 30 there are no changes to the section at the time of final

- 1 <u>adoption</u>.
- 2 (b) Rules and regulations subject to this section shall be
- 3 <u>submitted by the department to the General Assembly for review</u>
- 4 and approval in the form of an Administrative Rules Report. The
- 5 Administrative Rules Report shall be prepared by the Legislative
- 6 Reference Bureau and shall specifically refer to the volume and
- 7 page number in the Pennsylvania Bulletin where the rules and
- 8 regulations submitted for review and approval may be found but
- 9 shall not include the actual text of the proposed rules and
- 10 regulations. Following its preparation by the Legislative
- 11 Reference Bureau, the department shall hand deliver copies of
- 12 the Administrative Rules Report to the offices of the Chief
- 13 Clerk of the House of Representatives and the Secretary of the
- 14 Senate. The Administrative Rules Report shall be delivered to
- 15 both Houses on the same day and on a day when each House is in
- 16 session. Receipt of an Administrative Rules Report shall be
- 17 noted in the journal of each House on the day received.
- 18 (c) Each Administrative Rules Report submitted to the
- 19 General Assembly shall be proposed as a resolution and shall be
- 20 given an identifying number and be placed on the calendar of
- 21 <u>each House on the next legislative day following receipt. The</u>
- 22 resolution relating to the Administrative Rules Report shall be
- 23 considered by each House in the same manner and subject to the
- 24 <u>same conditions provided for reorganization plans under the act</u>
- 25 of April 7, 1955 (P.L.23, No.8), known as the "Reorganization
- 26 Act of 1955."
- 27 (d) If either House disapproves the Administrative Rules
- 28 Report pursuant to the procedure provided in the "Reorganization
- 29 Act of 1955," the rules or regulations referred to in the report
- 30 shall be void and the welfare scrip program shall cease.

- 1 (e) If both Houses approve an Administrative Rules Report
- 2 <u>affirmatively or if neither House disapproves the report, the</u>
- 3 rules or regulations referred to therein shall be deemed
- 4 approved and shall take effect as provided in subsection (h).
- 5 (f) Rules and regulations submitted to the General Assembly
- 6 for review and approval in the form of an Administrative Rules
- 7 Report pursuant to this section may only be approved or
- 8 disapproved by the General Assembly in their entirety and may
- 9 not be approved or disapproved conditionally or in part.
- 10 (q) The Chief Clerk of the House of Representatives and the
- 11 <u>Secretary of the Senate shall give notice to the department of</u>
- 12 the final action taken by their respective Houses on each
- 13 Administrative Rules Report. Upon receipt of such notice from
- 14 both the Chief Clerk of the House of Representatives and the
- 15 Secretary of the Senate, the department shall cause notice of
- 16 <u>such legislative action to be published in the Pennsylvania</u>
- 17 Bulletin which notice shall include a specific reference to the
- 18 volume and page number in the Pennsylvania Bulletin where the
- 19 rules or regulations which are the subject of the Administrative
- 20 <u>Rules Report were printed.</u>
- 21 (h) Any rules or regulations approved pursuant to the
- 22 procedure established by this section shall take effect
- 23 immediately upon publication in the Pennsylvania Bulletin of the
- 24 notice of their approval as required by subsection (q) or at
- 25 such later date specified in the rules and regulations as
- 26 adopted by the department prior to their submission to the
- 27 General Assembly. The welfare scrip program shall be expanded to
- 28 <u>a one hundred percent scrip program for general assistance</u>
- 29 payments Statewide concurrently with such publication on
- 30 effective date or on January 1, 1983, whichever date is latest.

1 Section 3. This act shall take effect in 60 days.
