AN ACT

Amending the act of September 9, 1965 (P.L.499, No.254), 2 entitled, as reenacted and amended, "An act providing for and 3 regulating the registration and licensing of motor vehicle 4 and mobilehome manufacturers, dealers and salesmen, fixing fees, creating the State Board of Motor Vehicle Salesmen, imposing powers and duties on the Department of State, the 6 7 Commissioner of Professional and Occupational Affairs and the board and prescribing unlawful acts and penalties and making an appropriation, "further defining "office or branch". 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. Clause (2) of section 6, act of September 9, 1965 13 (P.L.499, No.254), known as the "Motor Vehicle Manufacturer's, Dealer's Salesmen's License Act, " reenacted and amended December 14 21, 1973 (P.L.408, No.144), and repealed insofar as inconsistent 15 July 1, 1978 (P.L.700, No.124), is amended to read: 16 17 Section 6. Fees. -- The fee for an applicant for licensure 18 shall be: 19 20 (2) For motor vehicle dealers, twenty-five dollars (\$25) for

the initial registration, and fifteen dollars (\$15) for each

- 1 biennial renewal thereof. Each office or branch shall be
- 2 separately licensed and shall pay the same fees. Each used car
- 3 lot not immediately adjacent to the licensed premises shall be
- 4 issued a supplemental license for which a biennial fee of ten
- 5 dollars (\$10) shall be charged. As used in this act, an "office
- 6 or branch, " in order to require separate licensure, shall be a
- 7 place actually occupied either continuously or at regular
- 8 periods by a person licensed, or required to be licensed, under
- 9 this act, where the books and records relating to the office or
- 10 <u>branch are kept and a large share of business is transacted:</u>
- 11 Provided, That an "office or branch" shall not include a trade
- 12 show, vehicle show, dealer show or similar function: And
- 13 provided further, That nothing in this act shall prohibit a
- 14 person licensed under this act from participating in such a show
- or from exhibiting such person's motor vehicle, mobilehome,
- 16 house trailer or recreational vehicle at such a show; nor shall
- 17 any additional fee be charged for participating in such shows.
- 18 Section 2. This act shall take effect in 60 days.
